President's Message

It is sweet justice that our 100-year anniversary is coinciding with renewed energy to pass the Equal Rights Amendment in Congress. LWVUS and LWV-CDC have supported and pushed for ratification of the Equal Right Amendment since 1972 but now with Virginia becoming the 38th state to ratify ERA, this long-awaited milestone looks promising for passage in the U.S. House. After passage in the House, the focus will shift to the Senate, which will be a more difficult hurdle, but we are lobbying hard to add more cosponsors and inform members of Congress.

Fair Districts PA reports that Senator Tom Killion (District 9, Chester and Delaware Counties) has introduced a Senate bill mirroring the House bill to create an independent citizens commission to draw both congressional and legislative districts in time for the 2021 redistricting process. Bills have also been introduced in both houses to establish such a commission by constitutional amendment.

New Voting Machines are on display for the public in the lobby of the Government Center in Media. Many League members are currently serving as "qualified trainers" to educate residents and train poll workers for the 2020 Primary. League members are demonstrating the new machines in libraries and other community venues throughout the County as well as explaining the election reforms adopted in Act 77.

We are hosting Regina Mauro from the Philadelphia Regional Census Center and Michael Ranck, CEO of the Delaware County Complete Count Committee at our Hot Topic discussion on March 20. They will discuss how a complete and accurate 2020 Census count ensures that that Delaware County receive proper funding from the Federal government.

We hope that you join many of the current suffrage themed events in Philadelphia. The Constitution Center is opening a new exhibit June 10, on the 19th Amendment: How Women Won the Vote. It will feature many familiar faces, Elizabeth Cady Stanton, Alice Paul and Ida B. Wells and their role in the long fight for women's suffrage. Vision 2020 - Women 100, a national celebration of American Women is a series of programs and events presented by Drexel University that celebrates the path to gender equality. LWV-CDC Program Planning Recommendations

On Feb. 3, members of the LWV-CDC Board of Directors convened to conduct LWVUS program planning and obtain consensus on positions that we intend to use in education and lobbying activities. Over the last three years, LWV-CDC has advanced the priorities of the LWVUS' campaign for Making Democracy Work in the areas of redistricting, voting rights and improving elections. LWV-CDC played a leadership role by offering opportunities for civic engagement via candidate forums, civic education seminars, voter registration drives, a more robust Vote411, and speaker programs – to name a few examples.

In addition, we recommended a completely new position and an expanded position to LWVUS:

- We propose that the narrow LWVUS positions on the death penalty and sentencing policy be expanded based on the LWVPA's positions on criminal justice that addresses bail, effective counsel, alternatives to incarceration, restorative justice and appropriate sentencing. We also support LWVPA's positions on improving prison conditions, eliminating solitary confinement, supporting re-entry and reducing recidivism. We believe a new comprehensive LWVUS Criminal Justice position will reflect the complexity and broader issues of criminal justice.
- We also decided to resubmit our 2018 proposal to study alternative methods for electing members of Congress to include changing from the current federally mandated single member district to allow multi member districts where possible and appropriate. The current position on the election process does not cover this issue and therefore we are recommending a completely new position. We believe that multimember districts are essential to achieve proportional representation and will produce more balanced representation by encouraging the nomination of a diverse roster of candidates. There is good evidence to suggest that women are more likely to be elected from multiple member districts and that ethnic, religious and different language groups are better represented from multimember districts.

The CDC-LWV is ramping up its Primary Election (April 28) activities. If you want to get involved, here's how:

- Demonstrating voting machines and presenting election law changes to clubs and organizations: The League is fielding a full roster of trainers to demonstrate the machines at libraries, senior centers, Ys and other organizations that request it. - 3. Fair Districts PA is sponsoring a bus trip to Harrisburg March 23 to lobby legislators to vote for two bills to redistrict our congressional and state House and Assembly districts.

Senate Bill 1023, introduced by Senator Tom Killion, (R, District 9, Chester and Delaware Counties) would create an independent citizens commission to draw congressional districts SB 1023 is not a constitutional amendment and can be passed in this session, making possible creation of a commission before 2021.

Senate Bill 1022, introduced by Senator Lisa Boscola (D, District 18, Lehigh and Northampton counties) would amend the PA Constitution to give that same commission authority to draw the state House and Senate districts. In effect, S.B. 1022 piggy-backs on 1023 while ensuring that the proposed changes for congressional and legislative redistricting become part of the PA constitution.

These bills mirror bills already introduced in the General Assembly.
