A very special thanks goes to our Advocacy Chair, Lora Rathbone, for all the work she did behind the scenes to make the meetings successful and for keeping us updated on the bills.

Now we welcome March, a month that contains "the green holiday" that my grandson says is his favorite. Indeed, St. Patrick's Day and the shamrock symbolize good luck, and we hope it will be so, a full year after the statewide shutdown due to COVID-19. Many of us have been lucky enough to receive our vaccinations, but hopefully our teachers and other essential workers will be vaccinated soon. By August, perhaps our schools can return to fulltime in-person instruction and many events and activities can resume, including the League's! We paid \$400 for the MyLO website, \$7 in PayPal fees, \$848 for National PMPs and \$504 for State PMPs. The 3<sup>rd</sup> and 4<sup>th</sup> quarter Per Member Payments (PMPs) were paid in order to complete those commitments.

The next fiscal year Per Member Payment is determined by our membership on February 1<sup>st</sup>. An updated Membership List has been sent to members only.

#### You Can Be An Advocate ~ Lora Rathbone

The 2021 WA State Legislative session is only halfway through and we have already done so much! As I write, LWVWA Democracy Lobby week is still happening, with interesting and informative presentations on a variety of Democracy topics every day. (February 22-26).

Several of us from LWVBF in the 8<sup>th,</sup> and 16<sup>th</sup> legislative districts met with our state legislators. The league asked us to inform them of the league's top priorities which are:

- 1. Voting Rights Restoration 1078. This would promote racial justice by automatically restoring the right to vote for every citizen living in the community once they served their time. Currently rights are not restored until after they finish parole which has caused confusion.
- 2. Closing the Revolving door 5170. Establishes a one-year "cooling off" period before elected officials and high-level employees can work as a lobbyist. It would build public trust.
- **3.** Harassment of Election Officials 5148. Makes harassment of election workers a class C felony.
- 4. Remove Advisory Votes- 5182. They regard decisions on state expenditures that have already been passed by legislators. This is confusing to voters. Removing them would save \$156K-194K.
- 5. Ranked Choice Voting- 1156. Having more than one choice should make campaigns more focused on the issues than on the politician and should lower election costs.

LWVWA bills I am following include:

HB 1297: Working Family Tax credit (Rep Boehnke is supporting it), and SB 5096 Capital Gains tax learn more at <u>https://lwvwa.org/revenue</u>

**SB 5160: Provide certain tenant protections** during and after public health emergencies. Senator Brown votes "without recommendation" which means she could still be persuaded to support it. Will be voted on in the Senate soon. https://lwvwa.org/housing

SB 5373: The Washington Strong Act authorizes nearly \$5B of green bonds to invest in infrastructure and mitigation to reduce climate change and transition to a clean economy. This bill has large revenue implications, so it is not subject to ordinary cut-off dates. HB 1050: Reducing GHG emissions from hydrofluorocarbons. SB 5141: Implementing the recommendations of (HEAL Act). HB 1099: Improving the state's climate response through updates to the state's comprehensive planning framework. MELD calls provide a monthly interaction between Leagues to network, share ideas, accomplishments and best practices with guidance and mentorship from our coach Lynn Busacca. Our State Liaison Susan Fleming, also shares State and National resources with us and gives state leaders summaries from the local Leagues. Benton-Franklin is currently in Pod #5 with members from Kitsap, Grays Harbor and Thurston Counties.

Our calls are 60 minutes, Lynn provides an agenda. Discussions are casual and productive. Some highlights of our last call are:

- Lynn forwards us various articles and information. I noted the use of 'consent agendas' could be useful for our board meetings. I will forward the article to our officers.
- Per Carol Goss (Thurston League), they are reviewing/revitalizing an Observer Corps activity. Tony Wilson suggested having a spot to put current observer reports on each leagues website for members to review (more timely than monthly Voter).
- Per Tony Wilson, they are working on *Civil Discourse* workshops. This may be a 2 3 year project.
- Per Susan Fleming, State Convention topics are still being reviewed. Some ideas are:
  - how leagues could work with groups that are NOT non-partisan
  - what 2021 state legislation was partisan and non-partisan
