Pickens Board of Elections February Takeaway

LWVOP attendance at Pickens and Oconee Election Board meetings underscore our active support for the important mission of these agencies. Here are just a few highlights from the February 7th Pickens Election Board meeting.

- Director, **Dr. Amy Sams** reviewed pre-filed bills H3471, H3172, H3161, H3472, H3685, H3695, and S403. These bills, if passed, will impact the Voter Registration and Election Office in various ways. For example, H 3161 proposes to change partisan primaries to registered party voters.
- Dr. Sams discussed the County Council Budget request for increased funding for staffing.
- Dr. Sams reported that the SEC had accepted feedback from voters regarding confusing directions on feeding ballots into the scanner. The graphic on the scanner shows the ballot scanned in face up, but the directions given by the poll workers was to scan face down for privacy. These conflicting instructs were identified by a LWVOP post-election survey given to Dr. Sams and the Board. The policy going forward will not include instructions to turn ballot upside down when scanning.
- Board member, Luke Campbell, discussed strategies to help voters become more informed before casting their vote. He suggested reaching out to various community resources, including the LWV, to help with voter education.

Voters in Pickens County are fortunate to have an engaged and committed Board and staff. They are working hard to make our democracy work!

Recap of February Meeting: Medicaid Expansion

Close to 40 folks turned out to learn how CoverSC, (a recently formed state coalition supported by LWVSC), will work to expand Medicaid to some of the state's poorest citizens. Nine of the participants joined through Zoom.

Teresa Arnold¹, Chair of CoverSC, described the coalition, its members and the strategies and timetable by which the coalition will work. She said that local groups such as LWVOP and its partners are in the best position to undertake what needs to be done now educate the public about why expanding Medicaid to the uninsured is important for humanitarian as well as economic interests of the state and the uninsured.

In Pickens County, 16% of residents have no medical insurance. In Oconee, 22% have no medical insurance. They pay out-of-pocket for their expenses whether its doctor visits, prescriptions, tests, hospitalizations, eye-glasses, or dental work. Twenty-three percent of South Carolinians carry medical debt, the second highest state in the country. Much of this debt could be reduced if the South Carolina Legislature passed a bill for expansion of the Medicaid program as have 40 other states. Agreeing to expansion means the federal government would pay 90% of the cost.

Dr. Peter Sparks, co-founder of the Clemson Free Clinic in 2004, applauded efforts of the community to provide primary health care services to the uninsured but stated that no one should have to reply on "charity" for health care services that can determine life or death.

The outcome of the meeting is the possibility of forming a local network of organizations to support the work of CoverSC. It will hold its first meeting March 14 by zoom, 12:30 - 1:30. The Anderson League of Women Voters will join the group. If interested, contact **Janet Marsh**, jmarsh@clemson.edu.

Suggestion 1: Conduct a fact-finding project to document the level of staffing in other counties.

Suggestion 2: Request the State Elections Commission to recommend staffing levels. Some members expressed the opinion that only elections officials have complete knowledge of the staffing needed to maintain and prepare equipment for elections.

The level of staffing is a continuing problem. How can the LWVSC weigh in appropriately?

Hearing of H3728, "SC Transparency and Integrity in Education ACT"

On March 1st the South Carolina Senate scheduled a subcommittee hearing for H. 3728, radical legislation designed to censor educator speech around historical and contemporary racism and oppression. The hearing will be on **March 15th, at 9:00** in the Gressette Building, Room 105 at the State Capitol.

- meeting with your senator in district.
- drafting written testimony.
