President's Message -- Diane Molleson

The National League's new membership system, ChapterSpot launched in early February, and members should be receiving an email asking them to log in to the ChapterSpot portal and create a profile. As of February 14, our League's members, with the exception of the officers, had not yet received this invitation. Please stay tuned for this message from the National League. February 14, 2025 was the League's 105th birthday, and we celebrated the occasion with lunch at CG Public House in Kennewick. Despite the snow, the event was well attended. Our guest speaker was Tracci Dial, Multimedia News Director for NW Public Broadcasting. Her presentation on the "Truth Seekers" in the age of disinformation was very timely and informative. She also provided suggestions for reliable news sources she uses, such as https://www.readtangle.com/readtangle.com. With the threat of cuts to public broadcasting, she suggested making our voices heard at Protect Our Public Media: https://www.protectmy publicmedia.org.

Seventeen members joined our consensus discussion on the State League's Elder Caregiving Study, which focused on care for vulnerable adults 60 years and older in Washington State. These consensus meetings provide the study committee and the State League's board with valuable input they then use to form a position. Once the League's positions are approved, they can be used to advocate for legislative action.

We will be having a consensus discussion (date and time to come) on the LWVWA's other study completed this year: **Welcoming Immigrants to Washington State**. LWVBF members Judy Golberg and Christine Grantham were on the study committee and they will be available to participate in our discussion. LWVBF Treasurer's Report - Carla Ciotti

As of January 31, 2025:

Checking is \$8,023.02 <u>Savings is</u> \$1,857.38 Total \$9,880.40

Income and Expenses: In January we did not receive any new memberships or donations. The only income was two cents interest in the savings account. We also did not pay any expenses.

Transition to ChapterSpot Membership Platform: The National League of Women Voters (LWVUS) launched the new membership system on February 3, 2025. In February, all members will receive an email asking them to log in to the ChapterSpot portal and create a profile, but they will not be asked to renew their membership until it expires. As of February 14, members of our League, other than officers, have not yet received the invitation to log on and create a profile. After the invitations are sent, a group of seven members have volunteered to contact other members to inform them of this step and assist if needed. The Join/Renew button has been placed on the LWVBF webpage and is working. On February 11th, Dartanya Helgeson was the first member to join using the new system. Welcome Dartanya!

Education Fund: We have not received an official update on the balance of the Education Fund since January 1. Our balance stands at \$9,040.42.

On February 7, a Project Approval Request was submitted to the Education Fund Manager outlining the plans of the Scholarship Committee to award two scholarships of \$2,000 each. The request was for a total of \$4,500. The extra \$500 is to cover expenses.

Extreme Risk Protection Awareness Project – Richard Badalamente

The ERPO Awareness team now consists of LWVBF members Richard Badalamente (Project Leader), Diane Molleson, Carla Chiotti as well as Karla Carlisle, Managing Attorney for the Northwest Justice Project; JoDee Garretson, Executive Director of SARC (Support, Advocacy & Resource Center), Rosanna Herrera, SARC Program Director, and Christine Brown, former candidate for Congress. There's always room for more, especially those willing to write letters to the editor and/or guest commentary on the issue. The Benton-Franklin Health District has designated our League of Women Voters of Benton & Franklin Counties as a partner in the Health District's Community Health Assessment (CHA) and the resulting Community Health Improvement Plan (CHIP) program. This is a result of our Extreme Risk Protection Order (ERPO) team's efforts to reduce gun violence in Benton and Franklin Counties.

ERPO information brochures have been translated into Spanish and are being distributed widely in an effort to improve general awareness of the role of this particular protective order and its purpose.

Pat Griffith of the Seattle LWV contacted the ERPO team and proposed partnering with Grandmothers Demand Action, a spin-off of Moms Demand Action. MDA is primarily a legislative advocacy non-profit.

Richard, Karla, and Rosanna met with the Benton Franklin Police Chiefs and the Benton County Prosecuting Attorney, on February 5, 2025. Richard presented an overview of the project to raise public awareness of ERPOs, and the team participated in a roundtable discussion concerning petitioning for and serving ERPOs. It was clear from the discussion that more work is needed to convince the police that ERPOs are both a life-saving measure, and a crime prevention measure.

Easy ways to help get LWVWA priority bills passed during the WA 2025 Legislative session:

- 1. Sign up for the LWV WA Legislative newsletter. <u>Click here to subscribe</u>. It is sent each Sunday during the session. They provide good descriptions of the bills and straight forward directions.
- 2. Follow the directions: often the only thing to do is click on a link, state your position (select Pro), then give your contact information. (Later, we will be asked to contact our legislators. See #4).
- 3. For more impact, you can sign up to send written or oral testimony for bill hearings. To do this click on the bill in the LWVWA action alert OR go to the LWV WA website https://lwvwa.org/2025Issues/ then click on a topic i.e. Local News and Democracy, then on a bill number in the list of priority bills. If the bill is having a hearing that week there will be a dark green bar "sign up to testify". Click on that bar, then follow the directions. Or contact me at ldrathbone@outlook.com and I will walk you through it. I would like to help!
- 4. Schedule a meeting with your legislators to lobby. If you would like to speak to them in a Zoom meeting, let me know your legislative district, then we'll plan on a time. We will also have a meeting to plan what to say before we meet with them.
