### **Automatic Dues Renewal**

The second of three legislative forums during the Iowa 91st Assembly was held on Saturday, February 22, 2025 at the Coralville City Hall. The following legislators participated: Senator Zach Wahls, Senator Janice Weiner, Representative Dave Jacoby, Representative Elinor Levin and Representative Adam Zabner. Representative Amy Nielsen was ill. We wish her a speedy recovery. Senator Dawn Driscoll, Representative Heather Hora and Representative Judd Lawler did not attend.

The focus of the forum was on the Environment and Water Quality. Interested local organizations were invited to send someone on behalf of their organization. Representatives from 100 Grannies, Iowa City Climate Advocates, Sustainable Iowa Land Trust, and Iowa City Sierra Club were represented and asked questions. Many questions also came from the large audience pf around 60 people. Thank you to Barb Stein, who served as moderator, and Cathy Eisenhofer, who was our timekeeper. It was an informative session.

# **EDUCATION**

On March 27 through 28, a two-day symposium, "Locating Reproductive Justice: Global and Regional Perspectives", will bring together scholars and artists from across the United States to share local, regional and global perspectives on the state of reproductive justice. The symposium, sponsored by the University of lowa Obermann Center for Advanced Studies, is the launch event for a new book series by the same title to be published by the University of lowa Press.

LWVJC is co-sponsoring the symposium, which will include two major public events. On Thursday, March 27, a panel of invited speakers will examine the "Changing Landscapes of Reproductive Justice", looking at how people, past and present, have negotiated laws, policies, and structural deficiencies to access reproductive health care. On Friday, March 28, participants will consider possible future directions in reproductive justice.

Both events will take place 4:00 – 6:00 p.m. at the Iowa City Public Library.

Looking ahead, the Education Committee final program of the season will take place on Thursday, April 3, at the Iowa City Public Library, 6:30 – 8:00 p.m.. Bram Elias, Clinical Professor of Law and Director of the UI Immigration Clinic, and Jennie Schmidt, Executive Director of the Free Medical Clinic, will discuss the "Legal and Medical Issues: Facing Immigration in Johnson County".

### **ADVOCACY**

The Advocacy Committee has been busy this month with an onslaught of bills from the lowa Legislature on topics ranging from education funding and new public school mandates, the elimination of DEI programs, voter ID requirements, and limiting the liability for agricultural chemical companies. As Johnson County legislators explained to a robust audience at the LWVJC Legislative Forum on the environment last week, lowa continues to rank second nationally with newly diagnosed cancer cases. At the same time, SSB1051 (SF 394) was advanced by the Senate Judiciary Committee to limit the liability of pesticide companies stating the "a consumer warning label... shall be sufficient to satisfy any requirements for a warning."

Another legislative action we are keeping a close watch on, <u>SJR6</u>, proposes an amendment to the lowa Constitution that will repeal the natural resources and outdoor recreation trust fund established in 2010 "for the purpose of protecting and enhancing water quality and natural areas in this state." When the fund was created, 63% of lowa voters approved the amendment. The trust has never been funded with tax revenue; however, its existence provided a pathway toward cleaner water in the state, an issue that continues to be unhealthy with unimproved nitrate levels in many water sources.

Last week, Iowa Rebublican lawmakers also introcuced HSB242, an all-compassing bill that

removes gender identity as a protected class from the Iowa Civil Rights Act in addition to making definitional changes to how "sex" and "gender" are classified and defined in Iowa Code. Protection from discrimination in employment, wages, public accommodations, housing, education and credit practices on the basis of gender identity would be removed from Iowa Code under the bill.

# **FUNDRAISING**

This year the goal of the LWVJC Board was set at \$8,000 and donations could be designated for the Operations Fund to cover the costs of administration and/or the Education Fund for tax deductible consideration. Donation letters were done again by PIP Printing and PIP designed, printed in color, prepared and enclosed the response card, folded, stuffed, addressed, added postage and delivered to the post office for mailing; a QR code was added this year for convenience. Letters were mailed in late November 2024 and sent to 165 members of record. Total cost for this service was \$514.48 or \$0.06 per dollar raised. As the goal was reached during January, 2025, no follow-up was done except in the VOTER.

The Fundraising totaled \$8,030 with the Operating Fund receiving donations of \$4,955, similar to last year's yield of \$5,074; the Education Fund totaled \$3,075, slightly more than last year's \$2,925. Thirty-three member units participated in the fundraising campaign or 20 percent of those solicited, fewer than last year though the number of mailings increased by 19; the average amount given was \$164.99 per donation.

Thank you Judith Pfohl for sending donation acknowledgements to those who contributed; thank you Diane Duncan-Goldsmith for your guidance and support; and thank you Vicki Aden for your usual steadfast leadership and direction.

### **UMRRILO**

In November, 2024, the Mississippi River Network, now known as ONE Mississippi, had its annual meeting in Minneapolis. The good news gained in discussions was talk about overcoming the political climate against environmental issues. Recent Iowa polls show people want clean water! An article in the LWV Des Moines newsletter, "Summit's Controversial Bid to Build a Carbon Capture Pipeline Wins Iowa Board's Approval" requires our pushback.

This article stated permits must be obtained in South and North Dakota before any construction can begin. The Iowa Utilities Board gave permission for eminent domain, one of the more controversial parts of the bill. Summit Carbon Solutions is partnering with 57 ethanol plants across five states, a threat to bedrock aquifer water supplies.

None of the states will experience public benefit because of construction of the pipeline. Investors, foreign and domestic, plan to score big monetarily with federal tax credits. There is no public benefit for lowa residents. The insurance liability policy won't be able to replace the water in bedrock aquifers which can be depleted with the billions of gallons of water needed by ethanol plants to produce ethanol. Depletion will also affect the availability of water to rural residents and communities as it takes 3 gallons of water to produce 1 gallon of ethanol.

Safety also was a major issue during the months long hearing the board held on Summit's application in 2023 as many in attendance expressing concern about potential leaks as colorless, odorless carbon dioxide is an asphyxiant which can sicken, even kill, people exposed to it.



# LEAGUE OF WOMEN VOTERS\* OF IOWA 2025 Public Policy Priorities

# \* VOTING



Promote equal access to voting and ensure all votes are counted. Adopt automatic voter registration. Enact ranked choice voting. Pass a constitutional amendment allowing lowans with felony convictions to vote after time served. End electoral college.

### TRANSPARENCY & CITIZENSHIP



Demand government accountability and transparency by requiring all amendments and bills discussed in committee to be available to the public prior to a vote. Demand timely processing of Freedom of Information Act (FOIA) requests. Encourage direct citizen participation by continuing virtual committee and subcommittee meetings. Reinstate gender balance requirements for appointed boards and commissions.

# **EDUCATION**



Provide oversight and track public funds being used for non-public schools. Require any non-public school receiving public funds to meet the same standards as public schools. Fully fund public schools and reinstate all AEA functions. Continue to expand access to affordable childcare and free four-year-old preschool.

# TE REPRODUCTIVE RIGHTS



Guarantee access to the full range of women's reproductive health services. Repeal the six-week abortion ban. Make contraception available without prescription and promote programs that help prevent unplanned pregnancies. Ensure Medicaid services are comprehensive and accessible. Set policies that attract maternal health professionals and address the state's OB/GYN deserts.

HUMAN TRAFFICKING



Increase state funding for victim services; develop strategies to prevent human trafficking, domestic violence, and sexual assault; and enact "Safe Harbor" legislation to protect victims from criminal prosecution.

### ENVIRONMENT



Recognize the need for and fund water quality initiatives. Fully fund REAP. Develop state climate change strategies.

# GUN SAFETY



Enact comprehensive common sense gun safety legislation. Ban assault rifles and military-grade weapons. Enact background checks on all gun sales, close gun show loopholes, require gun safety locks, repeal "stand your ground" law, and oppose legislation that allows the carrying of guns in schools.
