# County Commissioner Amber Waldref, District 2



Amber Waldref, District 2  
County Commissioner,

The LWVSA Affordable Housing & Housing Solutions committee met with County Commissioner Amber Waldref on January 16th. For the past 2 years, elected officials and community leaders of multiple greater Spokane jurisdictions were attempting to create a Regional Housing Authority, which would have been an official government entity formed to combine funds and efforts to work on affordable housing and homelessness projects. However, this proved to be too difficult due to the power dynamics of the different jurisdictions. Fortunately, this group of individuals pivoted and agreed to meet informally in what is now being called a Regional Housing & Homelessness Collaboration. The goals of this Collaboration are to combine and reduce duplication of efforts in regards to funding, strategizing, operational issues and the collection and use of data.

One example of a project that this group is working on is collaborating on the collection, analysis and metrics of the Homeless Management Information System (HMIS). Every individual who interacts with affordable housing & homelessness services is entered into this system. The goal of this project is to understand how service providers and government employees are currently using this system and to train individuals to use the data, using best practices, to set goals and track key performance metrics. Also, as a result of this collaboration the City of Spokane, City of Spokane

Valley, Spokane County and the Spokane Regional Health District worked together to launch a new data dashboard to help the community better understand homelessness and programs that exist to provide support to those who are unhoused.

Amber would like to create a housing assistance fund to address the short-term needs of those individuals and families who are housing insecure and at risk of becoming homeless. These funds would be used for initial rent and security deposits and both government jurisdictions and non-profits could contribute to this fund.

Amber also would like to increase the number of detox beds in our region. The County is funding 12 new beds at Spokane Treatment & Recovery Services (STARS) and the city might fund 10 more beds, but she said we still need more places for people to stabilize and get substance use treatment.

Amber doesn't think there is majority Commission-

## LWVUS 2024 Survey

Every December, the national League of Women Voters conducts a survey asking local and state Leagues for data regarding activities for the year. Here is snapshot of the work of Spokane League members – it is not a complete list!

- 4030 volunteer hours
- 157 voter service activities
- 85 member volunteers
- 19 naturalization ceremonies
- 9 languages – general election ballots translated into Arabic, Chinese, Dari, Kinyarwanda, Russian, Spanish, Swahili, Ukrainian and Vietnamese
- 9 immigrant community partners – Asians for Collective Liberation Spokane, Find a Solution, Latinos en Spokane, Manzanita House, Mujeres in Action, Muslims for Community Action and Support, Refugee and Immigrant Connections Spokane, Thrive International and World Relief Spokane
- voter registration at Unity in the Community, Valley Fest, Spokane Pride, 3 retirement homes, Eastern Washington Legislative Forum, Freedom in the Arboretum, Spokane Community College, Eastern Washington University, Spark Central, Rosauer's, and several other community events
- OSPI candidate forum in the primary election
- civic education in all Spokane Public Schools

# Meeting with Spokane County Elections Office

The Spokane County Elections Office has been a long-time partner of the Spokane League. The County Auditor and League member, Vicky Dalton, has supported our League's outreach efforts to young voters in the high schools and to new citizens at Naturalization Ceremonies.

Spokane County Elections Office asked to meet with the League, and we were asked by three workers, "What do you do, and how can we help you in your work?"

Elaine Harger and I described the two parts of our mission, Empowering Voters and Defending Democracy, and the two parts of our organization – educating voters and affecting public policy. We offered examples of our work –

- tabling at many community events, including Naturalization Ceremonies
- presenting to high school students about voting and civic engagement,
- hosting candidate forums,
- translating the general election ballot into nine languages,
- observing and reporting on local government meetings.

We also offered examples of our advocacy work, stressing that while we are a nonpartisan organization, we sometimes take action on issues.

When asked how we could partner with County Elections, we had a wish list of:

- tours of the county election office and their processes
- invitation to be independent observers of the election process
- sample ballots, including envelopes, to show to first-time voters
- stickers, Mark the Ballot SWAG
- training about the Accessible Voting Unit for those with disabilities and limited reading ability
- invitation to partner with outreach events at local colleges (including the College HUB at Eastern Washington University)

This meeting presents an opportunity for the Spokane League. County Elections wants to become more involved with our work, and we can learn much from them. The Spokane League Board will be meeting soon; this recent discussion with Spokane County elections staff gives the Board some wonderful choices for strengthening this partnership.

er support for the County to adopt the 1590 tax at this time, which would add a tenth of a percent to sales tax to fund affordable housing. Some commissioners are currently prioritizing working with the community on a sales tax to fund criminal justice reforms and new jail facilities.

We asked Amber how the LWVSA could support this regional collaboration. She asked our committee and other league members to participate in the feedback process for the Continuum of Care 5-year plan. She feels that the community is not aware of the CoC Board and how to provide input

to plans to reduce homelessness and the league could serve as an educational body and conduit to the community. She encouraged our committee members and other league members to go on the Spokane City and Spokane County websites to learn more about the city, the County and CoC what they are doing to combat homelessness and promote affordable housing.
