As you can imagine, there is a lot of controversy over this new law. Come hear what all the fuss is about.

President's Perspective:

The hardest working people this year have to be those who work in our city and township clerks' offices. These women and men have been "dancing as fast as they can" to implement the changes to Michigan's election laws resulting from the passage of Prop 2 of 2022. An additional challenge has been that this is a presidential year. Provisions had to be made for nine (9) days of early voting for both the primaries in February, August and the election in November. Because their state representative was

elected mayor, Westland had to hold a special election, which included an additional primary and election.

The League, along with other community organizations, has been involved in a Clerk Engagement program. We wanted to make sure the clerks have what they need to run elections. Several of us met with clerks in our areas to see where we could help and let them know that we were a resource that could be counted on. At our February membership meeting we heard from Livonia City Clerk, Lori Miller, about how they are preparing for the increase in work load.

Thank you to those who worked one or more of the elections. Some of you worked both early voting and the primary election. For those who have never done this work, there will be another primary in August and the general election in November that will offer you an opportunity to join in. If anyone has a doubt about the integrity of our election system, they need to work as a poll worker. You will see first hand the number of checks and balances in place to keep the election safe and secure. While it was a long day, it was a very fulfilling day. At my polling location in February's primary election, we had a number of first time voters who were so thrilled to be casting their first vote. That was exciting to see.

Some of us also worked a shift or two at the Board of Canvassers in downtown Detroit. This is where the paper ballots are actually counted by hand and verified that they match with the tabulators. There are four Board of Canvassers members, two Democrats and two Republicans. Their job is to verify the numbers and certify. It was interesting to see a room filled with ballots by precincts with workers counting and verifying. Most of the time it was like "watching paint dry", and that is a good thing. The primary election was fully certified in Wayne County on March 12, 2024.

Our Voter Service team is busy at work updating materials and keeping an eye on who is running for office in our geographical area. Not only does the League offer online and print election guides for voters this year, we will be doing candidate forums for as many races as we have capacity to do. Please consider stepping up and volunteering to help provide these voter education services through the League and/or volunteering to work the elections. Let's not forget Megan Chenoweth who powers our Vote 411 digital presence; her work to keep Vote 411 updated is a huge benefit to our voters. "This is not a drill;" it is a big election year, and we need your help.

Doing this presentation earned our League \$300 of grant money offered by the State League. We have until May 31st to do additional presentations, earning \$100 for each, to a maximum of \$600. 2024-2025 Friedrichs / Bowman Scholarship

To provide financial support for students who are pursuing their educational goals at Schoolcraft College, our League established this scholarship. In addition to a monetary award, the LWVNWW County gives a free one-year membership to recipients of the Friedrichs / Bowman Scholarship with the desire that the recipient attends at least one LWVNWW Co. meeting.

The 2024-2025 Friedrichs/Bowman Scholarship is **now open** on the Schoolcraft College Scholarship Universe portal for students to apply. The application will remain open until Jun 23, 2024. The first round of award decisions will be in July or August 2024. Two students will be selected based on the scholarship criteria.

Scholarship Criteria:

Full-time or part-time enrollment required.

Students must have a cumulative college GPA of 2.0 or higher to be considered.

NOTE: No criteria other than the standard Foundation essays on career goals and how the scholarship will help them.

If you know an eligible Schoolcraft College student, please encourage her/him to apply by the deadline of June 23, 2024. To access the scholarship, they must log into their Schoolcraft College student portal, access Scholarship Universe, and search for the Friedrich/Bowman Scholarship.
