Our **Annual Meeting** will be held on **Thursday, May 15 at 5:30** p.m. at **Tri-Tech** Vocational & Technical School (5929 Metaline Ave. in Kennewick). It will be a buffet dinner, \$25 per person. Please have cash or your checks, made out to LWVBF, ready so they can be collected at the door. The buffet menu (grilled chicken puttanesca, roasted potatoes, roasted asparagus, green salad and strawberry shortcake trifle, coffee and tea) has vegetarian and gluten free options. **RSVP** to Diane at <u>molleson@frontier.com</u> **by May 6** if you plan to attend. Please understand that we are responsible for all the meals we order, so any no-shows will still have to pay. At the meeting, we will elect a new slate of officers and board members, pass a budget and a program of work. We will also be giving two Marilyn Perkins Scholarship Awards to the winners of our annual essay contest. The winners are invited along with their parents, and it is inspiring to meet them.

The **LWVWA's State Convention** will be held in Vancouver, Washington on **June 6-8**. Guest speakers will include WA State Attorney General Nick Brown and LWVUS President Dianna Wynn. We can send four delegates and currently have three interested LWVBF members. Members can also be observers, and can attend in-person or virtually. Voter Registration Drives

League Members can go to <u>https://www.lwv.org/take-action</u> to sign up for alerts from the LWVUS. The LWVUS encourages members to contact their senators to oppose the *Safeguard American Voter Eligibility (SAVE) Act*, "which would require citizenship documentation to register to vote even though voters in every state are already required to affirm or verify their citizenship status when registering. The *SAVE Act* would create one more barrier to the voting process, as many eligible voters do not have easy access to the necessary documents."

Income and Expenses: In March, we received one new membership from Marie Bang. The total deposits for the month of March total \$200.61. This includes donations from members from the Pi Day/Immigration Consensus Meeting event at Diane's house and the Go Green Table Talk at Shalom. Expenses totaled \$759.75 and included reimbursement to Diane Molleson for the printing of TRYs (\$570.68), reimbursement to Janet Nail for name tags (\$127.07), and the room charge at Shalom (\$40.00).

Transition to ChapterSpot Membership Platform: The League of Women Voters of the US (LWVUS) launched the new membership system on February 3, 2025. The rollout of the new system has been slower than expected. As of April 7, members, other than selected officers, have not received an email inviting them to log in to the ChapterSpot portal and create a profile. If you would like to complete this step, members can log in at the LWVUS website and choose the Profile button to create a profile. We are still expecting LWVUS to send invitations to create a profile when they have caught up with questions and fixes with ChapterSpot. You will not be asked to renew your membership until it expires in the Fall.

Making Donations to LWVBF - Carla Ciotti

Many members of LWVBF have generously made donations to our local league usually by adding money to their annual dues. With the change to the new ChapterSpot Membership System, donations made by increasing your annual dues will be divided among National, State, and Local leagues. Our share will be 20%, minus processing fees.

When you are asked to renew your membership, we would like to encourage you to pay the recommended dues of \$75 (this has been our league's regular dues amount), then use another method to donate extra to our league.

Ways to donate to our local league:

- The recommended method is <u>write a check</u>! A check written to LWVBF and mailed to P.O. Box 765, Richland, WA 99352 will be deposited into our bank account and used for local programs and operating expenses. Every penny of your donation will go to our league. Although our league is a charitable, non-profit organization, we are not a 501(c) 3, so this donation will not be tax-deductible. Donations will be greatly appreciated, especially during the uncertainty of the ChapterSpot transition.
- 2. Go to our website, https://my.lwv.org/washington/benton-franklin-counties. The Donate button will take you to a page where you can donate either to the Education Fund (more on that below) or to the League of Women Voters. If you choose the second option, you will be directed to another page that gives you a choice to either donate by check or to continue and donate using PayPal with your credit card. Donations will come directly to our local league, minus PayPal fees.
- Go through the LWVUS ChapterSpot website when you pay your dues. The donation button for local leagues will be on the page following your dues renewal page. Remember if you simply add money to your dues amount we will only receive a fraction of it. If you use the donation button we will receive the amount minus Stripe transaction fees.

2025 Legislative Update from the LWVWA – Lora Rathbone

The 2025 Legislative Session for Washington state ended April 27. LWVWA issue chairs chose from hundreds of bills to prioritize. And this year, as is usually the case, only a few of the bills passed. Many thanks to all of you who signed in "Pro", sent comments, or even written and oral testimony!

Bills that have passed or are likely to pass this year, as of this writing:

Making Democracy Work

SB 5077 - Expansion of voter registration services. (Automatic Voter Registration Expansion) 8th & 16 Legislative District Senators and Representatives voted no.

SB 5400 - **Supporting local news journalism.** Co-sponsored by Senator Boehnke. It would help address the local news decline in Washington state by funding the employment of news journalists to cover civic affairs in underserved communities. New dollars would come from for-profit social network sites and internet search portals and websites that gross more than \$5 million annually. These firms don't compensate news outlets for the original content they use on their own platforms.

AHB 1060 - **Concerning newspapers and eligible digital content.** Requires newspaper printers and publishers who were exempted from Business & Occupation taxes for 10 years to submit a complete annual tax performance report. House- unanimous. Senator Boehnke- no, Senator Dozier- yes.

Social and Economic Policy

Health Care:

HB 1142 - Standardizing basic training and certification requirements for long-term care workers who provide in-home care for their family members, including spouses or domestic partners. Amends the training requirements for long-term care (LTC) workers who are providing in-home care to their family members to align the training requirements across the in-home care provider types. Passed. Effective 7/27/2025. 8th and 16th Legislative District Senators and Representatives voted yes.

HB 1432 - Improving access to appropriate mental health and substance abuse disorder services. To improve access by updating Washington's mental health parity law and ensuring coverage of medically necessary care. 8th and 16th Legislative District Senators voted yes, along with Representative Rude; the other Representatives voted no.

Housing:

HB 1217 - **Rent Stabilization**. Improving housing stability for tenants by improving the current situation of rent gouging and short notices to tenants, making them unable to adjust to rent increases. 8th and 16th Legislative District Senators and Representatives voted no; believe it leads to housing shortages.

HB 1353 - Establishing a self-certification program for accessory dwelling unit project permit applications. Allows cities planning under the Growth Management Act to operate programs through which registered architects can certify compliance with applicable building codes. Unanimous. Passed. Effective date 10/1/2025. <u>SB 5148</u> also relates to GMA housing requirements.

HB <u>1491</u> - **Transit-Oriented Housing**. Provides guidelines & assistance to cities in achieving this type of development. It helps with affordable housing and promotes use of transit. All 8th & 16th District legislators voted no.

Environment:

HB 1409 - The Clean Fuels Program. Strengthens CFP standards - means more incentives for and investments in clean fuels, including investments in electric vehicle infrastructure and utilities to improve air quality. 8th & 16 Legislative District Senators and Representatives voted no.

HB 1462 - **Reducing greenhouse gas emissions associated with hydrofluorocarbons.** Their use in refrigeration, air conditioning, and heat pumps make them significant contributors to climate change. Better working fluid alternatives are available and in use. All 8th & 16th District legislators voted no.

SB 5284 - **The Recycling Reform Act.** Establishes an extended producer responsibility program for covered packaging and paper products. All 8th & 16th District legislators voted no.

Progressive revenue:

Because of the state's budget shortfall, we were also asked to advocate for additional revenue. The deficit "stems from an unanticipated downturn in forecast revenue combined with an upturn in services needed and committed." Washington state has the second most regressive tax structure in the US, resulting in a greater burden on lower income people. The League asked that legislators not reduce services and not increase regressive forms of tax to generate new revenue; rather, that they consider new progressive sources of revenue".

The final LWVWA Legislative Newsletter will be issued May 4 and will report on bills that passed and will summarize the implications.
