# President's Message

As we move into May, our League focus is upon the June 5th Primary election. Voter Service Chair Elizabeth Brady is organizing quite a few events. Voter registration is being done by some members, but the call for that service is waning as more and more organizations also take up the voter registration baton. With new DMV automatic registration laws taking effect, the pool of the unregistered is shrinking, which is good news indeed. Our special task is to help voters become informed. We are beginning training to deliver the Pros and Cons on the ballot issues on the Primary ballot and, of course, this will lead to the November ballot issues. All of you know that only the legislature can put ballot measures on the Primary ballot, so we have 5 issues to consider in June. But November is when Initiatives come before the voters, and this November we have an array of issues to vote upon. Our trained Pros and Cons presenters will be invaluable to help voters think through the ballot measure proposals.

We are also going to do the Mail Ballot Drop-Off Program (MBDO) with the Registrar of Voters at three local libraries for the June Primary. Over 30 members have signed up and are being qualified by the County of San Diego to be temporary County employees so that we can monitor official ballot boxes at Carlsbad Dove, Encinitas, and Oceanside Downtown libraries. People will be able to deliver their Mail Ballots to these sites the week before the June 5th election at any time the libraries are open and put them into the ballot boxes.

The public can also educate themselves about those who are running for various levels of public office at our candidate forums. We have already moderated four major forums just for the 49th Congressional district seat currently held by Representative Darrell Issa! Each forum takes a team of League members – a minimum of six. If you want to pitch in for either the Primary in June or the General Election in November, give Elizabeth Brady a call.

Finally, sincere thanks to Margaret Liles, our Newsletter Editor. She has done a great job for years, organizing and getting out our monthly newsletter, the Voter. Her term is up in June, and she is unable to continue. Words can't express our appreciation for her dedication and care.

# League of Women Voters Policy of Non-Partisanship - What Does That Mean Exactly?

The League of Women Voters is renowned nationally for its consistent non-partisan policy, but it's easy to be a little fuzzy on what that actually means, especially in the current very adversarial political climate, when it's easy to feel that "partisan" action is required to address real policy concerns. Where did our LWV stance originate? How do we observe it today?

League founders in 1920 felt that keeping a non-partisan stance would protect the fledgling organization from being embroiled in the politics of the day, but League members were encouraged to be political themselves through citizen education and lobbying efforts to achieve government and social reform legislation. This continues today. The League enjoys such a stellar reputation for fairness because it neither supports nor opposes candidates or political parties at any level of government, but studies and works on issues of concern to members and the public.

You may be surprised to learn that the League moderated Presidential debates. For 16 years after the Nixon/Kennedy debate of 1960, no televised presidential debates were held until 1976, when the League sponsored the televised Presidential debate and even won an Emmy award for Outstanding Achievement in Broadcast Journalism! The League continued to sponsor the presidential and vice presidential debates every four years through the 1984 elections. Following that election cycle, the Democratic and Republican national parties came together in a decision to move sponsorship of the debates under the purview of the parties. When the League challenged this move, it sparked national debate on the matter because the LWVEF (League of Women Voters Education Fund—the education side of LWV) argued that changing the sponsorship, putting control of the debate format in the hands of the two political parties "would deprive voters of one of the only chances they have to see the candidates outside of their controlled campaign environment." The LA Times noted, "Since 1976 when the league institutionalized presidential debates, "sponsorship" by the league has come to represent integrity and representation of the voter's interests. How could the league sign an agreement which runs counter to all the principles the league represents... The commission is the Democratic and Republican parties. They have a responsibility to the candidates. The league has a responsibility to the voters." High praise indeed.

The clearest statement on how League members should interpret our League policy of non-partisanship was contained in a recent note from Helen Hutchison, our State President, in addressing our local Board members and for responses to the public:

LWV is non-partisan but is political. We never promote or support any party or candidate. But we do advocate policy. LWVUS and LWVC take strong stands against policies that don't support our mission. Mentioning an **elected official** or **administration** does NOT make a comment partisan. Part of our advocacy role is holding our elected officials to account for their actions.

We are not going to stop making statements because they make people uncomfortable. We will continue to listen to criticism to make sure that our statements are based on policies.

So here are a few questions you might have, and our President Anne Omsted's answers:

- Can I join the campaign of someone who is running for local, state, or national office as a volunteer and work for them? Yes, as long as you do so as an individual and do not use or display your membership in the League or present any views as League views
- Can I take part in marches and/or demonstrations as a private person if I'm a LWV member? Yes, subject to the same conditions listed above, as a private person in your own name and not that of the League
- What can I not do as a League member if I am participating in an election? This is often decided upon depending on the circumstances. For instance, you can participate in a Pro and Con as long as the information given is from the League and no other source. We would not permit you to sort questions or moderate a Forum but you could be a runner or timer. Again, no mention of a political party or candidate is permitted.



# All The Right Stuff

The LWV Public Policy Position on Gun Control has all the right stuff needed to stem gun violence in America. It is has been carefully reviewed and updated over and over again since the 1990's. Here's a teaser to get you dig it out and read it yourself:

The League of Women Voters believe that the proliferation of handguns and semi-automatic weapons in the United States is a major health and safety threat to its citizens...

I call your attention to this now because of the renewed pressure that the survivors of the massacre at the Parkland school have brought to bear on our legislators to pass gun laws to help end the senseless shooting deaths of children and adults.

The proliferation of guns in our society as a result of the repeal of gun control laws and the passing of pro-gun laws over the last 40 years has resulted in some frightening statistics:

- The number of guns manufactured in the US nearly doubled in 3 years to almost 11 million from 2010 to 2013.
- There are roughly twice as many guns per capita in the US as there were in 1968 more than 300 million guns in all.
- Americans are 25 times more likely to be murdered with a gun than people in other developed countries.
- On an average day 96 Americans are killed with guns.
- In an average month 50 US women are shot to death by intimate partners.
- Guns are now the third-leading cause of death for all Americans under 18.
- 91 percent of children under 15 who were killed by bullets lived in the US.
- On average two dozen children are shot every day in the US.
- More than 208,000 students attending 212 schools have experienced a shooting at school since the Columbine High School massacre.

 In the 20 years ending in 2012 there was an average of 3 school shootings per year in California.

Right here in San Diego County there have been three school shootings since 2000 and just last year there was a mass shooting at an apartment complex. Many of our fellow citizens in San Diego feel enough is enough and are looking for ways to reduce the risk of gun violence in our communities. We have gone to city councils and school boards and requested resolutions that call for stronger gun control laws and call for the end of gun shows at the fairgrounds.

The 22nd District Agricultural Association, a nine member board appointed by the governor has the authority to end the hosting of gun shows at the fairgrounds and section 6.25 of their governance manual states: Whether or not a fair rents out their facilities for gun shows is a policy decision to be made by the fair board and their community. The 22nd DAA has been targeted by NeverAgainCA to receive numerous appeals by letter and in person asking them to vote to end the gun shows. We want to encourage you to express your opinion on this issue and get involved, even just to write a postcard or letter, go to one board/council meeting or go to one rally. You can't sit on the sidelines, no one expects it to happen to them or to their community until it does. Carlsbad Unified School District receives its final waiver approval from the State Board of Education for its new district election map: On March 15, 2018, the California State Board of Education approved the requested waiver of the Education Code Requirement that the Establishment of Trustee Areas and Adoption of a By-Trustee Area Election Process be put to a vote by the Electors of the District. **Update on pre-registering 16- & 17-year voters** – In exciting voter registration news, Secretary of State

In exciting voter registration news, Secretary of State Alex Padilla was recently quoted as saying that their office is registering "future voters" at the fast speed of ~1,000 per week. He went on to say that in the weeks between March 14<sup>th</sup> and April 2<sup>nd</sup>, over 7,000 new 16- & 17-year old voters pre-registered! This is certainly exciting news. In my opinion, these new voters present another great opportunity for the League to educate them on how to finalize and change their voter registration once they've turned 18. Many new voters may not know how to change their voter registration, or know about mail-in ballots if they move away for college. We've got much work ahead of us! Bravo to the students who are getting civically engaged following the horrific events at Parkland. To read more:

## **Board Briefs for April**

At the April 13th Board meeting, the Board took the following actions:

- Approved the new Position on Homelessness. It now goes to the membership for approval at the Annual Meeting on June 9, 2018.
- Approved the new Member's Handbook, which will be sent to every member to provide information about our league, background on how the League works, and current reference information.

#### **Board Briefs Continued**

- Learned that the San Diego League is planning to do a study on Transportation in the County and invites us to join them. The Board agreed to invite members to participate.
- Heard the Nominating Committee's recommendations for Board and Chair positions for 2018-2019 and will request adoption at the Annual Meeting on June 9th. (Continued Page 7)
- Learned that LWVC and the coalition of proponents had decided to move the California Schools and Local Government Funding Act of 2018 to the 2020 ballot, collecting signatures until June, 2018.
- Heard a presentation from Co-Webmaster Loann Simon about a Marketing and Communication Plan for our Board to better serve our members. It was adopted.
- Heard about some serious transfer problems related to shifting our website to MyLO, the new LWVC web system and authorized expenditure of up to \$3,500 to address those problems.
- Adopted a policy on expenditure of ILO monies which our League received with the dissolving of the San Diego County ILO last year.
