May 4-7 LWVWA Convention at the Holiday Inn Express in Pasco -Many thanks to the members who will be volunteering at this event. It is greatly appreciated! (FYI-Meals can be purchased separately, even if you don't plan to attend Convention as a whole, or if you are a volunteer but would like to eat a meal(s). Lunches are \$32.00 and dinners are \$35.00. Membership and Dues: We currently have 85 members, including 8 students, and 9 second-in-household members.

2023 Convention: Beverley Johnson-Torelli, Diane Molleson, and Wendy Espinosa, will attend the State convention as delegates. We are hosting the convention in Pasco May 4-7. Karen Miller, Martha Swedlund, and Chuck Torelli will attend as Observers. The registration fee is \$260.00 and early bird registration ends April 18th.

Ed Fund: Our State Ed Fund dollars should be \$12,590.00. We received a \$75.00 check from Jane Sereda which went to our State Ed Fund. We have received the \$1,500.00 for the Civics Ed Fund grant. \$2,100.00 will be taken out for this year's scholarship.

Membership, Engagement and Leadership Development ~ Leona Hassing

MELD pod #4 met at the monthly Zoom meeting in late March with five in attendance. Three representatives from Kitsap, Thurston and Benton-Franklin counties, the pod facilitator from Mason and LWVWA President, Lunell Haught.

Each rep told of the key accomplishments in their units over the last month. Topics included, but not limited to Tribal affairs, scholarships, DEI (diversity, equity, and inclusion), and maintaining membership.

President Lunell talked about activities with the State League. She was very excited about the upcoming Convention in the Tri-Cities, noting the quality workshops. the extra activities available for the attendees and just members meeting together for the convention. The discussion topic for this month was -- Advocacy Now and Beyond -- how might your Local League encourage member engagement during and after the legislative session? Among ways discussed were attending town hall meetings, maintaining a personal contact with your legislators, becoming familiar with local city councils and county commissions, establishing an Observer Corp. Information about Observer Corp can be found on the League website under member resources.

LWVWA Advocacy Report ~ Lora Rathbone

The 2023 WA Legislative Session has ended and there is a lot to celebrate! Thank you for all the ways you participated. It does make a difference when we work together.

Here is a note from the LWVWA: "There will be a final Legislative newsletter on April 30, containing some summary (and celebratory!) information. And then a final-final note identifying bills that the Governor has signed or vetoed. This will be mid-May, since the Governor has a period of time after the end of session to decide about signing bills that have been passed by the legislature. Thanks so much for your valued and consequential participation this session—it matters, and it counted!"

These are the bills the LWVWA supported. **Please send a note to your legislator to thank them if they supported one of these bills**.

Democracy: See descriptions of the bills <u>HERE</u>. <u>Bills that have been signed by the Governor and are now law:</u> HB 1048- Enhanced WA voting Rights. Effective date 1/1/2024. All 8,9,15,16 LD Senators and Reps voted no. SB 5082- **Abolish Advisor Votes**. Effective date 7/23/2023. All 8,9,15,16 LD Senators and Reps voted no. Bills that will become law when the Governor signs them:

SB 5112 - Updating the voter registration process. All 8,9,15,16th LD Senators and Reps voted no.

SB 5208 - Updating the online voter registration process. All 8,9,15,16th LD Senators and Reps voted no.

HB 1317 - Concerning grassroots lobbying disclosure. all 8,9,15,16th LD Senators and Reps voted no
