# History of Earth Day, Julie Grinde

In the 1960's there were not many laws to protect our water and air and there was not an Environmental Protection Agency (EPA). Gaylord Nelson was the Governor of Wisconsin during that time, served two terms and became known as the "Conservation Governor." After he was elected Senator in 1962, he proposed that a day be set aside for education in environmental issues... a Teach-In for the country to spotlight the environment and set a political agenda. Each community could address the issues that affected them and celebrate Earth Day in their own way. He persuaded Congressman Pete McCloskey, a Republican, to co-chair this event and hired a national coordinator to plan events across the country.

On April 22, 1970 Americans demonstrated in massive rallies to support a healthy sustainable environment. Over 20 million people including 10 million elementary and high schools and 2000 colleges participated. People across party lines, scientists, and people from all walks of life were part of the event and set in motion an environmental movement for change.

The EPA was created and countless numbers of laws to protect the environment were passed. Some included: Clean Air Act; Water Quality Improvement Act; Resource Recovery Act; Toxic Substances Control Act; Federal Environmental Pesticide Control Act; Endangered Species Act; Safe Drinking Water Act; the Federal Land Policy and Management Act; and the Surface Mining Control and Reclamation Act. In 1995 President Clinton awarded Senator Nelson with the Presidential Medal of Freedom for his role as the founder of Earth Day. Earth Day 1990 mobilized 200 million people in 141 countries that gave environmental issues a global stage. Ten years later Earth Day focused on climate change and clean energy. Over 5000 environmental groups and 184 countries participated.

Earth Day 2020 marked the 50<sup>th</sup> Anniversary with the theme "climate action." It went entirely digital for the first time and provided a global 12 hour live streaming music and speaker event. One goal was to build a new generation of environmental activists with millions of participants world-wide.

This year a **THREE DAY CLIMATE ACTION** (April 20-22) event will feature three separate climate action summits involving 1 billion participants and culminate in President Biden's climate summit on Earth Day. # A HISTOTY NOTE FOR YOU....About Earth Day, J. Grinde

All three levels of the League of Women Voters have been supportive of Earth Day since the first Earth Day in 1970. Senator Gaylord Nelson declared April 22nd as a time to celebrate our earth and its resources. According to a local news article in the Herald-Times Reporter, over 100 recycling projects in the county were initiated on the first Earth Day in 1970.

During the 1970's and early 1980's, a group of people from the University of Wisconsin-Manitowoc campus, members of the League and other community volunteers began to collect newspapers for our first recycling efforts in Manitowoc. Discarded newspapers were placed on city street corners to be picked up, brought to the center to be placed on a truck and sent to a recycling center outside of the county.

League does not have a written record of Earth Day events until 1990 when a city-wide celebration took place at the UW-Center. Susan Mudd, President of Citizens for a Better Environment, was the key-note speaker at this event sponsored by the UW, League and other community groups. The Fine Arts Room was filled with displays and exhibits about how to care for the earth. Children could display posters on the environment. The Lecture Hall had scheduled speakers to provide education to all who attended. Nine league members were on the committee which was chaired by Vicki Mayer and Cindy Jacobson. Over 200 people attended and enjoyed the family activities.

Each year from 1990 to 2002 the Earth Day event was held at the UW-Center on Saturdays or Sundays near April 22nd. These were sponsored by League, the University and sometimes other community groups. Speakers were doing demonstrations, involved in panel discussions or shared individual ideas about how to care for the earth. Family activities were planned including cleaning up the campus grounds and Silver Lake Park. Kite flying was popular and one year 100 kites were given away. In 2001 over 500 people attended.

In 2003 Earth Day was held at Expo and was combined with CleanSweep. Attendance was poor and the next year Earth Day was back at the UW-Center. This continued through 2009. The format always included speakers and demonstrations with many family activities and special experiences for children. Sometimes our league did water testing for people who brought in a water sample.

Then from 2010 to 2012 Earth Days were held at Silver Lake College. Speakers and 20 exhibitors provided information on composting, organic food, wildlife and wind energy. There was a Nature Hike, ground water testing and recycled art projects. The week prior to Earth Day, there was a community wide collection of electronic devices and expired medications by the students of Silver Lake College and Lakeshore Technical Institute. There was also a community rummage sale where people could recycle books and other items. Other activities included learning about alternative energy, face painting and flower planting for children.

The league usually had people sign petitions on state legislation regarding clean water and air and support for state funding for recycling and energy conservation programs in Wisconsin. We also provided information so people could see what legislative district they lived in and who the representative was for that district. For the next two years Earth Day was held at JFK Fieldhouse and then for the next 3 years Earth Day was combined with Healthy Kids Day and held at the YMCA. There were demonstrations, exhibits and music related to Earth Day and healthy

living. The league had an exhibit highlighting local water issues and information on living Green. Earth Day 2015 had over 350 people who attended.

When the YMCA was being remodeled in 2018, the community did not sponsor an Earth Day but supported the Earth Day events at Grace Congregational United Church of Christ in Two Rivers. A representative from Woodland Dunes and one from the Nature Conservancy were the main speakers. Exhibits, food and games were available and League had a display on the history of Earth Day.

In 2019 the League co-sponsored the Earth Care Festival at the UW-Center. There were 35 exhibitors and a speaker from the Wisconsin Sea Grant. Some of the exhibitors included Great Lakes Conservancy, Friends of Branch River, Woodland Dunes, LTC Wind Energy Group and the Butterfly Lady. Activities for children included games, crafts and prizes.

Since the first Earth Day, league members participated in newspaper recycling and since 1990 have co sponsored Earth day activities for the community every year.

#### **BOYS AND GIRLS CLUB**
