The following is for the newsletter and Annual Meeting booklet. This is some background as to what **DEI** is and why we need a **Land Acknowledgement** statement.

WHAT IS DEI?

LWVMC is an organization fully committed to diversity, equity, and inclusion (DEI) in principle and in practice. There shall be no barriers to full participation in this organization. Diversity, equity, and inclusion are central to the organization's

current and future success in engaging all individuals, households, communities, and policy makers in creating a more perfect democracy.

Land Acknowledgement Statement

Our board has approved the following statement that will be approved by the general membership at our 2023 Annual Meeting.

We acknowledge that we reside on traditional Ho-Chunk, Menominee, Ojibwe(Chippewa) Ottawa, and Potawatomi homelands along the west shore of Michigami, North America's largest system of freshwater lakes, and the Manitowoc, Mishicot and Neshota Rivers. This is now what we call Manitowoc County. We recognize these peoples' past history and continue to honor their connection to these ancestral grounds.

Truth and acknowledgement are critical to building mutual respect and connections across all generations. We welcome opportunities to advocate for the continued connection between Indigenous nations and their tribal lands. Please take a moment to honor their ancestral grounds and to celebrate the unwavering resilience and tenacity of the Indigenous peoples still here and throughout the world.

Non-Partisan Policy

The League of Women Voters of Manitowoc County may take action on local governmental measures and policies in the public interest in conformity with the principles of the League of Women Voters of the United States. It shall not support or oppose any political party or any candidate.

The Board of Directors is responsible for carrying out the League nonpartisan political activity/conflict of interest policy in its community, keeping in mind that everything the League does should be measured against the yardstick of nonpartisanship.

While the League encourages its members to be active politically, we specifically prohibit the President and Voter Service Chair from:

Running for/or holding elective office, and

participating in political campaigns including fund raising, contributing financially, chairing campaign events, working for, endorsing or

contributing in any significant way to a campaign for a political candidate or political party.

(Article II – Purpose and Policy: Sec. 2, Policy)

LOCAL STUDY ON POVERTY IN MANITOWOC COUNTY

At the Annual Meeting in 2015, the League of Women Voters of Manitowoc County voted to begin a study of poverty and its impact on families in our county. Committees established then researched poverty and its relationship to four factors: Economic, Food, Shelter and Health. Each committee put aside their committee work to join the Health Committee when they recognized the scope of the drug crises facing out county. This committee competed an extensive report "Poverty and Addiction in Manitowoc County" about the effects of substance abuse on low income households. The report was released in October, 2018 and the League advocated for a number of support positions covering human services needed, criminal justice issues, public schools needs and government responsibilities.

The next concern of the study was to focus on Housing in our county. This committee met a few times before Covid forced the committee to abandon meeting and continue any additional study. Since then a Housing committee has not been formed and no one has been able to step forward to chair a committee. The lack of adequate and affordable housing is a constant need in the community.

At this time the Board of Directors recommends the membership vote to **DROP** the poverty study adopted in 2015. Members will be asked to support this recommendation. The members present at the Annual Meeting can vote to **DROP** or **RETAIN** the local study. If this is the members' choice to **RETAIN** or continue the study, people will need to volunteer that evening in order to begin committee efforts.

Other items that members will need to vote are: BUDGET, MINUTES OF ANNUAL MEETING – 2022; CONTINUED SUPPORT OF LWV-MC LOCAL PROGRAMS. LEAGUEOF WOMEN VOTERS OF MANITOWOC COUNTY ANNUAL MEETING – May, 2022

League members were unable to have a traditional in-person Annual Meeting due to COVID-19. Members got the Business Meeting information and ballot through their email or the postal service. Members were asked to vote on 3 items: Proposed 2022-2023 Budget, Report of the Nominating Committee, and Local Program with a recommendation to continue the Poverty Study with a focus on Housing in Manitowoc County. Our Local Program consists of support statements for all of our local studies dating back to 1969. Our League has 64 members and 40 responded Yes to all of the agenda items with no one voting No.

BUDGET

The proposed Budget is based on local dues of individual (\$55) and Household (\$80) providing an income of \$3150, Member Contributions of \$1000 and grant income of \$50. There was a transfer from savings of \$1575 bringing the total of **Income to \$5611.00.**

Major expenses included \$1760 (LWVUS) and \$1650 (LWVWI) to pay our dues to national and state leagues. (Dues for both of these levels of league total \$62.00 per member) Other major expenses include \$350 for speakers, \$300 for Great Decisions, \$400 for web site maintenance, and \$275 for room rental/zoom. The total **Expenses were \$5611.00**.

The Proposed Budget for July 1, 2022-June 30, 2023 was accepted by all who voted.

LOCAL PROGRAM:

The League of Women Voters of Manitowoc County supports two major goals through our Local Program. One goal is to provide Voter Service information to people regarding how and where to vote and how to participate in the election process. League also sponsors non-

partisan candidate forums for the community. A second focus is to sponsor public information programs on issues of concern to League and the community.

Another part of Local Program includes Support Positions for local studies the league has done in the community since 1969. Each of the 18 Support Positions is related to a local study or issue. These have included day care, school lunch, drug treatment court, mental health issues and poverty in Manitowoc County.

The Board recommends that league continue to support our Local Study - "Poverty in Our Midst: How It Affects Families in Manitowoc County and Our Community" with an emphasis on housing in Manitowoc County.

The Local Program was accepted by all who voted.
