POVERTY AND HOUSING IN MANITOWOC COUNTY

The League will be hosting a Forum on Poverty & Housing at Manitowoc City Hall on Thursday, February 20th, 2020 at 7:00 PM. This event is free and open to the general public. We encourage lawmakers and community representatives at all levels to attend, as well as those impacted by our lack of low income housing. An industry expert will address the current state of low income housing in Manitowoc, and will explore what it would take to have enough housing to meet the need. We will look at how similar issues have been addressed successfully in other communities. We will advise on the different types of housing, as well as what is currently available and what the wait lists look like. We will then discuss the launch of the 2021 League of Women Voters of Manitowoc County Poverty & Housing Study.

POVERTY STUDY UPDATE

We completed our study on "Poverty and Addiction in Manitowoc County" and distributed 240 studies in the community. Printing of this publication was possible through a grant from the West Foundation and the generosity of John and Kate Miller. We have about 20 copies left. Currently, members of the committee are meeting with the Superintendents of the schools in the county to share our 6 recommendations for public schools that were a part of our concurrence statements.

A committee has been formed to study the low-income housing issues in the county which was identified as another component of our Poverty study. This will be our focus for the next year. The League October 20th meeting described in this newsletter will be a discussion of the housing issue.

Members of the Housing committee include Theresa Collins, Erica Strauss, Julie Grinde, Nancy Slattery and Cecilia Held. We would like to have at least 2 more

our members as well as the general public on what is happening in our local government. Currently Mary Wallace, and Sue Matczynski will be taking turns observing the Two Rivers City Council; Linda Gratz will be observing the Manitowoc School Board; Cathy Cole will be observing the Two Rivers School Board; Darlene Wellner and Linda Gratz will be observing the Manitowoc County Board; Theresa Collins and Erica Strauss will be observing the Manitowoc Common Council; Ceil Held will be observing the Criminal Justice Coordinating Council; and Ceil Held and Erica Strauss will be observing the Human Services Board. Purpose:

Mission: Informed and active participation of citizens in government, increased understanding of major public policy issues, and influencing public policy through education and advocacy is an important part of many organizations. An Observer Corps helps meet that mission. By regularly attending public meetings of local governmental agencies, the Observer Corps' members keep elected officials aware of the organization's interest in local government and helps all the organization's members and the general public be better informed citizens through the reports on those meetings.

Current local Situation:

Currently our community doesn't have the reporting on local government that was standard several years ago. The newspaper and radio staff that formerly covered local government have been reduced in numbers and cannot provide information to the public in an on-going consistent manner. We are hoping that by implementing an Observer Corp and sharing this information through the media we can once again allow for transparency of local governmental decision making and accountability.

Objectives:

1. Strengthen communication between the organization and local government bodies, including county commissions, city councils, city commissions, township trustees, boards of education, planning commissions, and other boards responsible for a single functional area such as transit, health or parks.

- 2. Encourage individual members to become better informed regarding the decision-making process in local government.
- 3. Gather information and identify problems, issues, and trends in the community so as to enable the organization to assess its relationship and importance to current and future organizational programs.
- 4. Increase the visibility and enhance the image of the organization among elected and appointed officials, community leaders, and those persons responsible for effective delivery of services by public agencies.
- 5. Encourage better government through the observers' presence at meetings.
- 6. Share information with the organization's members and the public about issues that may affect communities in the area.

Process:

League members will volunteer to cover local governmental meetings. They will attempt to cover County Board, School Board and local Common Council meetings. The League will send a letter to the governmental bodies regarding this undertaking and who will be covering their meetings along with contact information. The League member will attend meetings and will complete the observational form which will be handed in to the League Coordinator who will determine the follow up needed. Follow up might include a formal response from the League Board of Directors based on League positions, and/or reporting out to members and the public information that has been gathered. The League hopes to work with local media staff to help disseminate information to the community members.
