MENTAL HEALTH COMMITTEE REPORT

Our Drug Court Virtual Forum was a big success due to the wonderful organization of Tim Gadzinski from the Manitowoc Public Library and the excellent presentation by Jason Latva, Drug Court Coordinator. He formed a panel that included Judge Dewane and three drug court participants. The three participants stole the show with their honest, brave, first-hand accounts of their struggles with addiction. Thanks also to NAMI and RUTH for cosponsoring the forum and contributing to Chamber Bucks to thank the three participants.

Our next project is to write a report on Mental Health Courts which we hope will serve as an impetus to get such a court for Manitowoc County. We have agreed on an outline and assigned parts of the task. We appreciate the participation of Kathy Protzman of NAMI. She has connected us with state level NAMI staff that support mental health courts and will be meeting virtually with us in February. We will keep the League appraised of our efforts.

MANITOWOC AREA HOMELESSNESS – PART II

The Lakeshore Continuum of Care, a coalition of agencies that aims to end homelessness in the area, will be hosting the director of the Wisconsin Balance of State Continuum of Care, Carrie Poser, for a two-part online series on homelessness in the area.

Part two will take place from 1 to 3 pm on February 8th and will look at local data that can help identify gaps, strengths, and begin discussion about next steps needed to strengthen coordinated efforts.

As part of the closing months of the League's 100th year birthday, the state office is initiating an Oral History Project to honor the over 90 Lifetime League members in Wisconsin who have been in league 50+ years. One of the goals is to record personal reflections from league members about why they joined, why they stayed in league and their message to prospective and new League members. Another goal is to share their perspective of what the League has done well and where it should direct its energy going forward.

Our League has 5 Lifetime League Members: Modesta Olson, Darlene Wellner, Connie Hendries, Marilyn Sontag, and Julie Grinde.

Our members will share information about how our league educated the community through our studies about Interstate 43, Nuclear Energy in Manitowoc County, the Manitowoc County Jail, Day Care Needs in Manitowoc County, Mental Health Services and our most recent study about Poverty and Addiction in Manitowoc County.

Local studies and projects can result in real changes in the community such as establishing the Municipal Court for the City of Manitowoc, the Drug Treatment Court for Manitowoc County, the Great Decisions Program, and continued work to improve Mental Health Services for our people.

The *Ernie & Joe* documentary, produced and directed by Jenifer McShane, follows two police officers with the San Antonio Police Department who are diverting people away from jail and into mental health treatment, one 911 call at a time.
