FROM THE ARCHIVES

The League of Women Voters of Wisconsin is honoring members who have been in league 50+ years and asking them to share their league experiences. As I was looking through our newsletters and minutes, I realized many of our current members are not aware of this league's impact in our community and how our league is connected to LWVUS and LWVWI. I thought I would give you short history notes on some of the issues we have studied and changes that occurred in our community because of the hard work and concern of our league members who still work on some of these issues today. A HISTORY NOTE FOR YOU.... About Day Care Position

In the 1960's a group of citizens who worked closely with children and families many of whom were in poverty, were concerned about the lack of day care services in Manitowoc County. This led to the Manitowoc LWV adopting a study on day care needs in our county resulting in our current position in support of "adequate day care services in Manitowoc County with a special emphasis on serving the needs of low-income children." League members were involved in establishing the Manitowoc County Day Care Association and by 1977 a day care center was opened in Two Rivers and two in Manitowoc. The study was written by Darlene Wellner, Lois Karn and Esther Wellner.

Since the 1970's the League of Women Voters of the United States has supported comprehensive child care services to prevent and reduce poverty and has lobbied for specific programs and legislation. They re-affirmed that position in 1989 under the "Meeting Basic Human Needs" national position.

A HISTORY NOTE FOR YOU....About County Government

The League of Women Voters of Wisconsin has been interested in strong county governments and in 1959 adopted a state study on County Government. The study was completed in 1961 and the LWVWI adopted positions in favor of smaller county boards, filling administrative officials by appointment and filling policy making officials by election. They concluded that strengthening of county government would occur with a county executive or administrator to head county government to deal with administrative responsibilities currently handled by the County Board Chairperson. The executive or administrator would provide the equivalent of a mayor or city manager in city government.

The state legislature defined the difference between a county executive (elected for a four year term with veto powers over county board decisions) and a county administrator (appointed with no veto power). The LWVWI encouraged local leagues to lobby for one or the other based on which was appropriate for their county.

The League of Women Voters of Manitowoc County advocated for a County Executive to head county government. The board failed to act. The League

conducted a successful petition drive which required signatures of 5,000 county citizens to enable the issue to be placed as a referendum on the ballot in 1969. It was soundly defeated by the voters and League efforts to get this passed were delayed for a decade.

In 1990 the League sponsored a meeting at the Capital Civic Center to discuss changes in county government which included the possibility of reducing the size of the Manitowoc County Board and whether a need existed for an executive or administrator and the pros and cons of each. Over 400 people attended. Our league supported a size of 15 county board supervisors. After that meeting, the Manitowoc County Board of Supervisors passed a resolution to decrease their size from 30 to 24.

At that time our league supported an Administrator given the evidence that some administrative head of county government was necessary due to the growing complexity and size of Manitowoc County government. This fact was increasingly recognized by the members of the county board and county citizens as well. In that same year the County Board created the position of Administrative Coordinator and after a series of people in that position the board created the position of County Executive which had to be decided by a referendum.

In 2000 a referendum passed to create the elected position of County Executive for Manitowoc County. Our League supported the referendum and Dan Fischer served as the first County Executive followed by Robert Ziegelbauer.

The League of Women Voters of Manitowoc County continues to support initiatives to maintain strong county government responsive to county citizens.
