
YOU CAN TRUST THE ELECTIONS IN THE WISCONSIN SYSTEM PRESENTED BY MEAGAN WOLFE, WISCONSIN ELECTIONS COMMISSION ADMINISTRATOR

During the course of her appearance in **Manitowoc Public Library's Balkansky Community Room** the evening of **March 27 at 6-7:45 PM**, Wisconsin Elections Commission Administrator, **Meagan Wolfe**, will provide an outline of Wisconsin's very thorough and decentralized system of running elections, speaking to how the Wisconsin system is different from systems in other states, and explain why our state's voters should trust it to deliver accurate and fair results. We hope that you'll be able to join us on **March 27** for the information-rich "You Can Trust Wisconsin's Election System," presented by Manitowoc Public Library and the League of Women Voters—Manitowoc County, from **6-7:45 PM**. If you are unable to attend in-person, this presentation will also be livestreamed on both MPL's Facebook page (www.facebook.com/manitowoclibrary and You Tube channel.

Meagan Wolfe is administrator of the Wisconsin Elections Commission, serving as the state's chief election official. Wolfe was appointed by the bi-partisan, six-member Commission in February of 2018 and unanimously confirmed by the Wisconsin State Senate in May of 2019 for a four-year term. Serving as an election security advocate and ambassador for the needs of Wisconsin's clerks and voters are among her highest priorities. A significant part of her job is ensuring that Wisconsin's 1,922 local election officials (the most of any state) have the resources and technology they need to conduct elections. Wolfe previously served as WEC's Deputy Administrator and IT Director, managing the teams that develop and maintain the statewide voter registration system, election security, and all other IT applications of the Commission. She joined state service in 2011, starting as the state's voter outreach coordinator and later as an elections IT project manager leading a major redesign of the MyVote Wisconsin voter information portal (myvote.wi.gov).

VOTING: TUESDAY, APRIL 2ND, 2024

The State League is educating the public about the proposed amendments to the State Constitution that will appear on the April 2nd ballot and urging a NO vote. The two proposals would impose restrictions on election and administration.



Question 1 would ban all private donations from election administration. Funds from non-governmental organizations have been used when government money is not sufficient to effectively conduct an election, such as during the pandemic. **Question 2** would limit those who perform any tasks in conducting an election to election officials. The vague language of this proposal would inhibit clerks from relying on the outside experts, volunteers and community organizations they now use to assist in running an election.

What you can do:

- Arrange for presentations in your church or neighborhood. <u>Use this</u> <u>slideshow presentation</u> or request a presenter from the advocacy team.
- Use the <u>LWV Wisconsin Vote NO toolkit</u>, with graphics and text for social media, letters, or flyers, to get the word out.
- Use our <u>sample letters to the editor</u> to help you write your own letter to the editor.

SCHOOL BASED MENTAL HEALTH FORUM

Our League Mental Health Committee recently held a panel discussion on school based mental health services. We were pleased with the attendance of

about 50 people and the presenters really made a case for the need for these services. Kristin Sterns from Lakeshore Community Health Center, Jennifer Schneider from Two Rivers Public School District and Heather Baugniet, from the Mishicot School District were wonderful presenters. Through a large two year federal grant, Lakeshore Community Health Center is now able to offer mental health counseling in all Manitowoc Schools.

We learned that the United Way of Sheboygan County provides funding for services for families who do not have health insurance or who have large deductibles that they can't afford to pay. As a result, members of our committee met with the Sheboygan United Way coordinator to learn how they are able to do this. We received a wealth of information and are looking forward to sharing this with our committee and seeing what can be done here in Manitowoc County to help.
