#### VOTE NO ON THE APRIL CONSTITUTIONAL AMENDMENT

Shall section 1M of Article III of the constitution be created to require that voters present valid photographic identification verifying their identity in order to vote in any election, subject to exceptions which may be established bylaw?

Wisconsin's strict photo ID law is among the most restrictive in the nation. Research from the Brennan Center for Justice revealed 14.5% of eligible voters lack an unexpired photo ID with their current name and address on it and face difficulties voting. The Center surveyed 23.5 million voters across 42 jurisdictions regarding the 2016 election and determined improper noncitizen votes accounted for 0.0001% of the vote. Wisconsin already has a state law requiring voters to provide a valid photo identification to vote. This law passed in 2011 has been implemented in every Wisconsin election since 2016. The law identifies acceptable photo ID, exceptions, and the use of provisional ballots. These things are clearly identified in the law.

A Yes vote means adding language to the constitution to require valid photo identification to vote and authorizing the state legislature to pass laws to determine what qualifies as valid photo identification and exceptions to the requirement. Voters passed a law in 2011 that already did what this amendment will accomplish. Wisconsin has safe and secure elections with safeguards in place to ensure only eligible voters are voting. Is this amendment solving a problem that doesn't exist?



People in Wisconsin have had to vote on 6 confusing constitutional amendments on the ballot in the last year. Is there that much wrong with our state Constitution? Following are the study conclusion statements about which we are asked to respond:

- 1. Transparency is essential to an effective Federal Judiciary.
- 2. Accountability is essential to an effective Federal Judiciary.
- 3. Independence is essential to an effective Federal Judiciary.
- 4. Ethics is essential to an effective Federal Judiciary.
- 5. There should be binding universal standards of conduct for judges and Justices at all levels of the Federal courts.
- 6. Court hearings, documents filed in the court, and rulings for all federal cases should be open and available to the public.
- 7. There should be an effective enforcement mechanism for the Federal Judiciary code of ethics at all levels.
- 8. An enforcement mechanism should include a process to require a judge or Justice to recuse him or herself when a reasonable litigant would believe that the judge or Justice has a bias against any party or an issue raised in the case.
- 9. A judge or Justice's decision and rationale to recuse or not recuse should be publicly disclosed in writing.
- 10. Federal judges and Justices should be subject to rigorous financial disclosure requirements, enforcement, and penalties for all financial benefits, including but not limited to income, gifts, paid speaking engagements, and book deals.
- 11. Stability of law is a value that contributes to a strong democracy.

12. Public perception of the Supreme Court's legitimacy contributes to a strong democracy.

#### NEWS FROM THE TREASURER: PAYING MEMBERSHIP DUES

The LWV at the National level has changed the format for paying annual membership dues. When it is time for you to pay your dues, we will no longer be accepting checks paid to the LWV of Manitowoc County. You will pay your dues online using a credit card at <a href="http://www.portal.lwv">http://www.portal.lwv</a>. Current dues are suggested at \$75 per year. However, if this is a hardship, dues will be accepted starting at \$20 per year. Your dues payment is automatically divided up between National, State and Manitowoc County. You can also make a donation to the LWV of Manitowoc County at the same time you pay your membership dues. The LWV of Manitowoc County will get your full donation minus a credit card fee.
