# MENTAL HEALTH COURT FORUM

The League of Women Voters of Manitowoc County will sponsor a public forum on the topic of mental health courts at **Manitowoc City Hall on Thursday**, **October 3 at 7 pm.** Co sponsors of the event are RUTH (Responding with Understanding, Truth and Hope) and NAMI (National Alliance on Mental Illness).

The main speaker will be Judge Donald Zuidmulder, of Brown County who presides over his county's mental health court. Judge Zuidmulder is responsible for starting Brown County's Drug Treatment Court in 2009 and has watched the number of treatment courts in his county grow to four under his watch. He will discuss how the mental health court has benefited Brown County by reducing police contacts, jail costs and recidivism among participants. He will also give suggestions for how to start a mental health court.

Mental health courts work with individuals with mental illnesses who are involved with the justice system. The court program provides a diversion from incarceration, treatment, support and monitoring. Currently there are three mental health courts in Wisconsin, located in Brown, Eau Claire and Outagamie Counties.

The October 3<sup>rd</sup> program is free and open to the public. Light refreshments will be served.
