#### **VOTER SERVICES**

I have recently stepped down from chairing Voter Services which has been very near and dear to me. I became chair when I decided to register voters in the area and was certified at a State League convention. From there, I was able to interest local league members to help out, by getting them certified through the Manitowoc City Clerk. It has been a joy to be chair of this committee. I still will be a member of this committee and will be working at the Two Rivers Library to help and assist people to register to vote and to inform the public on the candidates.

Suzanne Zipperer has stepped in to chair this position and I am grateful for her enthusiasm. However, we still have hurdles to overcome. The League has reconnected with Manitowoc County Chamber of Commerce to host panel discussions as it did in the past. Linda Gratz and Suzanne Zipperer met with the Chamber's legislative committee. We tried to have a candidate panel for the Republican primary in Representative Tittl's dstrict. He did not reply to numerous attempts to reach him. The NEW Conservatives hosted a debate and several of us attended. President Nancy Slattery spoke with Tittl and Dave Wage, his opponent. We will work to have Tittl at a panel with Democratic opponent Steve Welch. Both candidates will be given the opportunity to record answers to our questions that we will share via social media. Steve Lankton wrote a letter to the editor in regards to Tittl's lack of participation to be part of a forum. Thank you, Steve for this well written letter.

Suzanne Zipperer is the chair, and this committee needs members to assist at voter registration tables at the Manitowoc library and to help with candidate panels and other activities. Please consider giving your time to this important task of registering voters for this election.

Again, the legislation has proposed another inane amendment to the constitution. If this amendment is approved, voters may be required to show additional documents to establish their citizenship, such as proof of birth in this country.

Many people don't have a birth certificate and those who do, especially women, may now have a different name. Would women be required to show marital documents to establish their right to vote as a citizen?

The proposed change is unnecessary!!! It is another form of **Voter Suppression! VOTE NO** on this Constitutional Amendment.

October 16, 2024: "Private School Vouchers: How They Impact Local Taxes and The Public Schools"

We are all set for a room at the Manitowoc Public Library for October 16<sup>th</sup> for our meeting on "Private School Vouchers: How They Impact Local Taxes And The Public Schools". The program will run from 6:00-7:30 in the Balkansky room of the library.

Our guest speaker is Denise Gaumer Hutchinson from the Wisconsin Public Education Network. The Wisconsin Public Education Network is a non-partisan grassroots coalition to support our public schools. Denise is also a member of the LWV in Brown County. We are also thinking about having the finance person from one of the local school districts present specifics on what is happening because of vouchers for their district. In addition to our speakers, we will also have a 30-minute question and answer period.

The LWV Wisconsin has a position on school funding which we will read before the event. Under Elementary and Secondary Education it states "Charter school authority given only to K-12 public school districts to maintain Wisconsin's commitment to local control of K-12 education. A system of school choice within the public school system, but which does not include any tax dollars being given to private or religious schools." Hope to see you on **October 16<sup>th</sup>**.
