

The League of Women Voters of Santa Cruz County Board Meeting Minutes Wednesday, April 10, 2024

Treasurer's Report: Geri McGillicuddy

The checking account balance is \$10,445.97. The savings account balance is \$2,517.59. The money market account has a \$5,033.34 balance. The total is \$17, 996.90. Future expenses will be the deposit to Seascape Golf Club Grill for the room and brunch scheduled for June 22, 2024 Annual Meeting. The PMP payments are due on June 30th. Pam Peterson is the Budget Committee Chair and was in charge of the annual audit.
