
What is the ERA and Why do we need it?

Voter Service Update

While continuing to conduct voter registration at senior housing, the LWV ABC Voter Services team have been busy planning for future events :

Criminal Justice Position

In 2022, the LWVUS Convention adopted a comprehensive Criminal Justice Position. For the first time, LWV has a position that addresses most aspects of the Criminal Justice System including Policing, Pre-Trial Procedures, Sentencing, Incarceration and Re-entry.

In general, the new position supports a criminal justice system that

- is just, effective, equitable and transparent
- eliminates systemic bias
- promotes safety for law enforcement officers and communities
- promotes collaboration between government and community
- focuses on humane treatment and rehabilitation
- relies on evidence-based research in decision-making

In the past, LWVUS only had a position on sentencing, relying on other positions to support or oppose some other aspects of the criminal justice system. For example, advocacy for access to police records fell under the Citizen's Right to Know position and advocacy against solidarity confinement fell under the Individual Liberties position. For states which had not adopted additional criminal justice positions, the ability to engage in criminal justice advocacy at the local and state level was limited.

The new position allows LWV members to advocate on a much wider scale at the local, state and federal level. Not every possible piece of criminal justice legislation is addressed under the LWV policy so the LWVUS Legislative and Policy team is available is to consult before advocating for or against proposed legislation.
