Clean Water Act Restrictions after Sackett

LWV UMRR webinar November 6, 4 pm Registration Required

Join LWV UMRR to discuss the implications of the May 2023 Supreme Court decision in Sackett vs. EPA. The Sackett decision restricts implementation of the Clean Water Act, removing 'discontinuous' wetlands and ephemeral streams from Clean Water Act jurisdiction. The decision will have far-reaching consequences in states that depended on federal regulations for this protection.

Rob Lee, attorney for Midwest Environmental Advocates, will cover a brief history of the Clean Water Act (CWA), 2015 regulations defining Water of the US (WOTUS), and the 2020 Navigable Water Protection Rule. He will discuss the May 2023 Supreme Court Ruling and the now revised regulations just issued by US EPA and the Corps of Engineers. Following Rob, **Gretchen Sabel**, LWV ABC President and UMRR Communications Chair, will present information on the status of wetland regulation in the UMRR states based on a 2022 analysis by the Environmental Law

Institute, followed by a look at LWV positions that relate to actions supporting strong implementation of the CWA. A discussion period led by LWV UMRR Chair Mary Ellen Miller will round out the webinar.


October Board Highlights


As the study moves forward, the Committee needs your help with research, determining focus and determining what officials to interview.

Mapping Prejudice in Anoka County

Tuesday, November 14 6:30-8:00pm


Coon Rapids Civic Center 11155 Robinson Drive

Anoka County Library and Transformative Circle are hosting a presentation by the Mapping Prejudice project on the history of racial covenants. Following the presentation, there will be a hands on tutorial on how to find racial covenants in Anoka County property records and how to transcribe deeds.

Please bring a personal electronic device that can connect to Wi-Fi to participate in the deed transcription session.

Based at the University of Minnesota, Mapping Prejudice identifies and maps racial covenants, clauses that were inserted into property deeds to keep people who were not White from buying or occupying homes. The resulting maps, initially focused on Hennepin County, have helped to change popular understandings of structural racism in Minnesota.

In this collection, Indigenous writers and writers of color bear witness to one of the most unsettling years in the history of the United States. Essays and poems vividly reflect and comment on the traumas we endured in 2020, beginning with the arrival of the COVID-19 pandemic crisis, deepened by the blatant murder of George Floyd by Minneapolis police officers and the uprisings that immersed Minneapolis into the epicenter of passionate, worldwide demands for justice.

From authors with international reputations to newly emerging voices, *We are Meant to Rise* features people from many cultures and perspectives, including Indigenous Dakota and Anishinaabe, African American, Hmong, Somali, Afghani, Lebanese, Korean, Vietnamese, Japanese, Puerto Rican, Colombian, Mexican, transracial adoptees, mixed race, and LGBTQ+.
