

The Minnesota Nongame Wildlife Program is a conservation initiative run by the Minnesota Department of Natural Resources (DNR). It focuses on protecting and managing the state's nongame wildlife, such as songbirds, eagles, turtles, frogs, and rare mammals.

The program is entirely funded by donations—it receives no money from hunting or fishing license fees. The main source of funding is the "Chickadee Checkoff" on Minnesota state tax forms, where residents can donate to nongame wildlife conservation

# Consensus Meeting Federal Judiciary Study Monday, April 14 Part of Annual Meeting

## What is a Consensus Meeting?

All League action — our advocacy — is based on League positions. League can only advocate for a policy based on a position. Positions are reached through the consensus of members after conducting a study of the issue. League positions are written in broad terms, outlining principles we can apply to specific actions for decades in the future.

Consensus meetings involve discussing the issues explored in the study. The study committee provides consensus questions to facilitate this discussion. For a national study, every local League in the country submits their response to the consensus questions. A position is formulated based on the consensus responses.

# **The Federal Judicial Study**

The Federal Judiciary Study (FJS) Committee was authorized by the delegates to the 2024 LWVUS Convention.

The FJS study consensus questions are focused on:

- transparency
- accountability
- independence
- ethics
- standards of conduct
- recusals
- recusal enforcement procedures
- financial disclosures
- stability of law
- public perception

The FJS committee plans to present a Federal Judiciary Position for approval at the LWVUS National Council in June 2025.

# **Prepare for the Consensus Meeting**

The Study Committee offers some background materials and prepared short policy briefings related to the consensus questions.

LWVUS also sponsored a town hall meeting featuring experts on the federal judiciary. The panelists explained why many experts recommend Supreme Court term limits of 18 years and answered questions such as "What is a shadow docket?"

In addition, LWV Roseville Area has focused their recent program meetings on the judiciary.

"Behind the Gavel" features judges currently serving on the Minnesota
District, the Minnesota Court of Appeals and the Minnesota Supreme
Court. The judges offer insight into judges and court operations. (Note:
LWVRA had technical problems with the video recording, but the audio is
excellent and very informative.)

• "Federal Judiciary 101" features LWV RA member Karen Schafer, a retired government attorney, discussing the constitution and the history of the Supreme Court and other Article III federal courts.

# **Poll Pads in Anoka County**

#### **Anoka County Board of Commissioners Meeting**

On February 25, 2025, LWV ABC members **Paul Sitz, Kathy Aanerud and Wes Volkenant** attended the Anoka County Board of Commissioners Meeting to observe the discussion of the Elections Office request to replace poll pads. Purchase of the poll pads was approved 4 to 2 on roll call vote. Commissioner Braastad was absent.

On the board agenda Action Item form, the Election Office notes several reasons why poll pads are an improvement over paper rosters:

- No need for staff to hand stamp absentee voters on rosters
- Roster updated as absentee ballots received
- Decreased voter check-in times
- Voter Privacy voters cannot see other names when check in
- Easy confirmation of correct polling place
- Significant reduction of time and staff needed to upload results

During the board meeting, Commissioners commented that paper rosters are also expensive due to increased costs for full-time and temporary employees. Documents in the agenda show that about 60% of the poll pad cost will be covered by state voter funding.

The commissioners, with the exception of Commissioner Heinrich who voted against the proposal, were satisfied with the security of poll pods. Commissioner Reinert voted against the proposal because he believes cities should have the autonomy to choose whether they want to use poll pads or paper rosters.

Multiple commissioners thanked the public for their engagement on this issue. Commissioner Schultz commented that he had received more calls in the last two weeks than he had ever received before on any issue.

#### **Public Comment Period**

During the public comment period, which is not taped, five county residents spoke, three in support of poll pads and two against.

The comment period was opened by a member of the active citizen group ACEIT (Anoka County Election Integrity Team) which supports paper poll books, as well

paper ballots, hand counting of paper ballots, local storage of election data, precincts size capped at 2,000 and expanded Post-Election reviews. The ACEIT speaker thanked Commissioners Reinert and Heinrich for their "no" votes and warned the majority that the word would spread of their action. The last speaker also opposed poll pads, expressing concern about the hidden figures controlling our electronics.

LWV ABC member **Wes Volkenant**, acting as a private citizen, was the second speaker. Wes acknowledged the campaign of election disinformation the commissioners and elections staff have experienced over the past four years or so. Wes thanked Elections Manager Tom Hunt and his staff for their professionalism and communication with the public. Wes expressed his opinion that technology makes our elections more efficient and expeditious, noting that results are known by midnight rather than waiting 2 or 3 days as we did with paper. Two Oak Grove election judges thanked the majority for their vote, and expressed their preference for the poll pads.

About 10 members of ACEIT attended the meeting. Throughout the meeting and public comment period, several held large printed signs which characterized electronic poll pads as the Trojan Horse of elections.

# **March Board Highlights**



# **Proposed Redistricting Bill**HF550/SF824 Bipartisan Redistricting Commission

For decades, LWVMN has advocated for a *non-partisan* redistricting commission.

A new bill, HF550/SF824, proposes a *bi-partisan political* commission rather than proposing a *non-partisan* commission. Since 1992, the Minnesota Supreme Court has set new maps because the legislature was unable to reach bipartisan agreement on redistricting maps.

LWVMN objects to the proposed bill because:

- Proposed composition ensures a process of, by, and for the partisan political parties
- Proposed redistricting principles are narrower than those used by the Minnesota Supreme Court and do not reflect preservation of communities of interest as a high priority
- Proposed provisions for public hearings lacks specific requirements regarding the number, location, and manner of the hearings and there is no provision for online public input and participation.
- The proposal does not specify a deadline nor or address what happens if the commission fails to reach an agreement on maps

# **LWV Letter to Congress**

On February 14, 2025 the League of Women Voters sent a letter to Congress urging Congress to assert its constitutional authority under Article I to protect our system of checks and balances, the rights of Americans, and democracy itself. The letter was signed by leadership from every state League and DC affiliate in the country.

The letter expresses League concerns about a recent series of executive orders (EOs) and directed actions by the President which violate the law and encroach upon the constitutional authority of Congress. The letter urges congress to take action regarding the President's actions to:

- · End birthright citizenship for all persons born in the United States;
- Pause the distribution of federal funds already allocated to programs by Congress;
- Dismantle federal agencies such as the US Agency for International Development (USAID) and the Consumer Financial Protection Bureau (CFPB), which require notice to and the input of Congress before such actions can be taken;
- Allow private citizens, who have neither been elected or complied with the advice and consent requirement of the Senate, to access sensitive government systems; and

 Attempt to reduce the federal workforce through unorthodox means that deny them due process.

# **Take Action to Protect Voting Rights**

**Stop The Safeguard American Voter Eligibility Act** 

The U.S. House and Senate have introduced the Safeguard American Voter Eligibility (SAVE) Act. The SAVE Act would require *in person paper* documentation of citizenship to register to vote and every time you update your voting registration (all name and address changes). No state, tribal

or military ID, including REAL IDs, include citizenship information, so verification of citizenship will require a birth certificate, a passport or naturalization certificate.

The SAVE Act shifts the burden of proving citizenship from elections officials to individual citizens - and this burden does not fall equally. Birth certificates, even if in the possession of a citizen, will not be sufficient documentation for the 84% of married women who changed their name or the 86% of transgender people whose birth certificates do not match their current legal gender. Only half of American citizens have a passport. Rural citizens, working class citizens, citizens of color, and older citizens are less likely to hold a passport or a readily accessible birth certificate. Citizens unable to produce paper documentation of citizenship, including victims of natural disasters, will be disenfranchised.

The SAVE Act would invalidate all of Minnesota's hard won voter laws designed to remove barriers to voter registration - online registration, registration by mail and automatic voter registration. Voting drives by organization such as LWV will be obsolete.

If enacted, the SAVE Act will become effective on the day of enactment. A vote on the SAVE Act is expected within the next few weeks.

# **MMIR Update**

The Missing and Murdered Indigenous (MMIR) license plate, first issued in February 2024 (the same month of our MMIR program), has generated over \$90,000 to fund the investigation of unsolved cases, rewards for information, community searches and prevention programs. MMIR plates cost \$15.50 plus an annual contribution of at least \$25 when renewing registration.

Recently, the MMIR office, in its first instance of international cooperation, was able to help reunite a First Nation women from Manitoba with her family and friends. After finding her unconscious, Ottertail County Sherriff Office was unable to identify her using the usual law enforcement resources. When a sheriff contacted the MMIR office, staff was able to utilize their contacts in Canada to identify her and facilitate transportation home.
