Our Next Meeting – November 11 – Judicial Selection: Maintaining the Impartiality of our Courts

The League of Women Voters ABC invites members and the public to attend a forum on Judicial Selection: Maintaining the Impartiality of our Courts on Monday evening, November 11 at Andover City Hall's Senior Center (<http://goo.gl/maps/AqKTt>). Forum presenters will be State Representative Peggy Scott of Andover who is a member of the House of Representatives' Judiciary Finance and Policy Committee and Sarah Walker, President of the Coalition for Impartial Justice, a bipartisan organization that has developed recommendations for impartial judicial selections. Our October 8 meeting—State Election Law Updates

League members and friends had an opportunity to hear directly from Anoka County Elections Manager Cindy Reichert at the October 8 meeting. Reichert summarized election law updates for 2013 that include no-excuse absentee voting that will be available August 2014, expanded mail balloting, lower thresholds for taxpayer funded recounts and a taskforce and pilot project on electronic poll books.

Here in Anoka County, Reichert has had a busy summer and fall as she trains local election officials and judges on new election equipment and software. Reichert even arranged for one of the new ballot counting machines to be available for meeting attendees to test. Voters will still be using paper ballots, but as meeting attendees experienced, the ballot counter gives more complete and easy to read instructions on ballots with errors.

Reichert welcomed meeting attendees to contact her with any questions -- 763-323-5275.

New member Nyadoar Nipnip of Coon Rapids presented information about the fundraising work she's doing on behalf of children in the Gambella region of Ethiopia and in South Sudan (<http://goo.gl/maps/KMsaf>).
