3. Program

LWV ABC Program Report 2015-2016

Submitted by Program Chair, Gretchen Sabel

This was a productive year for LWV ABC! In addition to our voter service work that's described later in this report, we formed an Observer Corps that is monitoring the decision making process in our local governments and lent support to the formation of the new Upper Mississippi River Region Inter League Organization. Our League participated in two national consensus discussions – one on election financing and one on constitutional amendments.

Our member, Susan Anderson, was also very active in the Council of Metropolitan Area Leagues, an ILO here in the Twin Cities that has been addressing local government funding and issues relating to Metropolitan planning. Four members of LWV ABC participated in the Governor's Water Summit, held in St. Paul in March.

The dedication of Sandra Shanley to bird-dogging pollinator-related news was essential to our advocacy on pollinators. Our work here increased awareness and spurred action in our local cities, including pollinator-friendly city proclamations in Champlin, Andover and Anoka. Thanks to Kathie Whelchel, too, for organizing us to have a table for outreach at the Green Expo in Blaine last April. We are doing it again this year, volunteers needed for booth staffing!

And we had a unit in the Andover parade! This we are swapping out our participation in the parade for a table at Andover's Pollinator Party in late July, so you will have another opportunity to wear wings in public.

Here's a more detailed list of what we did at our monthly meetings:

May 2015 - May Pollinator Update and Prep for Summer of Action. This meeting featured fun activities and the opportunity for participants to sign up for parades, booths and other action.

June 2015 - Pollinators - Pesticides and Protection: Finding Balance

Pesticides – a risk to bees but a benefit to crops? We sought to understand the balance! This June panel featured:

- -Activist Lex Horan Pesticide Action Network of North America
- -Regulator Joe Zachman Minnesota Department of Agriculture
- -Researcher and Bee Advocate Gary Reuter University of Minnesota Bee Lab

It was a great opportunity to learn about pesticides and how their use impacts our imperiled pollinators.

This program was presented by LWV ABC as part of our continued action to engage residents in reducing the loss of pollinators through improved habitat, informed use of pesticides, and awareness of educational resources.





July 2015 - Tour of Coon Rapids Recycling Center. Many thanks to Colleen Sinclair for the excellent tour she provided for the League of Women Voters and friends last night! This recycling center is very well run, and we really appreciated Colleen's common sense management style. She explained to us the how and why of recycling materials, and let us know what we can expect in the future in this growing area.

August 2015 - Picnic at Geri and Darby Nelson's and a presentation by Gretchen Sabel on healthy, pollinator-friendly lawns.

September 2015 - We began our new local study on **Government Transparency**, and got


on first steps to make this a reality. All members and persons interested in this topic are invited

December 2015 – Potluck and consensus discussion on amending the US constitution.

The latter discussion was led by JoEllen Ambrose, and was a thorough and exhilarating conversation!

January 2016 - Panel discussion on Campaign Financing in Minnesota. Watch a video! February 2016 - LWV ABC Program Planning (Lively Issues) and Caucus positions

March 2016 – Lonni McCauley talked about the work that the Upper Mississippi River Region ILO will be doing to protect and enhance the Mississippi. This work focuses on nutrient loss reduction, as in discharges from wastewater treatment plants and fertilizer-containing runoff from farm fields. While having nutrients is essential for all life, too much nutrients, and in the wrong places, is a bad thing. Nutrient discharges into the Mississippi have led to development of a vast area of the Gulf of Mexico where the over growth of algae has resulted in oxygen depletion and the death of many sea creatures.

Fundraiser at Banfill Locke – March 31 - Mary Jo Truchon spoke briefly about the history of the Banfill-Locke house, dating back to 1847, that houses the Center for the Arts. She then

expressed appreciation for the current art exhibit of endangered and threatened species, discussed the importance of protecting the environment, and how we can all be involved in protecting monarchs and bees. Mary Jo described her jov of educating young people about nature and her optimism for their role in protecting the earth. She concluded with a brief history of her involvement with League of Women Voters, the importance of helping young people become involved in the political process, and LWV's activities with voter registration and community outreach.

LWV ABC Voter Service Report 2015-2016

Candidate Forums

Arlene Gillette moderated the candidate forum last fall for the Anoka-Hennepin School Board candidates in District 1, 2 and 5 held in the Board Room at the Sandburg Building. Twenty people attended.

We held a forum for the Primary and Special Election for Senate District 35, which followed the resignation of Sen. Brandon Peterson. It was livened up with the Legal Marijuana Now Party candidate. There was a full house at Anoka City Hall.

The Connexus Energy Board of Directors election has had 6% and 8% voter turnout the last two years, so the public needs a better understanding of candidates and the importance of participation. We invited all four candidates, but only the challengers agreed to come. It became more of an informational forum with Duane Ninneman from CURE giving background on rural electric cooperatives and the challengers answered just the three introductory questions on tape. The questions from the live audience of twenty five people were very interesting. The election will be finalized April 15th.

Other Activities

QCTV, LWVMN and LWV ABC cooperated to tape a *Caucus: Power up Your Vote* program that was shared statewide. Susan Sheridan Tucker, LWVMN Executive Director moderated. Our own Kathy Tingelstad represented the Republican Party and Vicki Wright represented the DFL Party.

Jessica Andrist, staff member at Margaret Place (Mary T) in Coon Rapids, asked us to hold a Caucus training session for their staff, residents, and public. We used the Caucus tape and answered questions. 23 people attended.

This spring we had a successful Voter Registration Training workshop with 25 participants including four students, several community members as well as LWV members. Ten people got together to put eight high school registration kits and 20 senior residence kits together. The spring registration drives have commenced!

5. Communications Committee

LWV ABC Communications Report 2015-2016

It was another active year of partnerships, outreach and publicity to create community awareness of LWV ABC programs and advocacy and to promote civic engagement.

QCTV Community Television: Gretchen Sabel, Jeorgette Knoll, and Geri Nelson effectively utilized the relationship that they forged last year with this community partner that serves Andover, Anoka, Champlin and Ramsey.

- Programs were produced at QCTV studios for two important topics:
 - o 11-19-15 Upper Mississippi River Inter-League Organization, hosted by Gretchen Sabel
 - 05-22-15 Safe Passage for Minnesota Children, hosted by Jeorgette Knoll
- Two public service announcement were produced for League of Women Voters Minnesota to promote membership
- A 30-minute program was produced to educate and motivate voters for precinct caucus participation

LWV ABC Website: With thanks to Bruce Pomerantz, LWV ABC launched a website using a nationally-offered template, League Easy Web (LEW). We have entered into an agreement with California LWV for use of the template and future updates. The website will provide us with public visibility and provide our members with a Members Only section for easy access to documents and photos. Information and a demo will be provided at the Annual Meeting.

Pollinator Partnerships: Continued outreach efforts were conducted to increase community awareness of the plight of pollinators and actions that can be taken by everyone to protect environmental conditions. LWV ABC activities included:

- Members staffed information tables at farmers markets
- Pollinator Proclamations were presented and passed at Champlin, Andover and Anoka City Councils
- We took the lead on conducting publicity efforts for the *Andover Pollinator Tour* resulting in feature stories in Star Tribune and Anoka County Union as well as being listed in garden calendars and Andover's city newsletter (itemized below).

LWV ABC Facebook page: Gretchen Sabel and Jeorgette Knoll keep our facebook page thriving with vital topics and up-to-date information on League activities.

2. Adoption of Local Program:

LWV ABC LOCAL POSITIONS

Local positions are the result of studies conducted within LWVABC and are used to advocate within the LWVABC service area. They are not included in LWVUS or LWV Minnesota program.

Appointive Process in Local Government (1978) (reviewed and elected to keep April 18, 2015)

LWV ABC supports publicized and orderly application and appointment process which will maximize participation of qualified individuals and assure efficient operation of advisory boards and committees.

Appointive Process in Anoka Hennepin School District 11 (1979) (reviewed and elected to keep April 18, 2015)

LWV ABC supports publicized and orderly application and orientation process, which will maximize representation and efficient operation of advisory committees.

Metro Watershed Management Organization and the Implementation of the Metro Surface Water Management Act (1992) (reviewed and elected to keep April 18, 2015)

LWV ABC supports the establishment and implementation of comprehensive surface and ground water management for the metropolitan area.

Anoka County Park System (1994) (Revised 2010) (reviewed and elected to keep April 18, 2015)

- LWV ABC supports the establishment of a well publicized citizen's advisory board to ensure that Anoka County government will be aware of and sensitive to county resident's park concerns.
- LWV ABC supports regular meetings of representatives of city and county park staff to
 exchange ideas and common concerns and to ensure that city park boards are aware of
 county park board plans and activities.
- LWV ABC supports a greater base of citizen support for the park system through the employment of a full or part-time coordinator to organize activities of volunteers.

Licensing of Rental Properties (2004) (reviewed and elected to keep April 18, 2015)

LWV ABC believes that municipalities need a licensing policy for rental properties and have an obligation to regularly inspect rental properties in their jurisdiction. Inspections should include examination of both the exterior and interior of the rental dwelling unit and the common areas of the interior used by all tenants. Cities should enforce code compliance to ensure the health and

safety of the property's tenants. City codes/ordinances should include a reasonable time for the correction of code violations. Emergency cases: when a violation constitutes an imminent peril to life, health, safety or property, the city may require immediate compliance and, if necessary, take appropriate action to correct the violation.

Home health Care (2007) (revised 2008) (reviewed and elected to keep April 18, 2015)

LWV ABC supports the provision and delivery of safe, affordable, flexible home health care services for all, including the elderly and disabled.

At the Annual meeting members review and elect to keep, update, or drop local positions.

Members are encouraged to let the board know when they 'take action' based on one of LWV ABC's local positions.

3. Non-Partisan Policy

The nonpartisan policy is reviewed and/or revised at the annual meeting. **LWV ABC Nonpartisan Policy**

Reviewed and Approved April 18, 2015

- 1. The President and Voter Service Chair will refrain from public involvement in political campaigns during their terms of office. Involvement includes such things as having one's name on campaign literature, displaying yard signs and holding coffee parties for a candidate. (Attending a precinct caucus is fine.) Board members who are candidates for political office should resign from the Board or take a leave of absence during their own campaign.
- 2. No League member who is highly visible in a political party, closely associated in some way with a candidate, or identified with an issue under discussion at a candidate forum should be involved in running that event. The object is to prevent, in the eyes of the public, either an actual or apparent conflict of interest.
- 3. Explain to incumbent candidates (and to new League members) that while League may have lobbied the office holder on an issue, that function is kept separate from voter service activities for the general public. The League position on an issue is never stated by the League during a public candidate forum.
- 4. Co-sponsorship can present problems of perceived bias, especially if the other organization is identified with a particular point of view or endorses candidates before the election. If LWV ABC's name is on a project, be certain that League guidelines for non-partisanship and fairness are agreed upon ahead of time and followed. If the group has endorsed issues or candidates before the forum, League should decline to be involved. Explain that we are concerned about even the possible appearance of endorsement.
- 5. Moderating for other forum sponsors: League does want to encourage citizen involvement and to provide experienced moderators for the community, but does not want to jeopardize its reputation by participating in poorly conceived or executed forums. If you are asked to moderate for another group, you must explain our nonpartisan policies to them and find out the following:
- a. Motivation of the sponsoring group
- b. Have all candidates been invited? Are they attending? If not, why not?
- c. What are the issues in this election?
- d. Format and ground rules? Do the candidates know them?
- e. Will timers and ushers for collecting questions be provided? (You may want another League member to sort questions and to help you keep track of speaking rotation if there are several candidates.)
- 6. All voter service projects, including candidate meetings, should include a disclaimer that League neither endorses nor opposes candidates for political office.

At the annual meeting LWV ABC members review and if necessary update the Nonpartisan Policy.

Proposed Change to Non-Partisan Policy:

Geri Nelson proposed the following change in policy because we need to have co-sponsors to get the voter service grant.

 Co-sponsorship is encouraged, but can present problems of perceived bias, especially if the other organization is identified with a particular point of view or endorses candidates before the election. If LWV ABC's name is on a project, be certain that League guidelines for non-partisanship and fairness are agreed upon ahead of time and followed. If the group has endorsed a candidate before the candidate forum, League should decline to be involved. Explain that we are concerned about even the possible appearance of endorsement.
