Although not legal in Minnesota since 1961, these covenants have helped shaped housing patterns in Minnesota.

Bluesky

LWV ABC has Joined Bluesky Our Handle: @lwvabcmn.bsky.social

LWV ABC has joined the social media app Bluesky to increase our outreach. In the last few months, LWVUS, LWVMN, most local media and many state offices are among those who have joined Bluesky, the fastest growing social media program.

Bluesky is incorporated as a Social Benefit Corporation which means the board is legally required to consider customers, employees, communities and the environment, not just stockholders, when making decisions. Unlike most other social media apps, Bluesky has no ads and no overall algorithm controlling what you do and do not see. Your home feed (the posts you see) is *only* the accounts you "follow". You can choose to switch to the "Discover" feed to see a wider variety of posts.

LWV ABC Facebook

Our informal poll at the Annual Meeting indicated that only a few members have a Bluesky account, while many members have a Facebook account. At this time we hope to be able to continue to use Facebook, but encourage members to also join Bluesky. The LWV ABC Facebook account is currently suspended.

Facebook has been an unreliable communication platform for us recently. LWV ABC, like other local Leagues, have had our Facebook account frozen twice, even after complying with identity requirements. The recurrent user boycotts of Facebook, an algorithm that does not necessarily show our posts to friends, reports of Facebook shadowing blocking legitimate users, and uncertain future of Meta (Facebook's

owner) due to the anti-trust investigation, were also strong incentives to seek a social media platform beyond products owned by Meta.

May Board Highlights

This was the first board meeting of the new year, following the April annual meeting and board elections. This "retreat" meeting focuses on getting organized for the new year.

- Many appointments to committees were made, with more in progress.
- Future monthly program meeting locations were discussed: Clarification was shared that Andover Community Center meeting room is available to a group our size despite previous conflicting information. Co-sponsored programs with Anoka County Libraries will be pursued, perhaps quarterly, following success of the May program at Northtown Library.
- A group was formed to prepare orientation methods for new members.
- Programs for summer months were discussed an advocacy topic for June, no program in July, and an August program that perhaps tours a local utility.
- Future monthly board meetings will be held on the fourth Monday of the month via Zoom at 4:00 p.m.

Down the Drain America's Wetlands

Down the Drain is a collaborative project of reporters and editors in 12 states. The project, an 8 part series of articles, tells the story of wetlands all across the Mississippi river Basin. *Down the Drain* also published a state by state list of wetlands to visit.

Wetlands are diverse ecosystems which face increasing threats from draining and flooding, as well as decreasing funding. A U.S. Fish and Wildlife Service report indicates an approximate 50% increase in wetland loss from 2009 to 2019 compared to the previous decade. Minnesota lost 140,000 acres of forested wetlands between 2006 and 2020. A 2023 U.S. Supreme Court decision removed federal protection from a large number of the nation's wetlands.

Duck hunters have been a significant source of funding for protection and restoration of wetlands. In Minnesota, wetlands funding from duck stamps, paid by duck hunters since 1934, has decreased as the number of duck hunters has decreased. In Arkansas, they have experienced a decrease in ducks which they fear will lead to less hunters, resulting in decreased sale of firearms and less revenue to improve wetlands.

Data Centers Pump the brakes?

Data centers are the physical buildings which contain the servers, storage drives, and other network equipment behind everything you do online - emailing, viewing websites, streaming movies, banking, downloading eBooks, shopping, searching for information, etc. All data centers need enormous amounts of electricity and water (for cooling equipment) to operate. Future data centers require considerably more acreage, electricity and water than the ones currently found in Minnesota due to the electricity demands of Artificial Intelligence (AI).

Minnesota has at least <u>60 data centers</u> with a mega data center currently under constructions in Rosemount by Meta. Ten additional mega data centers have been proposed for the near future. Big tech has been lured from arid climates to Minnesota by our water and tax incentives. The proposed data centers, taken

together, could equal or surpass the electricity use of every household in Minnesota. The larger the center, the higher the need for water, water that is then contaminated by forever chemicals and no longer usable for drinking or agriculture.

Minnesota had been offering tech companies data center tax incentives of a 20 year sales tax exemption on most technology equipment and electricity use. **Recent legislation will eliminate the electricity tax incentive on July 1, 2025.** Some Senate Democrats are currently proposing extending the sales tax break another 20 years to sunset in 2062. When sales tax incentives were enacted in 2011, Minnesota was expected to forgo \$5 million a year in taxes. Actual loss of revenue have been much more. Current projections are at least \$100 million a year in lost revenue, with a **loss of \$219 million projected for 2029**.

In March, the Minnesota Public Utilities Commission ordered Xcel to come up with electric rates for data centers that will ensure data center costs fall on the data center developers, not other utility customers. Most of the big tech companies make pledges for zero net carbon goals, but their goals are usually met by purchasing carbon offsets, which do little to improve local environmental conditions.

Minnesota law does requires a water-use permit for industries drawing more than 1 million gallons a year, but some data centers bypass this

law by getting their water directly from a city system. Local government, motivated by increased property tax revenue and construction jobs, are not required to consider how increased water usage impacts the surrounding areas. There are few financial incentives for companies to conserve water or invest in more efficient cooling technologies, as data centers do not pay the full economic cost of their water use.

The position of environmental groups can be summarized by the four point petition that the Minnesota Center for Environmental Advocacy (MCEA) delivered to legislature on May 18:


- No Tax Breaks for Billionaires
- No Environmental Review Exemptions
- Hands Off Our Water

• Adhere to Minnesota Energy Goals

LWVMN's current position on data centers can be summed up as "Pump the brakes and consider the consequences!"

- Once individuals are elected, they are no longer just candidates they are public servants, responsible for representing all their constituents, regardless of party.
- Holding elected officials accountable to the public interest is not a partisan act; it is a vital function of a healthy democracy.




