#### High School Project Update

The LWVVT High School Registration Project got under way in January with opportunities to visit schools in a number of districts. League members registered eligible voters at Montpelier High School, Woodstock High School, Mt Abraham High School in Bristol and more recently, Lake Region High School in Orleans, Vermont.

In addition, another volunteer training was conducted at Kellogg-Hubbard Library on January 24<sup>th</sup>. Interest in this project is high and many of those who were trained have become LWVVT members. The Grant now has up to 15 trained League members who are looking forward to visiting schools and other sites with this project.

Unfortunately, plans to register students a Lamoille Union High School in Hyde Park the beginning of April have been postponed indefinitely. Given that schools and other settings are closed, there are no current planned activities supported by the Grant.

When League members are able to reenter institutions, in addition to high schools, there is ongoing interest from the Capstone sites in both Barre and Morrisville. Vocational programs and higher education settings are other potential sites with particular emphasis on the Community Colleges of Vermont.

Given the current situation, the Grantor has indicated that timelines will be altered to extend this project into the summer instead of filing our final report at the end of June.

#### **Criminal Justice Series Ends**

The 2019/20 Criminal Justice series, presented in partnership with the Kellogg-Hubbard Library, wrapped up with a discussion of what happens after incarceration – the resources available and the potential complications. #### Prison Registration 2020 Update

The Inmate Voter Registration initiative continues to register inmates in correctional facilities around Vermont. This program is in collaboration with the Department of Corrections, Volunteer Services Department.

In December 2019, a team of LWV volunteers set up a voter registration table at the Chittenden Regional Correctional Center in Burlington and registered several inmates.

In February 2020, LWVVT volunteers traveled to St. Johnsbury to register inmates at the Northeast Correctional Complex and Work Camp. The volunteer coordinator arranged for the LWVVT registration table to be set up in the cafeteria when inmates obtain their mail and foodstuffs and another voter registration table in the work facility. The high visibility of the LWV volunteers resulted in 18 inmates registering to vote.

The LWVVT were scheduled to register inmates at the Southern State Correctional Facility in Springfield, VT on March 11, 2020 but were notified by DOC that VT correctional facilities will be closed to visitors and volunteers for several months due to the Covid19 virus. When the correctional facilities reopen the LWVVT will be registering inmates throughout the summer and fall.


