## Nonpartisan, Nonprofit, Tax-exempt, 501(c)(3), etc.

These terms are confusing for most of us. This paper is an attempt to make them clearer for LWV Aurora Area chapter members. We want to partner with other, similar organizations and understanding what these terms mean will help us figure out which those are. *Please note that whether an organization is nonpartisan or not, nonprofit or not, etc. is not a value judgment; its status simply is what it is.* 

**Nonpartisan:** The Illinois and U.S. Leagues are nonpartisan organizations. Our chapter is also nonpartisan and we have a policy about this. Our policy is designed to ensure that we continue as nonpartisan – both in reality as well as in the perception of those outside the League.

Being <u>nonpartisan</u> means being free from any political party designation, bias, or affiliation. In other words, nonpartisan organizations don't support or oppose any political party or any candidate for any office.

It's not always easy to tell whether an organization is nonpartisan. Here's a shot from the website for an Indivisible group. Note that it doesn't say they are partisan – but there is a reference to defeating "the Trump agenda." Clearly this is a partisan organization.



**Nonprofit:** The Illinois and U.S. Leagues are also nonprofit organizations. This is a designation under **state** law for entities that apply and qualify for this status. They then generally are required to put all monies that are in excess of their expenses back into the organization; they cannot pay dividends as for-profit companies generally do. (A common misconception about nonprofit <u>business</u> organizations is that they cannot

make a profit; they can make a profit, but they can't pay any part of that profit to owners as dividends.)

**Tax-exempt:** This is a **Federal** designation for those **nonprofit** organizations that have applied for and meet the strict requirements of the applicable section of the Internal Revenue Code under which they qualify, and whose conditions they must satisfy. *Having tax-exempt status means that they do not pay any Federal income tax.* 

Section **501(c)(3)** – "c3" for short – is perhaps the most well-known of these sections of the Code. Having c3 status is the highest level of tax-exemption, as it permits donors to these organizations to claim a deduction on their personal income tax returns.

The three types of organizations that qualify for c3 status are public charities (this is the most common type, and includes churches and nonprofit hospitals), private foundations, and private operating foundations.

The American Association of University Women (AAUW) is a public charity c3 organization, per its website.

AAUW is a top-rated 501(c)(3) charity. Donations are tax deductible. Tax ID#: 52-6037388



In return for not paying any Federal taxes, c3 organizations are required to keep their lobbying and legislative activities at an "insubstantial" level. They may educate but are

**strictly forbidden** from intervening in political campaigns or endorsing/opposing any candidates for public office. They also cannot make any payments to individuals, or for their benefit, which could be characterized as anything other than fair payment for services rendered or goods provided.

The <u>education fund</u> of the Illinois League is a c3 organization; donations to it are tax deductible. There are Leagues chapters around the country that are c3 organizations, although none are in Illinois to my knowledge.

Most League chapters are tax-exempt under Section **501(c)(4)**, generally called social welfare organizations. These entities may engage in political lobbying and campaign activities. The LWVUS, LWVIL, and the National Rifle Association (per its website) are all c4 organizations.

The Indivisible organization is a c4 per its website, as well as being partisan:

The **Indivisible** Project (or **Indivisible**) is a left-of-center 501(c)(4) tax-exempt organization headquartered in Washington, D.C., and created in late 2016 as a response to the election of President Donald Trump.
