### From the President JoAnne Dimond

This month we have an important election on Tuesday, November 5. There are two items on the ballot this year: Referendum 88, Regarding Initiative 1000 – having to do with Affirmative Action and Initiative 976 – having to do with \$30 car tabs. Information about all aspects of the election can be found on the Washington State Secretary of State's website: https://www.sos.wa.gov/ There are several Advisory Votes on various issues, and information about these can be found on the Washington State LWV website:

https://lwvwa.org/ballot-measures. A proposed Constitutional Amendment, Senate Joint Resolution 8200, which would add "catastrophic incidents" to the specified emergencies that the legislature may take certain immediate actions to ensure continuity of state and local governmental operations, is also on the ballot. (A large majority in the House and Senate supported this measure.)

This year it is possible to register to vote right up to Election Day by going to the auditor's office. An advantage to voting early: you can check to see if your ballot was received by going to <u>https://voter.votewa.gov</u>

Information about various candidates can be found in the Voters' Pamphlet, which has been mailed to your home and is also online on the Washington State Secretary of State's website. Another source of information is the Vote411 website: <u>https://www.vote411.org/</u>.

In addition to this month's election, plans are forming to celebrate the Voting Rights Centennial Celebration in 2020, which is also the centennial of the founding of the League of Women Voters. Christine Grantham has offered to chair our *(Continued on next page)*

## The Last 100 Years: Women and History Marilyn Perkins

When I was growing up, I was probably more interested in politics than the average child. For instance, I was very aware that my parents and my grandmother did not support the same candidate in the 1956 presidential election. I watched the conventions, back when you didn't know for sure who was going to win the nomination and always assumed I would vote when I was old enough.

My mother was born about three weeks after the 19<sup>th</sup> amendment was ratified. Though she never talked about voting that much, I knew she did and even worked at the polls. Women have been able to vote my whole life, but when I was born, women had only had the right to vote nationally less than 28 years.

In Washington State, women obtained the right to vote on Nov. 8, 1910. We were the fifth state to grant women the right to vote, and the first one in the 20<sup>th</sup> century. Wyoming, Utah, Colorado and Idaho had already enacted women's suffrage. Our League celebrated Washington's 100<sup>th</sup> anniversary of women's suffrage nine years ago by marching at the Richland Community House. We made some of the staff a little nervous; they thought we might get wild and crazy.

We can't forget Veterans Day on November 11. Originally known as Armistice Day, it became a federal holiday in 1938. After WW II and the Korean War, it was renamed Veterans Day. In 1971, it became one of the federal "Monday" holidays until President Ford, a Navy veteran, helped return it to Nov. 11 in 1975.

November 11, 2019 will also be the 130<sup>th</sup> anniversary of Washington becoming a state.
