### Ukiah City Council

Five of the six candidates for two seats on the Ukiah City Council participated in a forum presented by the Mendocino Women's Political Coalition and the American Association of University Women at the Ukiah Civic Center on September 24. # Supervisors May Work Better

# An ad hoc committee will study how

The Mendocino County League has submitted a letter of support for a proposal by outgoing First District Supervisor Glen McGourty to revamp the way County staff provides information to the Board. His suggestions include developing specific working plans to implement the official Strategic Plan; regularly tracking and reporting progress towards meeting the Strategic Plan's goals; regular followup on the Supervisors' directives and initiatives; staff time devoted to research and background information for them; and staff time devoted to assisting the Supervisors' constituents.

The letter, signed by chapter President Charlene McAllister, states, "Supervisor McGourty's proposal for a focused conversation about how to take our BOS to the next level of effectiveness identifies five areas where he feels there is an important need/opportunity for improvement. These topics are all clearly important aspects of good government and/or good management within the Board/CEO framework. The League of Women Voters of Mendocino County applauds and supports the project of defining these needs and looking for the best and most available ways of meeting them."

After 45 minutes of discussion, the Supervisors unanimously voted to establish an ad hoc committee of outgoing members Gjerde and McGourty to study possible ways to implement the proposal, and to report back at the December 17 meeting. The proposal itself can be found on the agenda for the October 22 meeting of the Board of Supervisors, item 4g.

# Jackson State Forest Planning

# Management Plan Update Meetings Scheduled

The California Department of Forestry and Fire Protection (CalFire) has invited the public to a series of discussions on a new 10-year Forest Management Plan for Jackson Demonstration State Forest. Its press release states, "Forests provide immense and diverse values to the citizens of California. They supply many benefits that we use and enjoy, including clean water, carbon sequestration and storage, fish and wildlife, forest products, and diverse recreational opportunities. The Forest Management Plan guides our activities to sustain and improve upon these benefits. The plan will address opportunities for Tribal co-management, restoration ecology and economy, research and demonstration, sustainable forestry, recreation, and protection and restoration of wildlife habitat."

A series of meetings, already underway, "are intended to gain public insight prior to the first draft of the updated Forest Management Plan." A final draft is scheduled to be completed by early summer, 2025. The next meetings, on the topic of Restoration Ecology, will be held on Monday, November 18, 6-8 pm in Ukiah at the Saturday Afternoon Clubhouse, and on Thursday, Nov. 21, 5-7 pm at Town Hall in Fort Bragg. Restoration Economy is the topic for the December meetings, on Thursday the 12th from 6-8 pm at the Senior Center in Ukiah, and on Friday the 13th, from 5-7 pm at the Fort Bragg Veterans Hall. Pre-register for any or all meetings.

The Mendocino Trail Stewards have also encouraged public participation in these meetings, stating that "CalFire is making plans to log more second-growth redwood trees, the carbon storing champions of Jackson State Forest ... without a new forest management plan in place .... For the past few years, we have advocated for an update to the outdated 2016 Forest Management Plan to account for a rapidly changing climate. Now is your chance to give input on a plan that will guide the management of JDSF for the next decade."

# Mendocino Coast Hospital

# Public concerns include services and stability

As statements during the candidates' forum on October 2 made clear, Adventist Health has begun negotiations with the Mendocino Coast Healthcare District to restructure the contract by which it operates the coastal hospital (now known by the acronym AHMC). A clause in the contract, allowing such proceedings when a 5% profit is not earned from hospital operations, made it possible for the early renegotiation to begin.

At the MCHCD board meeting held the evening of October 24, Board Chair Paul Garza tried to allay public concerns by stating that, although the negotiations are underway, "The hospital will not close, and Adventist Health will not go away." At a GRI workshop on local elections held October 27, Mr. Garza added that Adventist Health had prompted the talks because they thought the District might gain income under a different arrangement, not because of their concern over lack of profit. He said that the two sides were very close to an agreement, and that he expected it would be reached by the end of November. He stated that new income for the oncology unit was likely, and reiterated his belief that the hospital has hopeful prospects for the future.

Public concern was reflected in a September 5 article by Malcolm Macdonald in the Anderson Valley Advertiser entitled "Oncology at the Coast Hospital," in which he discussed rumors that the coastal oncology clinic was to be closed, and reported coastal administrator Judy Leach's statements at an August board meeting that no decision to close the oncology unit had been made, but that "we are however continually evaluating the future viability of all healthcare services including oncology."

Several local residents, including doctors, made comments at the October 24 meeting criticizing difficulties in scheduling appointments at AHMC.

Both the Mendocino Voice and the Advocate-News published articles about the negotiations; MCHCD and Adventist Health also recently issued a joint press release.

Note: The November 5 election will determine directors for two seats on the Healthcare District Board.

# LCP Update this month will feature Drought Resilience

Peter McNamee has announced topics to be addressed at the next Grassroots Institute Mendocino Vision Working Group LCP Update workshop on November 21. The "Mendocino County Water Agency has agreed to make a presentation on their work to address drought resilience and how that impacts long term coastal zone planning. The workgroup is also working with Supervisor Williams on a proposal to encourage the county to seek grant funding to assess the impact of climate migration on the county and how that can be built into coastal land use planning and management. [We are] also working on a draft set of metrics for measuring the success of the LCP update process in preparation for the LCP update public hearings in 2026." The meeting will be held from 3-5 pm on Zoom.

# **Two Traffic Studies Underway**

The Mendocino Council of Governments (MCOG) is engaged in two studies of possible interest to Voter readers. On October 21 it sponsored a public engagement workshop on a Noyo Harbor Multimodal Circulation Plan. The focus of the project is "transportation, mobility, and access in Noyo Harbor that improves economic activity, daily business operations, and organizes tourist activity." Signage by the consultant group Fehr & Peers suggested that the study will cover the desirability of making N. Harbor Dr. one-way through the harbor and under the bridge to come out on the west side of Highway 1; the benefits of adding a roundabout at the intersection of Highway 1 and N. Harbor Dr.; the improvement of pedestrian and bicycle access in the harbor; and the provision of improved bus service. More information, including maps and a survey link, is available on the Noyo Ocean Collective website.

MCOG is also updating the Mendocino County Regional Transportation Plan and Active Transportation Plan (RTP/ATP) and would like to hear from members of the community about transportation needs, deficiencies, and mobility barriers/ challenges. "The RTP/ATP is a long-range planning document covering a 20-year time span, which includes short- and long-range transportation projects across all modes of transportation, including motorized, non-motorized, and public transit. It promotes a safe and efficient transportation system, and establishes regional goals that support mobility, economic, and health aims of the region. The 2026 Plan is due to be adopted by February, 2026.

# A 100-year perspective

It's worth looking back – a week before the 2024 election – to reflect on what the newly formed League of Women Voters was engaged in.

### Voter education

Local leagues were working on Voter Guides. Teams were creating templates for developing questions for candidate forums but were seriously concerned about the fact that some candidates were refusing to attend the forums. There was a good deal of stress around the fact that questions needed to be nonpartisan in content, concise, and non-judgmental.

#### Get Out the Vote

The turnout in the 1922 election, especially among women and young people, had been dismal. Leagues across the country were focusing on women voters, particularly in urban areas where large numbers of working women needed to be engaged. League research had shown that young people were uncertain about the mechanics of voting and whether they could make a difference.

#### Barriers to voting

Leagues were tabling to engage citizens and help them navigate the voter registration process. Literacy tests, poll taxes, party pressure to register with the 'right' party were all challenges that members were prepared to assist hopeful voters in dealing with.

### Navigating polling places

Vast numbers of polling places were in saloons and bars. In 1924, a lot of women were concerned about just walking into a totally male, probably hostile, environment to stand in line and vote. A concerted move to find alternative polling places was underway.

#### Nonpartisanship

Just major angst at all levels about how the League needed to be 'nonpartisan' and what kinds of language and behavior were - or were not - nonpartisan.

Move forward to 2024 and we can see that the challenges haven't gone away. The specifics may have changed but the underlying problems remain. Through it all a hundred years of facing those challenges - we have endured and succeeded. We're resilient and we're still here.
