

### **Voter Services Report – November/December 2018**

On National Voters Registration Day, September 27<sup>th</sup>, LWV-HF registrars visited four high schools in Thornton School District 205 and HF District 233, as well as the Sunrise Senior Living Center in Flossmoor, netting 34 registrants. Another 15 voters were subsequently registered at Waterford Senior Living Center in Hazel Crest.

On Saturday, October 13<sup>th</sup>, the LWV-HF met up with fellow Chicago area Leaguers and participated in the historic Women's March to the Polls. Tens of thousands joined in the March to encourage voter turnout and participation in democracy. LWVIL was a sponsoring partner of the March and staffed a booth to provide ballot and voter information for the Nov. 6 General Election. The League promoted its nonpartisan Voter Guide which can be accessed at www.IllinoisVoterGuide.org. The Guide is an awesome resource that empowers voters with access to candidate information up-and-down the ballot in every precinct. Voters can review their ballot, learn about candidates, and print out their choices so they are prepared when they cast their votes.

Volunteers are needed for the Voter Services Committee. This upcoming year (2019) means new challenges for all of us. The CONSOLIDATED ELECTION will take place on Tuesday, April 2, 2019. There are sure to be requests for candidate forums which require staffing by our local league members. Think about being a part of this exciting and rewarding committee. #### 10 Year Deadline to Hold Global Warming Down to Moderate Levels

Many prominent news organizations simultaneously ran this story on Oct 7, 2018. The U.N. Intergovernmental Panel on Climate Change (IPCC) wrote a report requested as part of the Paris climate agreement, that we will need to take "unprecedented" actions to cut carbon emissions over the next decade. According to the report we must hold the global temperature to 1.5 degrees Celsius, which is still possible, but only if emissions stopped today, so that the planet would not reach that temperature. This will require sweeping change globally to energy, transportation and other systems. It calls for a total or near-total phaseout of the burning of coal. In short "net zero (carbon emissions) must be the new mantra." We must grow more trees that will store carbon over the planet. Such large transitions pose profound challenges for sustainable management of the various demands on the land for human settlements, food, livestock feed, fibre, biogenergy, carbon storage, biodiversity and other ecosystem services," the report states.

The IPCC report represents the work of 100 scientists and went through an elaborate peer-review process involving tens of thousands of comments. The final summary for policymakers (leaders and politicians) was recently agreed to in a marathon session by scientists and government officials in Incheon, South Korea.

For many years predictions for a warming planet and solutions to slow it down have been reported, and too often denied. The "inconvenient truth" nonetheless prevails, and last week's report from the IPCC is the culmination of the current view of scientists given to all of us to meet this deadline together in the very near future.

\*\*\*\*LWVHF Area will host a meeting in April bringing speakers from energy companies to talk about how we as consumers, household by household, can request and pay for wind and solar energy to the ComEd grid. The more people that incorporate this source in their choice of energy, coordinated through ComEd (the delivery system), the less ComEd will rely on coal burning plants as a source. This is the kind of difference that can meet the 10-year goal.
