This is an opportunity for members to learn about important regional services and keep the rest of the League up-to-date on actions that impact our daily lives.

Some of the areas that the League has traditionally monitored include the County of San Diego – (Land Use, Behavioral Health, Health and related issues, the Justice system, the Board of Supervisors), SANDAG (Transportation), and the San Diego County Water Authority. In our modern world, it is now possible to read agendas and meeting packets online and, in some cases, view meetings online.

Please let Cathy Greene know if there is an issue that interests you, where you have expertise, or follow closely (or would like to follow). We want to build a knowledgeable team to inform us when county issues arise, so we can take appropriate action. Commitment levels and involvement can vary, depending on you.

On another topic, many thanks go to the Womens' Interests Committee, who, partnering with Soroptomists International of Vista and North County Inland, AAUW Del Mar- Leucadia Branch, and North County Lifeline, put on a well-attended, educational forum on Human Trafficking. In the first part of the forum, the movie "Chosen" was both touching and horrifying. District Attorney Summer Stephan gave an excellent overview of current laws and practices related to human trafficking. Trafficking survivor Jaimee was stunningly honest about her history, and how she regained control of her life through a lot of work and help. There is much work to be done in this area. Join the Soroptomists International of Vista and North County Inland on Saturday, January 20th, 2018 from 1 – 3 PM in Vista on the 12th Annual Human Trafficking Awareness Day and take a One Mile Walk to raise public awareness. It is a small thing that will help raise public awareness of this truly dreadful crime.

Issues on Homelessness, part 3: What Can Be Done?

This month we address the difficult question of "WHAT can be done?"

Most communities have a collection of homeless programs that provide services and housing to some people who are experiencing homelessness and some people who are struggling with unstable or unaffordable housing. In North County there are a broad range of housing services stretching from Escondido to Carlsbad. The nonprofit Alliance for Regional Solutions brings together all nine North County municipalities, the County of San Diego, law enforcement agencies, private foundations and more than 30 nonprofit health and human service organizations. The Alliance oversees a network of six homeless shelters that include about 220 beds with approximately 100 of those only available during the winter months.

There has been a significant rise in interest on the part of elected officials across the County in seeking out a real solution to the homelessness situation. The County Board of Supervisors, as well as Council members from the City of San Diego are stepping up efforts to offer short term and long term solutions to housing the homeless. Along with the San Diego Housing Commission which administers the federal funds intended to help the homeless there is a broad-based group called the Regional Task Force on the Homeless (RTFH).

This past year, the Regional Task Force on the Homeless was merged with the San Diego Regional Continuum of Care, creating a combined organization charged with engaging stakeholders to drive solutions for ending homelessness. County Supervisor Ron Roberts was elected as chair and San Diego City Council member Chris Ward was elected vice-chair.

A Homeless Crisis Response System is different from what most communities have in place today. A Homeless Crisis Response System responds to the needs of all people who are without housing in a given community. San Diego County has over 900 individual service providers who are well intentioned and are passionate about their mission. However, there is no articulated, coordinated system for delivering services on a regional level.

The RTFH hired a private company with expertise in helping cities and regions develop a Community Plan to systemically address the needs of all homeless persons across the County. That Plan is in the second year of development and holds great promise for articulating a Homeless Crisis Response System. While the Task Force's "Community Plan" is still in the draft stages it

will be important for the League to monitor the progress of this Regional effort.

San Diego City has already adopted a multi-year plan based on the concept of "Housing First". Housing First offers permanent, affordable housing as quickly as possible for individuals and families experiencing homelessness, and then provides customized wraparound supportive services to meet their needs. When those experiencing homelessness don't have to face the fear of getting kicked out of a program or pressure of an arbitrary deadline to meet a provider's expectations, they are, according to the National Alliance to End Homelessness, more likely to discontinue substance abuse, participate in job training, attend school and spend fewer days hospitalized than those not participating in Housing First programs.

In November and December the LWVSD and the LWVNCSD will begin to consider this topic and begin steps for consensus on the issue of Homelessness in San Diego County.

The North County League will hold an Informational Meeting on December 2, 10 am to noon, at the Carlsbad Senior Center. Please mark your calendars for this important event. It will feature presentations from the League's Regional Committee on Homelessness, and opportunities for questions and discussion by League members.

FINAL CAVEAT TO LEAGUE MEMBERS!

Talk is cheap. Solutions are hard. The questions of where funding will come from, and who will get it when it comes, and what will be done to hold agencies accountable for systemic change are not answered yet. It is still in the "promises" column and not in the reality column. This is precisely where the League's influence is most essential. Each step of this process should be measured for its progress toward stated policy goals. If the League articulates a policy, its members will be able to support or critique various aspects of planning and decision-making by public and private partners who are supposedly working to implement this seamless system of solutions. Unlike many "stakeholders" in this game, the League has nothing to gain in revenue or reward from any source involved in creating or implementing solutions. What the League does have is the endurance, the focus and the shared expertise of its members to examine progress over the long term, evaluate potential and actual effects of proposed or implemented plans, and comment on how these matters affect the public interest.

December Observer Reports Luncheons

What is an observer? Observers are league members who attend public meetings of elected and appointed agencies. As the league's "eyes and ears" observers sit quietly and remain neutral as they record what the agency is doing and whether the meetings are conducted in an open and transparent manner. Observers alert the board whenever there is a concern with the function of the committee or if the committee is moving forward with a controversial issue. No other organization has the equivalent of the League's Observer Corps. Observers do not attend meetings to advocate for or against a particular policy; they are there simply in support of good government. Observers are an extension of the league's role as a champion of transparency; a core principal of the LWV and a vital part of its mission since 1920.

Twice a year, observers share their reports with their fellow members at the Observer Reports luncheons. One of our most popular League meetings, the luncheons are an excellent opportunity to learn about your community, meet new members and connect with old friends in an informal setting.

Oceanside Unit observers include Kathy Christy (Oceanside Public Library Board), and three new observers---Mary Ellen Reese (Oceanside Planning Commission and the Oceanside Economic Development Committee) and Diane Stone and Marlene Suliteanu (who co-observe the Oceanside Arts Commission).

San Dieguito unit observers are Nancy Dietrich (The 22nd Agricultural Association); Alec Jolly (North County Transit District Board); Joyce Joseph (San Dieguito Union High School Board) and Barbara Mendell and Nancy Hand (who share the

MiraCosta College Board of Trustees). Nancy Hand also reports on the Carmel Valley Community Planning Board.

All members are invited to hear the observers' reports and learn what's happening in your community.

HUMAN TRAFFICKING FORUM A SUCCESS!

Prior to the formation of the Women's Interest Group (WIG), Jackie Stone and I interviewed Randa Krakow who is on the San Diego County's Task Force against Human Trafficking. We knew this was a critical county issue and would best be addressed in a community forum. Our newly formed WIG members Unfortunately, the only time Jackie could reserve the Dove Library's Schulman Auditorium was from 9:30 am to 12 pm on a Saturday. Our next dilemma was how are we going to get people to come to a forum early on a Saturday morning? One of the reasons the event attracted close to 150 people is that we invited other organizations to co-sponsor the event: AAUW Del-Mar Leucadia, Soroptimist International of Vista and North County Inland, North County Lifeline and Sisters of the Streets. The other reason was our enthusiastic and thorough publicity efforts. Flyers were distributed to libraries, churches, synagogues, high school and college campuses, as well as other groups familiar to WIG members. Local and County newspapers publicized the event and Lola Sherman, Reporter for the Union Tribune, devoted a full column to the issue and event.

After a warm welcome, the audience viewed the video "Chosen" which emphasized how U.S. teenagers can easily fall into the trap of pimps, or "facilitators" as they like to be called.

Soroptimist member, Kaye Van Nevel was our Moderator. She has been fighting against human trafficking since 2005 and was able to get two wonderful and engaging speakers — Summer Stephan, San Diego County District Attorney and Jaimee Johnson, a human trafficking survivor. Summer mesmerized the audience with her description of what her department has done and the ongoing problems we face. She talked about crucial legislation and partnerships with San Diego County middle and high schools in implementing her model curriculum to increase awareness and prevention of sex trafficking.

Jaimee shared her thoughts about suffering and being trapped in this lifestyle. Kaye, Summer and Jaimee then participated in a Question & Answer session drawing many questions and comments from the audience. It was exciting to see that our audience truly represented the community – all ages and ethnicities. It is so important for the League to increase public awareness about our organization. I think the Forum accomplished that mission.

As an ongoing Action Item, Nancy McMahon, Judy Thum and Norelynn Pion-Goureau are contacting high school counselors to promote the video "Indoctrinated" to be shown to counselors, parents and students. The video also comes with a Study Guide.


