Criminal Justice Civics Workshop Nov. 2

The League of Women Voters of Central Delaware County will present the next in its regular series of public civics education workshops Saturday, Nov. 2. This event will offer attendees the opportunity to learn more about the criminal justice system in Delaware County with particular focus on current issues pertaining to sentencing, parole and probation. They will hear informed perspectives from a panel of experts and be able to participate in the discussion.

The program will be moderated by Wana Saadzoi, a criminal defense lawyer and member of the Delaware County Bar Association. Panelists include: Lee Awbrey, public defender case management chief, Appellate Unit, Montgomery County; Andrew Christy, criminal justice and poverty

attorney, ACLU Pennsylvania; Dr. Keith Reeves, professor of political science, Swarthmore College, and Tamika Hayward, field parole agent, Pennsylvania Board of Probation and Parole.

The workshop will take place from 9:30 a.m. to 12:30 p.m. in the Matchbox Building of Swarthmore College, 500-504 Fieldhouse Lane Ave, Swarthmore. It is free and open to the public. Pre-registration is encouraged but not required at www.lwvcdc.org/calendar.

Vote Nov. 5 — And Vote No on Marsy's Law Amendment

The Pennsylvania League of Women Voters has sued the secretary of state to invalidate the vote on the ballot question to amend the state Constitution to give victims of crime equal rights to criminal suspects.

It is not that the League opposes the idea, but the amendment — two and a half pages long — is so long voters cannot even read the full amendment on the ballot. It is a mishmash of provisions that would alter eight other parts of the Constitution, would clash with crime suspects' rights and does not allow voters to chose the provisions they would support or oppose. The Legislature needs to try again with a better-crafted amendment.



President's Message

The 2019 Midterm elections were most interesting this year. Notably, there were two very important local races for the offices of Delaware County Council and Judge of Common Pleas. In response, LWV-CDC conducted two candidate forums which provided accurate and meaningful information to voters to assist them in making informed choices. In case you missed them, both are recorded and are available for viewing on LWVCDC.org.

The County Council Forum was most unusual in that both parties presented as a three-person slate of candidates with a primary spokesperson for each side answering the questions. Tiffany T. Griffin, a leading criminal attorney in Media served as our moderator for County Council and Jamie Mogilat, LWVPA VP of Government and Social Policy, moderated for the Judge of Common Pleas forum. Both moderators assured that a high level of non-partisan, civil discourse was maintained throughout both forums.

Over the past two years, LWV-CDC has been actively engaged in advocating for a Countywide Public Health Department. In June 2018, John Hopkins University's Bloomberg School of Public Health was hired by the County to conduct a study of the public health needs and services and provide the County with recommendations on how to enhance and strengthen these services. As part of the study, five focus groups and in-depth interviews now being scheduled to convene in November and January 2020 to discuss Delaware County's public health programs, policies, and services.

Three of the focus groups are for the general public, one will be targeted to health care professionals and one will be targeted to municipal leaders. Rosemarie Halt, RPh, MPH has been selected for an in-depth interview and other members of the LWV-CDC Public Health Committee will be participating in the health care and general public focus groups to convey results of our field research, interviews with public health officials and the benefits of forming a Public Health Department in Delaware County. We will also be responding to an on-line survey that is part of the John Hopkins study. Stay tuned for more information on our advocacy in the coming months.

Delaware County Council has voted to purchase Hart Intercivic 2.3.4 voting machines and these new machines will be used in the April 2020 Primary. County Council has asked LWV-CDC to help with community training. In December, two League members will receive training from the manufacturer of the Hart Intercivic as part of a "train the trainers" program. In January 2020, these trainers will begin training other League members who will train community groups to use the new Hart machines for the April Primary.
