November Program - The K-12 Teacher Shortage Panel Discussion

Even before the pandemic, the nation was seeing a teacher shortage. For generations, we took for granted that there would be a group of new, mostly female, mostly young college graduates waiting to teach the nation's children. Now, every year our local districts open with positions unfilled. Even more so, they can stay unfilled, with districts using long-term substitutes or teachers from other communities. This affects learning, community support, and morale. How much is about standardized testing or pay? The questions pursued in this program will focus on the local problem, short-term solutions, and long-term plans.

Guests include **Dr. Danny Merck** of Pickens County, **Dr. Lee D'Andrea** of Clemson University, and two teachers still confirming permission to attend. There will also be a representative from Clemson's "Call Me Mister" program who will be present.

We recognize that this is a systemic problem arising after decades of teacher neglect, of taking teachers for granted, and of placing low taxes above all else in our state. At some point, we need to confront how this decades-long attack on public K-12 education contributed to the shortages that we can't just blame on the pandemic. Bring your questions and ideas, and we'll cover the issue from the supply of future teachers to the reasons teachers leave the profession. Perhaps few issues are more important than ensuring our kids have well-qualified, well-treated, and respected teachers in our classrooms.

October Update from LWVOP Reproductive Rights Group

In October the SC Senate voted nonconcurrence with H.5399, the abortion ban passed by the House, and appointed 3 for a conference committee. Most opinions are that there will be no further action by the Legislature during this session. We will need to be prepared for a new bill in the next session. What happens will depend, in part, on the anticipated SC Supreme Court ruling in the suit filed to declare the Fetal Heartbeat Act unconstitutional. In a recent article in the *Seneca Journal* several our local legislators (**Alexander**, **Rice**, **Sandifer**, **Whitmire** and **Carter**) were asked about abortion bans. They seemed to uniformly support the Fetal Heartbeat Ban or something even more restrictive.

The LWVOP Reproductive Rights Group met to review efforts to educate and advocate for reproductive rights. Although we can't be sure about the effects of the activities, no more restrictive abortion ban was passed, and the Fetal Heartbeat Act is blocked so abortion is currently legal and available in South Carolina through 20 weeks of pregnancy. Meanwhile, alternate plans for access to abortion in North Carolina are being put into place. We will continue to reach out to other local organizations and individuals and be ready to respond quickly to action by the legislature next year.

Report on October Pickens County School Board Meeting

I attended the Pickens County School Board meeting on October 24, 2022. The meeting began with a Committee of the Whole, at which **Seth Young**, Assistant Education Supervisor for Human Resources, gave a report on the policy used to review of instructional resources, referred to as IGR, which is being revised, following the School Board's banning of two books, *Stamped* by **Jason Reynolds** and **Ibram X. Kendi**, and *The Perks of Being a Wallflower* by **Stephen Chbosky**. Mr. Young began by saying that Pickens County was one of only a few counties in the state that already had policy in place in the case a parent or guardian made a formal complaint about a specific instructional resource being used in the classroom. In the policy, the parent/guardian could request that their child be provided other resource material, or the parent/guardian could fill out a form requesting a formal review of the instructional resource. Mr. Young said the standing policy was followed in the case of the two banned books. A request was made to review two books, a District Level Committee reviewed the two books, and a recommendation was made to the Board, which voted to remove them for five years. At this meeting, Mr. Young suggested a list of topics for Board to continue discussing to refine the present policy:

- 1) whether or not there should be a district-wide list of approved educational resources and who should be the ones to approve such a list.
- 2) how School and District Level Committees to review these materials are appointed, who should serve on them, parents, community members, employees? Define employees (administrators, teachers, instructional coaches, etc.? Which community members?
- 3) whether or not review committee members should be compensated, as it takes a good bit of time and there is pressure on the committee members to meet a deadline. Mr. Young felt it was becoming difficult to get parents to agree to be on these committees.
- 4) based on discussion at the previous month's meeting, the wording had been changed as to who may request the initial review from "stakeholder" to "parent or guardian."
- 5) what would be an appropriate timeline for the review process so classes may continue if a material under review is listed on the syllabus. It had previously been determined that that a book would not be removed immediately, or this process could be used to disrupt a class, frivolously or
- 6) maliciously.
- 7) whether or not there should be a unanimous decision by the review committee or some type of a majority vote before the report is submitted to the Board.
- 8) how all affected parties should be notified when these challenges are being made to provide adequate input from all parties.
- 9) what information should be provided to the review committee members, just the challenged book or material itself, or the syllabus and how the materials will be used in the classroom, etc.

 The only discussion following his report was one committee member who disagreed with changing "stakeholder" to 'parent or guardian." They believed taxpayers should be allowed input.

The regular meeting of the Pickens County School Board was well attended. There was an overflow of people, and at least sixteen individuals spoke eloquently against banning books.

The rest of the meeting was other business. During the final remarks from each of the Board members, only one of the members addressed the book banning. **Ms. Williams** addressed the gratuitous use of expletives in the next book up for review (no title was mentioned). Referencing a statement made by former **Chief Justice Warren Burger** after the decision on *Island Trees Union Free School District v. Pico*, Ms. Williams stated her belief that it is the responsibility, not of judges, but of parents, teachers, and school boards, to dictate standards of morality and vulgarity allowed in the resource materials used by teachers in the schools. She is also the one who believed taxpayers deserved the opportunity to weigh in on what was being used in the classrooms. She was very open and offered to have a coffee with anyone who wished to discuss opposing viewpoints with her, and provided her phone number, and email address.

Recycling Clemson

Where Can I Take My Recycling in the City of Clemson?

The City of Clemson Department of Public Works has a recycling drop-off facility located at 1155 Old Central Road.

(If you've ever picked up free mulch at the brush grinding facility, the recycling drop-off facility is in this same area.)

What are the hours of operation?

Tuesday through Saturday from 8 a.m. to 4:45 p.m. with a lunch break from 11:30 a.m. to 12:30 p.m.

What recyclables are accepted at this location?

- #2 plastics only
- Steel and aluminum cans
- Mixed paper
- Clean corrugated cardboard (which **MUST BE** broken down)
- Motor oil only (No oil filters or cooking oil)
- Electronic waste
- Glass: clear, blue, brown, and green

What is NOT accepted at this location?

- No plastic bags or plastic wrapping
- No household cookware
- No Styrofoam or packing peanuts
- No lightbulbs
- No batteries
- NO HOUSEHOLD GARBAGE

DID YOU KNOW?

The City of Clemson still offers curbside pickup of corrugated carboard!

This service is offered only by work order on Friday afternoons.

To have your cardboard picked up, please call 864-653-2053 by close of business on Wednesday.

Then have your cardboard broken down and placed on the curb by 7 a.m. Friday.


