## Steering Committee Report

Greetings from the Steering Committee! I am writing this one week before the 2024 election, completely on the edge of my chair at this watershed moment in our democracy. By the time you read this, the election results should be known — we hope.

Some of us will be happy and relieved, others will be wringing their hands. Either way, we will need to pick ourselves up and continue the work of the League to study policy options, educate voters on those options, promote voter registration and voting, and encourage participation in the democratic process. Every person we can shift from non-voter to voter is an achievement, particularly when these voters understand the issues and candidates better than they had before. Each new or re-energized voter is part of the watershed that is a healthy democracy.

Speaking of watersheds, the town is making progress toward writing the Watershed Permits that will shape our response to the restoration of nitrogen-challenged coastal waters. It is a long road ahead to approve these draft permits and then implement their measures, but it is progress. The Urine Diversion Pilot Project is on the Fall Town Meeting Warrant; that technology could play a significant role in restoring our waters. The Senate in Boston approved a Climate Bill that addresses sustainable energy production and distribution, among

other things. The House has not yet been able to take up that compromise bill, as of this writing, but pressure to do so continues and the governor has signaled that she will sign the bill, if it reaches her desk. This bill addresses the urgency of the climate crisis better than the policies and regulations currently in effect — yet another watershed moment.

Lastly, the Natural Resources Committee is hosting a program November 21 on food waste composting, at the Gus Canty Center at 7:00 p.m. We hope to see you there! See the flyer on Page 4 for all the details.

## League of Women Voters Statement on 2024 Election Results

**WASHINGTON** — The League of Women Voters of the United States president Dianna Wynn and CEO Celina Stewart released the following statement on the 2024 election results:

"The 2024 election underscores the dedication of poll workers, election officials, and volunteers nationwide, who ensured that every eligible vote was counted, and every voice was heard. This year's election was marked by integrity, transparency, and high turnout. The American people have spoken.

"While we celebrate a fair and secure election, the outcome of this election has made the future for women unclear.

"Given the disturbing rhetoric made during this election season, we are deeply concerned about challenges we may face, particularly regarding the issues that disproportionately affect women, from health care and reproductive rights to eco-

nomic security and equal representation.

"We are thankful to Leagues across the country for their tremendous work supporting the election infrastructure and supporting voters, as well as every election worker and democracy defender who guaranteed our fair and free voting process. We are thankful for the work they have done so far this cycle and the counting, curing, and certifying work that will take place in the weeks ahead.

"The League is dedicated to our mission of defending democracy. As we move forward, we remain steadfast in our commitment to advocate for policies that uplift women and ensure equitable representation in all levels of government."

## **Food Waste Composting in Falmouth**

Each program is intended to take food waste out of the solid waste stream going to landfills, and to transform the waste into useful soil-amendment compost for farmers and gardeners.

## Legislative Committee Report

The Legislative Committee held a partially social and partially business meeting at my house on Monday, October 21, with five of the six members in attendance. We started out with a lively discussion that happened to focus on current events. The discussion also turned to civics education, and the members emphasized that they would like to have notice of the classroom civics presentations so that they could try to attend.

Regarding legislation, we reviewed the main issues that had been our focus during the current legislative session. The legislature has acted favorably on some bills such as early childhood education (originally termed Common Start), firearms regulation, and affordable housing. Although the affordable housing bill did not include a provision to use the tax on a portion of sales prices of high-end housing to help support affordable housing, the provision that had been the focus of our advocacy, our affordable housing expert opined that future passage was very unlikely. The legislature also passed a bill to allow candidate child-care expenses as campaign expenses, legislation that would be especially helpful to mothers seeking election to office. We plan to continue advocacy for legislation on end-of-life options and facial recognition technology. After the new session convenes and the list of bills supported by the LWVMA is issued, we will decide on our list of about 10 bills where we will place our emphasis.

After the meeting, our communications with Zorianna Petrosyan resumed. Zorianna, a Falmouth high school graduate who is now a college student, has been working to change school start times for middle school and high school students based on the scientific evidence that the brains of young people in this age group are really not designed to function optimally if school starts too early. Zorianna has

written a letter to the LWVMA educational specialist regarding this issue and I have written a letter in support of hers.

The next meeting of the Legislative Committee will be in January, unless we find an earlier meeting is necessary. Our annual public meeting is scheduled for Thursday, March 20, and the Hermann Room at the Falmouth Public Library has been reserved.

Last April, Mike Feeney received the Charles Mitsakas award for Outstanding Supervisor, which is presented by the Massachusetts Council for Social Studies. Because he received this award, Mike will serve for one year on the Board of Directors of the Massachusetts Council of Social Studies. In our experience, Mike has always been knowledgeable; his current position on the Council gives him additional access to other state leaders in his field. Mike's responsibilities here in Falmouth are also expanding, and now reach fifth and sixth grades as well as seventh and eighth grades, in addition to the High School.





