## Communications Corner – Richard Badalamente

Your Communication's Committee will publish a column in the Voter every month, beginning with this edition. Our focus will be on the process and content of communications that reflect the League of Women Voters mission and values, with particular emphasis on our non-partisan promise to the American voter.

For the League of Women Voters (LWV), being non-partisan means the organization does not support or oppose political parties or candidates. This principle is a cornerstone of the LWV, ensuring its focus remains on issues and voters, not partisan politics. This is particularly important in the current political climate, where divisiveness, anger, and anxiety seem to prevail.

As a non-partisan organization, the League encourages the informed and active participation of citizens in government. We act in support of, or in opposition to, selected governmental issues. Our members conduct in-depth studies before we take a position.

League members, as individuals, may of course support candidates of the political party of their choice. When they do so, they must be careful to avoid association with the League. This applies to both traditional media, e.g., newspapers, and digital/social media, e.g., Facebook and Instagram.

In future columns we'll cover topics ranging from the League's Unite and Rise 8.5 Initiative to Defend Democracy to an examination of selected League of Women Voters positions at the National, State, and Benton-Franklin levels. ## Required Minimum Distribution Use For Contributing To Charitable Initiatives – Richard Badalamente

A Required Minimum Distribution (RMD) is the smallest amount of money you must take out each year from certain retirement accounts—like traditional IRAs and 401(k)s—after you reach a specific age. The law requiring RMDs comes from the Internal Revenue Code, Section 401(a)(9). It applies to most people who have tax-deferred retirement savings, meaning they haven't yet paid income tax on the money in those accounts.

You must take your first RMD by April 1 of the year after you turn 72½, and by **December 31** every year after that. The government requires this so that taxes can eventually be collected on the money that has grown tax-free for years.

RMDs can be used for charitable giving through something called a Qualified Charitable Distribution (QCD). This allows you to give up to \$100,000 directly from your IRA to a charity or non-profit, like the League of Women Voters Education Fund, or the Tri-Cities Food Bank, for example, without paying taxes on that amount, while still meeting your RMD requirement.

If you don't take your RMD on time, **the IRS charges a 50% penalty** on the amount you failed to withdraw. This rule encourages compliance and ensures that deferred taxes are eventually paid.

## **Tribal Study Update Project – Chris Murray**

A two-year study of the current status of tribal nations in Washington was authorized by LVVWA at the 2025 annual convention. The new study will support updating positions on tribal issues that are based on an LVVWA study that was completed in 1980, and will allow for greater ability to ally with native American nations around issues they bring forth and also expand LVVWA membership's knowledge of tribal sovereignty and treaty rights. Current plans are to identify national and state policy changes affecting the tribes, and to solicit information from the tribes regarding issues where they would like the support of LVV positions.

I have volunteered to participate in the study group, and we began meeting in September. In addition to statewide issues, we'll also be gathering information on important local tribes. I'll be focusing on the Confederated Tribes of the Umatilla Reservation (CTUIR) and the Yakama Nation, both of which occupied homelands in the Tri-Cities and the surrounding region "from time immemorial". I'll also do research on a land acknowledgment that reminds us of the role of regional tribes in caring for the lands we live on. On November 1st, from 9 am to 4 pm, the LWVWA [Advocacy Team](#) will be providing an online workshop on what to expect in the 2026 legislative session, which begins January 11th. “The Legislature will be making some very important decisions this year,” said LWVWA Advocacy Director Cynthia Stewart. “And so, what we’ll be doing on that Saturday is providing background on whole range of issues.” The overview of the 2026 session starts at 9 am, priority issues presentations start at 11 am, and include Democracy, Environment, Health Care, Housing, Education, and Criminal Justice.
