Microplastics and Human Health

Since the 1970s, scientists have known about the presence of tiny bits of plastic — microplastics — churning in the oceans and being ingested by birds and sea life. More recent research shows the particles are also in the Great Lakes, which thousands of communities rely on for fresh drinking water.

Join LWV ABC and our guest Dr. Mary Kosuth to learn about microplastics and

human health. Dr. Kosuth will also discuss some Minnesota policies that will encourage Extended Producer Responsibility (EPR) for plastics, as well as what still needs to be done policy-wise.

Mary Kosuth, a microplastics researcher and 2017 graduate of the U of M School of Public Health, is a Postdoctoral Fellow at the University of Minnesota's Institute on the Environment.

Tom Hunt, Anoka County Elections Director

On October 13, 2025, LWV ABC presented Anoka County Elections Director Tom Hunt with our 2025 Friend of League Award in recognition of his outstanding service in preserving our democracy by providing voters with safe, secure and accurate elections.

During 2024, LWV ABC and Tom Hunt completed a series of twelve Public Service Announcements explaining changes to Minnesota elections laws. The 2024 Post-Election Review (PER) found zero adjusted differences when compared to machine results. League of Women Voter Observers reported that Anoka County, under the leadership of Tom Hunt, conducted the PER in a transparent manner, followed state requirements and demonstrated professionalism.

As Jody Anderson, a LWV Member, an election judge and a PER observer, noted at the Anoka County Board Meeting last month, "Tom Hunt has been a reliable and transparent Election Manager. I appreciate his skill in helping all Election Judges become familiar with Minnesota Election Laws."

The LWV ABC Friend of League Award is awarded to a community member or group who assists LWV ABC in achieving our goal of good government. Artist and LWV ABC member **Cindy DeRuyter** (pictured above with Tom Hunt) painted this year's award.



Whiskey Tender: A Memoir (2024) by Deborah Taffa



Although her parents were united in their approach to maintaining a family, their attitudes toward the world diverged in other ways, and Taffa received mixed messages about her Indigeneity, her

proximity to whiteness and how she was meant to carry herself.



In 2022, the state of Minnesota adopted a Climate Action Framework setting a vision for how our state will address and prepare for the effects of climate change. That framework included specific action steps and measures of progress to guide and evaluate that work. Thanks to new funding and other opportunities, the state is set to adopt a new Climate Action Framework in 2026.

Writing Letters to the Editor

Letters to the Editor (LTE) are helpful tools for advocacy as they reach a large audience, are often seen by elected officials and can cover information not addressed in news articles.

Tips for writing a LTE:

- 1. Keep it succinct and address only one issue.
- 2. Make it legible and traceable: Include your name, address and phone number.

- 3. When relevant, reference previous articles or topics covered in the paper. Examples:
 - "I was disappointed to see that (Paper)'s (Date) editorial '(Title)' omitted some of the key facts in the debate."
 - "I strongly disagree with (author's name)'s narrow view on (Topic). (Name of Op-Ed, date)"
 - "I am deeply saddened to read that (Topic). (Title of Article, date)"
- 4. Fact check and proofread.

Heidi Kloempken




Heidi Kloempken started as our LWVMN Associate Director on November 4, 2025.

USA v. Simon

Minnesota Voter Data

On October 14, 2025 League of Women Voters of Minnesota, Common Cause, and two Minnesota voters, all represented by the ACLU, filed a motion to intervene in United States of America v. Simon. USA v. Simon was filed by Department of Justice on October 25, 2025 to force the Minnesota Secretary of State Steve Simon to turn over extensive and protected Minnesota voter information to the federal government.

What is a motion to intervene?

A motion to intervene is a formal request to a court to join an already existing lawsuit, as either a plaintiff or defendant, because they will be directly and substantially affected by the outcome. Once a person/organization is allowed to intervene, they fully participate in the rest of the case — filing briefs, participating in trials or oral arguments, agreeing to any settlements and appealing decisions if desired.

Background

In June, the Justice Department (DOJ) sent a letter to Simon requesting data about Minnesota's compliance with maintaining its voter registration list and for the full statewide voter registration list. In response, Simon's office provided data on maintenance, but declined to send the entire voting list until the DOJ identified the legitimate legal basis for sharing that list. Simon's office also sought assurances that any data it supplies would be protected and used properly.

The Department of Justice contends that federal officials should have access to Minnesota's list to ensure Minnesota is in compliance with the Help America Vote Act, citing a March executive order.

League Position

Marcia Johnson, chief counsel of the League of Women Voters of the United States stated that, "The Department of Justice should be focused on protecting voters from illegal invasions of privacy, not violating those very privacy laws." When filing a similar motion in California, Celina Stewart, CEO of the League of Women Voters of the United States noted that "Participation in a democracy should empower people, not force us to trade safety, privacy, or peace of mind to be heard...Safeguarding voter data is essential to safeguarding trust in our elections."

In addition to Minnesota, the League has filed motions to intervene where the Justice Department has brought similar cases - in California, Maine, New York, and Michigan.

Other October Litigation

Indiana - lawsuit challenging state laws that target naturalized citizens.

New Jersey - filed a friend-of-court brief arguing that the community trust policies enacted by Newark, Jersey City, Paterson, and Hoboken, promote the safety, health, and welfare of all residents, regardless of immigration status.
