## LWV: Diversity, Equality and Inclusion (DEI)

The League's Shur Fellows have prepared a glossary of commonly used words as part of their work on DEI. Here are this month's words:

**Ethnicity:** A social construct that divides people into smaller social groups based on characteristics such as shared sense of group membership, values, behavioral patterns, language, political and economic interests, history and ancestral graphical base.

**Implicit Bias:** A negative association that people unknowingly hold. Expressed automatically, without conscious awareness. Many studies have indicated that [it] affects individuals' attitudes and actions, thus creating real-world implications, even though individuals may not even be aware that [it] exist[s] within themselves. Notably, [it has] been shown to trump individuals' stated commitments to equality and fairness, thereby producing behavior that diverges from the explicit attitudes many people profess.
