An added benefit is that voting makes citizens recognize that they have a stake, not only in the election result, but in the democratic process itself. the heart of our organization. For the coming election, our Voter Service Committee, led by Pat and Jane, has taken on a huge workload, with four candidate forums, a local proposition forum, a Pros and Cons of State Propositions program, and distribution of voter education materials. (If you are really focused on the national election, remember that voters who fill out their ballots because of a local or State issue will also vote for national offices.) This team is highly motivated and experienced, but it is small. If you want to help with any of these projects, get in touch with Jane (964-6351 or janeperson@hotmail.com) or Pat (937-3409 or pdunbar@mcn.org).

If you're more comfortable working on your own or with a friend, Jane can give you tips on setting up your own voter registration post. Last month Cindy, Jary, Loreto, and new League member Morning Nichols set up one at the Fort Bragg Farmers Market, and were surprised and pleased to find several new voters. This activity has much more impact than the number of new registrations you get. Just seeing you encourages people to check their registration and to vote. Also, you can distribute the Easy Voter Guide, which explains how to vote and how to get more election information. If you don't want to get out in public, talk it up with your friends. Brag (subtly and modestly) about how you have made a plan: where you will find answers to your questions; when you will fill out your ballot; when and where you will drop it off, mail it, or take it to the polls. Not everyone has formed a strong voting habit, and a little nudge can make a difference. And while the League is nonpartisan, it encourages members to also be active in

partisan efforts, which also increase participation. So you have many choices, but not much time. Empower yourself by empowering voters.

The more we collect at this time, the less we will spend on postage for having to ask later on. The full amount of your regular dues-\$60.00 for an individual membership or \$90.00 for a household-is passed on to the U.S. and California Leagues to support their continuing efforts towards making democracy work and preserving our world. This amount also gives you full membership in both organizations. As these regular dues add nothing to our coffers, we include additional levels of contribution for you to consider when you make your renewal. These fund the activities of our local League. Each membership level is named after a man or woman of the past who strove for human rights and justice:

 Susan B. Anthony founded the National Woman Suffrage Association along with Elizabeth Cady Stanton.

• Ida B. Wells was a suffragist, as well as an American investigative journalist,

educator, and an early leader in the civil rights movement.

• Emma Smith DeVoe founded the National Council of Women Voters, which merged with the National Woman Suffrage Association to become the League of Women Voters.

• Harriet Tubman escaped from slavery in the South to become a leading abolitionist before the American Civil War. She joined Elizabeth Cady Stanton and Susan B. Anthony after the Civil War in their quest for women's suffrage. • Frederick Douglass spoke at the Seneca Falls women's rights convention in 1848, urging women not to compromise on their demand for the vote. Donations to our League's Frederick Douglass Diversity Fund allow scholarships and "try us" memberships.

Thank you for remaining a member of a committed group of women and men who are working to make a difference in the future of our country.

### Jackson Forest Reports

Renewed logging plans for the Jackson Demonstration State Forest (JDSF) were announced in late August. Voter readers following the involvement of Mendocino indigenous groups in managing the JDSF may wish to read the Mendocino Trail Stewards' subsequent statement:

Many of you have already heard the unfortunate news that CalFire has announced the end of the pause on logging in the Jackson Demonstration State Forest (JDSF). We felt a glimmer of hope for community and tribal engagement after the August 19th meeting of the Jackson Advisory Group (JAG), when CalFire unveiled its new "vision" for Jackson, said to prioritize tribal co-management, cultural resource stewardship, and restoration ecology. Jessica Morse, Deputy Secretary of Forest Resources Management at the California Natural Resources Agency, even made an appearance to deliver the new vision to the Public.

Morse spoke eloquently about new management strategies for JDSF, including obtaining funding for operations that won't be tied to timber revenue, and modernizing the management plan to reflect the changing climate and the needs of tribes. "Your activism and engagement has not gone unheard," said Morse.

Just five days later, our renewed hope was turned on its head when CalFire released another press release announcing that logging would resume in the coming weeks on four Timber Harvest Plans: Chamberlain Confluence, Red Tail, Soda Gulch, and Caspar 500. Michael Hunter, Chairman of the Coyote Valley Band of Pomo Indians, was "shocked" when he read the news. Hunter, who has been in Government-to-Government negotiations with the State for six months regarding tribal co-management of JDSF, said "The State did not even bother to notify the Tribe beforehand. The State wants to continue logging our Pomo Homeland — the Jackson Demonstration State Forest — while negotiating a comanagement agreement with the Coyote Valley Tribe. This makes me question the State's seriousness about co-managing ancestral lands."

The Coalition to Save Jackson followed CalFire with its own press release. "CalFire appears intent on burning bridges," said Matt Simmons, staff attorney at the Environmental Protection Information Center. "The 'pause' in operations made community input and tribal negotiations possible. Now, any progress or goodwill has been shattered. We call on CalFire not to resume logging until they have a new Management Plan."

More information about the Coalition's response is in their press release. Also, Trail Steward board member John P. O'Brien, PhD., will be giving a talk about Jackson State Forest, its history, and the ongoing issues with management for the Audubon Society on October 17 via Zoom (register here).

# Bus Stop at The Woods

There's even parking

The League supports the Mendocino Transit Authority (MTA) as a worthwhile alternative to the burning of fossil fuels in private vehicles. Little River resident Ronnie James provides an update about MTA service in her part of the coast: Bus Stop at The Woods: This information is for those of you who live along Little River Airport Rd. or any of its connecting roads. Back in April the Mendocino Transit Authority (MTA) established a bus stop in front of the Woods Clubhouse. It is part of their Route 60/Coastal schedule. Currently the MTA bus stops at the Woods four times a day, Monday through Friday. There are two southbound stops at 8:25AM and 4:35 PM. You can use the morning run to get to the Anderson Valley and Ukiah. Using the two northbound stops at 9:15 AM and 5:10 PM, you can get to Mendocino, Caspar and Fort Bragg. At your request, the bus will take you along Franklin Street down to Denny's. There is a promised mid-day stop at the Woods when the MTA hires enough drivers. Check the MTA website (mendocinotransit.org) for a full list of schedules. If you want to use this bus service the Woods Cooperative Association (WCA) has authorized limited parking. They request that you park in the area next to the Lodge which is west of the clubhouse. There is no overnight parking at this time. This is a great way to avoid high gas prices. You can shop, make doctor appointments, hike the coast, lower your carbon footprint and even get to work if you have flexible hours. Each bus has two bike racks if you want to get around that way.

### Hubs and Routes Game Day

Collaborative Self-Sufficiency

If you weren't there you missed a fun and informative event. Co-founded by Jennifer Kreger and cartographer Rick Hemmings, the Hubs and Routes project [May '21 Voter] provides readiness maps on their website for residents of the Mendocino Coast. At the Game Day, September 10, in the Larry Spring Museum "commons" area on Redwood Avenue in Fort Bragg, there were many enjoyable ways to use the maps and to practice for collaborative self-sufficiency.

At the event was a yards-long map of Mendocino County's coast divided into various "islands". Basically, all of those who live along the Mendocino Coast live on an "island", with waterways of all sorts as borders.

Also on display was a foldable map that will be available to the public, after some additional fundraising to cover the cost. The maps include emergency supply locations, plus the best routes out of each zone, including hiking, biking, paddling "go-arounds," in case bridges aren't available as a result of earthquake, erosion or sea level rise. ## California League Updates

A recent message from California President Carol Moon Goldberg contains much information about our state League's election resources, advocacy, and its upcoming convention. The complete message includes links to the Easy Voter Guide, Pros & Cons, Ballot Recommendations, and current Legislative Advocacy.

Also, the regional collective of Santa Clara County Leagues has formally supported a recommendation to change county elections there to Ranked Choice Voting. You can read their letter to their Supervisors.



A message from US League President Dr. Deborah Turner announces the creation of "the LWVUS Legal Center, a database on lwv.org that showcases up-to-date information about our litigation work. Users can search cases by name, state, or topic to find information on historic and active cases."

She also suggests that we "join the League of Women Voters and our friends at Vot-ER, a nonpartisan organization integrating voter registration into the health care system, for our GOTV phone banks! We'll be calling people that health care providers and organizations helped register to vote to make sure they're prepared for the upcoming November election. Spanish-speaking volunteers are especially encouraged." Online training is offered for those who wish to participate. Contact istavely@mcn.org for links to zoom registration on several dates in late October and early November.

LWVUS Education Fund has launched a nationwide effort to combat mis- and dis-information called the Democracy Truth Project. It is considered one of the four prongs of its "Women Power Democracy" program focus.

As we do independently in Mendocino County, many local Leagues are doing youth voter registration through the annual LWVUS project. (Cindy Plank regularly places state and national information such the link above on our Facebook page.)

On September 21, the US House passed the bipartisan *Presidential Electoral Reform Act.* The bill would strengthen the *Electoral Count Act* and has been lauded as a step against future insurrections like the one that occurred on January 6, 2021. The Senate also unanimously passed their legislation, the *Electoral* Count Reform and Presidential Transition Improvement Act, out of the Senate Rules Committee on September 27. Advances in election reform, however, did not extend to financial transparency in the Senate's decision not to advance the DISCLOSE Act the following day. In response, LWV CEO Virginia Kase Solomón stated: "The League will continue to fight to ensure that voters can make decisions free from the influence of dark money and special interest groups in our politics. We call on our elected officials to continue to put this issue at the forefront of the fight for our democracy."

Finally, Human Rights Special Interest Group (HRSIG), one of whose members presented United Nations Artwork at a recent Annual Meeting [May '21 Voter], has announced the release of a new publication:

We are pleased to announce our latest work on Your Human Right to Vote. Once again we highlight work of the global community, starting with the 1948 Universal Declaration of Human Rights. This fundamental document states plainly and unequivocally--the right to vote is a human right. This right is enshrined in many international covenants adopted by Member States of the United Nations. This right is also included in Amendments to the US Constitution. Yet, we cannot be complacent--we must continue to protect this human right to vote and raise awareness of infringements on this right, especially in our local communities. We are mindful to *Think Globally and Act Locally*. Please see the overview of Your Human Right to Vote in our third Briefing Book, available for download here at no cost.
