# President's Message ~ Diane Molleson

Our candidate forums has been recorded by Northwest Public Broadcasting at the end of September and broadcast the week of October 14 on PBS through NWPB and KTNW. They will be rebroadcast the week of October 28 and will also appear on NWPB's YouTube, the LWVBF and Badger Club websites and on the Cities of Richland and Pasco TV sites through election day on November 5. We are covering 13 races, including an in-person debate between Jaime Herrera Buetler and Dave Upthegrove, the candidates for the Commissioner of Public Lands. A list of the races and the days/times they will be broadcast appears in this *VOTER*.

In August, we held a presentation and discussion of I-2117 (repeal of the Climate Commitment Act) led by Doug Ray, Board Chair of Carbon Washington and Senior Research Fellow Emeritus of Pacific Northwest National Laboratory. Ray described the strengths and weaknesses of the Climate Commitment Act and explained why he and Carbon Washington oppose I-2117, a position shared by the League of Women Voters of Washington. This event, held in the Richland public Library, was open to the public and well attended.

On October 16, we are hosting a Wine Social for our members and guests that would like to learn more about League. There, we will present the pros and cons of the four initiatives on the November ballot. (See details in a separate article.) We hope you will join us.

# LWV-BF Treasurer's Report – August 2024 – Carla Chiotti

As of August 31, 2024:

Checking is \$7,057.70 Savings is \$1,857.29 Total \$8,914.99

**Income:** \$1,145.02: We received \$1,045 in membership dues from one new member (welcome Mary Gates), 12 renewing members, and two second-in-household. We also received \$100 in contributions.

**Expenses:** \$16.77: We paid \$16.77 in PayPal fees. We received a \$15 reimbursement from Umpqua Bank for the mistake they made in July, but they made the same error in August and charged us another \$15. (This was reimbursed in September and the bank says they have it fixed this time).

**In-Kind Donation:** We received an in-kind donation of 200 red, white, and blue "Vote" wristbands. The value of the donation is \$136.

**Membership campaign:** During August, twelve members and two second-in-households renewed their memberships.

**Education Fund:** We received an update for the LWVBF Education Fund on 8/29/24. Thanks to a \$200 donation, our balance now stands at \$8,340.42.

# Table Talk Report – Lora Rathbone

## Pros and Cons of I-2117 and Washington's Climate Commitment Act –

This LWVBF Table Talk was held August 29 at 6 p.m. in the Gallery Room at the Richland Public Library. Douglas Ray, Board Chair of Carbon Washington and Senior Research Fellow Emeritus at Pacific Northwest National Laboratory, shared his views on the strengths and weaknesses of the Climate Commitment Act and explained why he and Carbon Washington oppose Initiative 2117. We publicized the event to the public, and refreshments were available. About 20 people attended.

Background information: the mission of CarbonWA is to increase demand for climate action and fight for smart carbon policy. "By focusing on effective, efficient, and equitable climate solutions, we develop and promote programs and policies that are supported by diverse stakeholders and set an example for national and global action." Carbon Washington supports the Climate Commitment Act (CCA). "By putting **a price on carbon** emissions, the Act ...provides necessary revenue to accelerate decarbonization efforts

and enables the funding of important programs like the Working Families Tax Credit, which helps lower-income families meet their needs."

Doug started his presentation by saying "reliable studies show that without a price on carbon, no significant decrease in climate pollution occurs. The CCA, which puts a price on carbon, is the largest element in Washinton state's program to reduce climate pollution. This cap and invest type of program is common in Europe. California has had a similar program for ten years; we learned from them and ours is better. The best source to learn about the CCA is <a href="https://climate.wa.gov/">https://climate.wa.gov/</a>.

I-2117 forbids pricing carbon in WA state. If it passes, we will not meet the required reductions in emissions. It will also end the \$2 billion already generated and being used to transition to clean buses, expanding the EV charging network, and much more. It will also end the prioritized support for overburdened communities, with programs such as utility bill credits."

The main argument for preventing pricing carbon is that it will increase the cost of gasoline - to only 25 cents per gallon, which is a small price to pay for clean air and better health. The LWVWA argument for a No vote is "there is no Guarantee of Lower Prices: Repeal of the law doesn't ensure lower energy costs but guarantees more pollution and weakens environmental protection."

The answer is not to repeal the CCA but to keep working to make the transition equitable.

# Emergency Risk Protection Orders (ERPOs): Project Update – Richard Badalamente

About a year ago, the LWVBF began a project to raise awareness of Washington's Extreme Risk Protection Order (ERPO) law, and in the process educate people about ERPOs and what they can and cannot do. This effort is consistent with the LWVWA's policy statement on gun safety.

The ERPO team, led by LWVBF member Richard Badalamente, now includes LWV members Carla Chiotti and Diane Molleson; Karla Carlisle, a lawyer with the Northwest Justice Project; and JoDee Garretson, the Executive Director of the Support, Advocacy and Resource Center (SARC).

The results of a public records request of the Benton County Superior Court and Franklin County showed how sparingly this law is used in Benton and Franklin Counties. Between 2017, when the law took effect, through the end of 2023, only 13 ERPOs were granted. However, we recently received some welcome news. An ERPO filed last month by the NW Justice Project was the first ERPO to be granted in Benton and Franklin Counties since 2021.

Richard and Rosanna Herrera of SARC will be meeting with Benton County Prosecuting Attorney Eric Eisinger in October to discuss how few ERPO petitions are being requested and granted.

We need League members willing to write Letters to the Editor in support of the ERPO law, not as members of League, but as members of the community concerned with gun violence. Richard would be happy to provide help (i.e. a template of the letter) with this effort.
