In Memoriam

Marilyn Perkins and Diane Molleson

Within ten days in September, we lost three LWVBF members. Paula Garland, Neil Norman and Shirley Miller were dedicated to their families and community. Given all their other responsibilities, we are very grateful they shared their time, energy and valuable insights with our League. Services have already been held for Paula and Neil. Shirley's memorial service will be at 2 pm on October 27 at Events at Sunset in Richland.

Paula Garland – Paula was born in 1915, five years before the 19th amendment passed. She, and others of her generation, lived through a lot of history. She was from Brooklyn and after her marriage, the family moved often on the East Coast. In 1952, they settled in Buffalo where she helped start a League and became its first president. She would later serve on the League's State Board of Pennsylvania. The family moved to Richland in 1972 and Paula was a member of our League for the next 46 years. For several years she offered her "empty garage" to hold our annual garage sale fundraiser. Once in Richland, she and her husband Dan became part of a smaller Jewish community than they had experienced before, and she took on leadership roles in the congregation and the Sisterhood, even serving on the National Board. We will miss her sweet nature and faithful support.

Neil Norman – Neil was a more recent member of our League, joining in 2014. He and his wife helped us celebrate Paula's 100th birthday. We always appreciate the men in our League, and Neil was a wonderful addition and served a term on our board. He had already made his mark in our community both professionally and as a dedicated volunteer helping those less fortunate, including refugees who relocated to the Tri-Cities. The father of many daughters, he was a strong supporter of women and their changing roles, and we benefited from his perspective on many issues. He spoke lovingly of the time he spent with his children and grandchildren.

Shirley Miller — Shirley, who died at age 88 on September 21, was a trailblazer. She moved to the Tri-Cities from the Midwest in the early 1950s and worked for civil rights, women's rights, gay rights and farm workers. She helped African Americans rent when landlords were turning them away. In the 1970s, she co-founded a group for victims of sexual assault—Benton County Rape Relief. Now called the Support, Advocacy & Resource Center, it marked its 40th anniversary last year. With several friends, she opened a local independent bookstore, The Book Place, which was a beloved community institution for 30 years. She joined League in 1967. We will miss her boundless curiosity, compassion and open-mindedness.
