PRESIDENT'S MESSAGE

October is the month our LWVOP focuses on voting and elections.

Leaguers are registering voters at two county high schools, the tech schools in Easley and Seneca, Clemson

University, and community events. We partnered with the NAACP in this endeavor with a prize awarded to the high school with the most newly registered voters.

Our three candidate forums focus on educating the public on the candidates running in different county and city races and how these candidates stand on the issues. A question-and-answer period allow voters to learn why candidates are running and what they plan to do if elected. In addition, the league maintains a website, VOTE411.org, with additional information on candidates. This involves submitting questions to all candidates and recording their answers on the website. Candidates who do not respond get recorded as such. These varied activities support our "Make Democracy Work" Program.

Our October General Meeting on October 18 concerns recycling. On August 1 the City of Clemson suspended its pick-up recycling program for lack of markets, problems of contamination and the need of a new truck. Residents were encouraged to take their recyclables to Kite Hill at Clemson University, the Pickens County recycling centers, or the brush site near the CATBUS location. Word has it that Pickens County government plans to purchase a bailer for bundling the plastics to make these recyclables more marketable. Meanwhile Clemson University continues to have a successful recycling program while Oconee County may have a better plan for its county residents. Why the disparity? Come learn the facts.

Voter Registration Activities Leading Up to the November Election

The League of Women Voters of Oconee and Pickens County has contacted all the high school students in our counties and given them the opportunity to register to vote. LWVOP teamed up with the NAACP in a competition among the high schools to see which school could register the most voters. A prize was provided by the Greenville League of Women Voters to the winner. We have also been to the Oconee and Pickens Technical Colleges to register voters. We are scheduled to register the CU football players which has been successful in the past. This is a yearlong process as many seniors are not old enough to register so we will need your help in the spring. A big thank you for those who helped this fall! Join us next spring as we push forward to increase our voter registration activities.

LWVOP OCTOBER PROGRAM – RECYCLING CHALLENGES

For more than a decade, communities have adopted recycling programs with the intent to reduce landfill use and demonstrate environmental awareness. Over time, this has become integrated across most communities, enabling people to "recycle" items such as paper, glass, aluminum, and plastic. But is that what really happens? The City of Clemson has halted curbside recycling after learning that Pickens County only recycles 8% of what it picks up. Most goes into the landfill. Halting curbside pick-up for now enables the city to save money but leave the door open to re-start the program when the market for recycling emerges. The goal of this program is to explore the market for our trash, what gets recycled, what we need to do better (no, don't put newspaper in plastic bags!), and how we can truly reduce, re-use, and recycle for maximum impact.

Guests for the October program will be **Allison Gantte**, Assistant City Administrator for Clemson; The Kite Hill staff, including **Director Dave VanDeventer**, will attend to discuss collaborating with the city and other possible recycling markets where the City can participate. We are waiting on confirmation of attendance from Oconee and Pickens County representatives. The goals of our panel are to discuss the current recycling market, how to reduce and reuse materials, and where we can all be more involved to recycle what we can.

The Ballot Box was NOT Stuffed - Here's the Proof

If the number of voters equals the number of ballots, the ballot box was not stuffed. The ballot box counts the number of ballots it reads and prints the number of ballots immediately after the polls are closed at the end of the election. (If there is doubt the number of ballots in the ballot box can everified by a hand count.

We also have a reliable count of the number of voters. The sign-in sheets are special; each having exactly 50 lines. Each voter is carefully instructed to sign on the line below the previous voter before being handed a blank ballot. When a sheet has 50 sign-ins, it is moved to the bottom of the stack and replaced by a fresh sheet. Immediately after the polls close, the number of voters is computed by multiplying the number of full sheets by 50 and adding in the number of signatures on the current sign-in sheet. The clerk prints two copies of the precinct voting results and posts one copy on a precinct door. The other copy is turned in to the county elections office, along with other documentation and equipment. Precinct results will also be posted at sevotes.gov.

When, as expected, the number of voters is the same as the number of ballots cast, we can trust the that the ballot box was not stuffed. Since the comparison of number of voters to number of ballots cast happens at every polling place in every county, we have a very secure election. If anybody tried to stuff a ballot box, the problem would be detected immediately.

Reproductive Rights Group Update We Won This Round!

In the previous *Voter* we reported on public education and advocacy in Oconee and Pickens Counties by the LWVOP Reproductive Rights Group (Group) to prevent the South Carolina Legislature from passing a more restrictive ban on abortion in South Carolina.

During August and September, the Group continued these efforts, asking Members of our respective county legislative delegations to vote no to more restrictive abortion bans like H.5399 passed by the full House in August, then amended and passed by the Senate in September. When the amended bill returned to the House on September 27, all our Oconee and Pickens County Representatives joined most of the House members in a nonconcurrence vote, requiring the bill to go to a House/Senate Conference to resolve the differences between the Chambers. The pervasive view as of early October is that there will be no conference this year and that the process will begin again in the next legislative session. So, in a way we might say we won this round, even though our legislators weren't voting no to protect reproductive rights. So, abortion continues to be legal in South Carolina up to 20 weeks; the restrictive Fetal Heartbeat Act is currently blocked by the SC Supreme Court, which will hear oral arguments on October 19. That decision will affect what happens next year in the legislature.

In October the Group will review our many actions and lessons learned, to guide us the next time we need to educate the public and advocate for reproductive health and rights. South Carolina women, girls and families are counting on us. Of those, 27 have responded and posted their answers. To date, the candidates have received a phone call, two emails, and a postcard requesting their participation.
