# Nonpartisanship & Political Engagement: A Balancing Act

In the final month leading up to the 2024 general election on Nov. 5, members have asked questions about how being a politically engaged citizen fits into the context of the League's longstanding nonpartisan character. From the national League website is the following statement about this balancing act:

The choice made [by the League of Women Voters] in 1920 to neither support nor oppose any political party or candidate for public office continues today to ensure that the League's voice is heard above the tumult of party politics. The nonpartisan policy has added strength to the League's positions on issues and has made possible wide acceptance of League voter service and other educational activities.

At the same time, the League is a political organization and encourages members to participate fully in the political party of their choice. It is an advantage to the League to have politically active members and, equally important, it can be a personally satisfying experience.

Each League's board of directors is responsible for drafting and carrying out a nonpartisan policy in its community. In order to ensure the credibility of the League as a nonpartisan organization, the board also is responsible for seeing that both its members and the public understand the League's nonpartisan policy. continued next page

#### Nonpartisan Engagement continued from page 1

At our October meeting, we will talk about being a partisan member of a nonpartisan organization and engage in activities that help clarify how and when a person can be one or the other at any given time.

To prepare yourself for this meeting, first familiarize yourself with our LWVSA's Nonpartisanship Policy. To help with that, here it is:

**A.** The League of Women Voters is nonpartisan in that it does not support or oppose any political party or candidate; it is political in that it takes positions on selected governmental issues.

While the League urges its members to be politically active, certain constraints are necessary to maintain the nonpartisanship of the organization. Therefore, the Board has established the following guidelines to protect the League's nonpartisan reputation:

**B.** In accordance with the national LWV's nonpartisanship policy, the LWVSA Executive Officers will not engage in partisan activities while serving as a LWVSA Executive Officer. Partisan activities include, but are not limited to:

- Holding political office.
- Donating reportable sums to a candidate.

• By word or deed, publicly endorsing a candidate for office/position.

**C.** All other members are encouraged to participate fully in the political process, serve on public boards and commissions, and participate in political activities as individuals without implying or receiping League endorsement. When acting in the public as League representatives, members must not allow partisanship to be discernible.

**D.** This policy is to be reviewed and endorsed or revised by the League of Women Voters of the Spokane Area ("LWVSA") Board of Directors ("Board") at the beginning of each League year and subsequently published in the VOTER.

The question has been asked, how is "executive officer" defined? Does this mean committee chairs? Our bylaws don't provide a specific definition, but do state the following:

One Executive Officer (a Co-President or President) and the Secretary shall be elected in odd-numbered years. The second Executive Officer (a Co-President or Vice President and Treasurer shall be elected in even-numbered years.

The second thing to do to prepare for the meeting is to review our state League's positions which oppose four initiatives on the upcoming ballot. We'll have an opportunity at our meeting to talk about how to advocate for "No" votes. You can find info at LWVWA.org. Be sure to scroll down on the homepage to find PDF links to "Simplified Ballot Initiative Summaries."

# Affordable Housing and Homelessness Solutions (AHHS) The Only Solution to Homelessness

We have long realized that homelessness is deemed a criminal offense in our society. Our former mayor was often guoted "we make homelessness to comfortable." That logic is hard to understand if you have ever spent a night in the cold with insufficient shelter. As part of her campaign to make being poor and unable to afford shelter more uncomfortable was to "sweep away" what few belongings they had to discourage them from existing in her city. Advocates have relied heavily on Martin v. Boise to prevent cities from criminalizing being poor and unhoused. Now SCOTUS has overturned that decision with the Grants Pass ruling. Public camping bans no longer are considered cruel and unusual punishment if you have no other shelter. Cities are now free to use jails as homeless shelters. The GAO, the government accountability office, has found that for every \$100 increase in monthly median rent, there's a 9% increase in homelessness. Victims of low wages and soaring rents are now going to be jailed if they can't find a way to

Being jailed brings all manner of consequences. Whatever assistance they are getting is cut off and requires months to reclaim. If they weren't already unemployed, they would be now. If they have been trying to keep their family intact this will surely make that even more difficult. Then there is the cost to the taxpayer. While the minimum wage will not support housing in Spokane, the taxpayers fork over \$200/day to house those incarcerated. Recently, during a presentation at the Spokane Homeless Coalition, it was reported that most of those incarcerated are there due to homelessness. At another press conference, Councilman Jonathan Bingle stated that law enforcement recognizes most of the crimes in Spokane are committed by 100 individuals who should be in jail. We should be more focused on putting those 100 in jail and house the criminally poor!

"The evidence is irrefutable that the best approach to addressing homelessness is providing people with access to affordable, stable housing and voluntary supportive services," said Sarah Saadian, the Senior Vice President of Public Policy and Field Organizing for the National Low Income Housing Coalition.

### **Ballot Translation Committee** Ballot Translation and Voter Outreach and Education for Naturalized Citizens

The Sample Ballot produced by the Spokane County Elections Office is now being translated for use as a voting resource by naturalized citizens whose first languages are Spanish, Arabic, Dari, Russian, Ukrainian, Swahili, Kinyarwanda, Vietnamese and Chinese. The translated Sample Ballots will be posted on the LWVSA website by Mary Hughes and Jan Wingenroth and linked to the Spokane County Elections website by Vicky Dalton, County Auditor. Print copies will be distributed at LWVSA voter workshops and other events hosted by our partner organizations.

With the project now in final production stage, the work of the LWVSA Ballot Project committee members, Judy Silverstein, Dawn Shuster, Becky Dickerhoof, Mary Moore and Susan Hales is in-

tensely focused on the presentation of 12 voter workshops for naturalized citizens and production of workshop kits containing the necessary translated voter education handouts for each. The non-partisan workshops are presented in partnership with the many organizations serving Spokane's refugee and immigrant communities. Workshop topics cover who is eligible to vote, how to register to be a voter, Washington's voteby-mail election system, the mechanics of how to complete and submit a ballot, how votes are counted in the Elections Office and other topics.

# Call for Donations – bring to the October meeting!

The LWVSA Board is asking members who attend the September 11th membership meeting at The Hive to donate items to help unhoused people in the Spokane area.

**Hope House** is devoted to providing services exclusively to women experiencing homelessness. Hope House is asking for the following items: sunscreen, deodorant, travel sized shampoo and conditioner, hygiene wipes, bath towels, laundry detergent (tide pods), disposable razors, ground coffee, **new** women's underwear (all sizes), hair accessories, individual alcohol swabs, leggings, and household items (no bakeware).

CHAS Mobile Medicine/Street Medicine/ Outreach provides mobile medical care to homeless individuals throughout the Spokane area. CHAS is asking for the following new and used items: men's and women's shoes (all sizes and styles — tennis shoes, boots, sandals), blankets and sleeping bags, men's and women's clothes in all sizes (jackets, sweaters, sweatshirts, t-shirts, long johns and snow pants).

# Pat Mummey

Pat Mummey created what friends and colleagues called a 'very wide wake' meaning her leadership was so strong that you never felt alone in doing the 'right' thing. She was president of the League of Women Voters of Spokane and ultimately became the first woman Spokane County Commissioner. In her eight years as county commissioner her influence is still felt. A recycling queen, and chair of a citizens' advisory board for the waste to energy plant she withstood tremendous heat from nay-sayers when she advocated to close the landfills and build the plant.

She was clear about what mattered in life. As a nurse working for a pediatric oncologist, she encountered hundreds of adults and children facing cancer. She is responsible for spearheading the no smoking indoors and on county property, despite the uproar it caused. She championed clear water, public health and affordable and efficient public transportation.

Mummey was well-known for her occasional abrupt approach. Her supporters say she was short with people because she had little patience for wasting time. That bluntness occasionally worked against her, but it usually worked for her constituents. For example, in a closed-door meeting about a high-ranking employee who was sexually inappropriate with a female staff member she told her male elected officials and executives that if they didn't remove the employee from office her next call was to the newspaper. The employee was removed from employment.

She proposed curtailing grass-field burning in 1989, six years before the state ordered industry to cut the smoke. She worked for longer prison sentences for violent and predatory sex offenders yet asked for better treatment of offenders and their victims. She ran for county coroner even as she was slowly dying from cancer herself in 1996.

Pat Mummey believed in the system regardless of its flaws and defects. She didn't always get her way, but she was never shy of trying and she wasn't afraid of not being liked. She had a long career on public committees and in office. She knew regardless of status, politics, or interests, we are all in this world together. She loved the League and understood its many different opinions and activities that made civic life better. She was an inspiring force.
