George Swimmer: Echoing everything you said about Linda Kunze, condolences to family. Ran for state representative many years ago. Lost in the primary. Involved in project for Belmont Underpass. Referenced a number of fatalities in DG. Suggestion for raising the track (like in Oak Park). Train traffic increasing, many during rush hour. Here tonight to propose the appointment of a special task force to look at possible grade separation in DG. Go back to plan that came up about 60 years ago about raising the track. Named a number of individuals in local government who might be interested in serving on such a task force.

Mayor's response: Such a project presents many challenges, financial, logistical, political, but this might be a better time than before. Maybe the time has come. It would be a project that would straighten out the situation at the crossing at Washington Street.

First Reading

Relates to residential construction projects.

- Barnett: supports as a logical next step. This feels like a better-balance, a focus on net change than previous drafts of the ordinance..
- Waldack: We can't change the weather, we can't change topography, we want to help our residents. I support this.
- Hosé: Heard from residents in all corners of the village, my storm water problems weren't bad until the big house up the street went up. Not a problem we can solve overnight, but this is a good step.
- Tully: this has taken a lot of work. Appreciate perspectives from the community. Can't let perfect get in the way of good.

Manager's Report

A. Facilities Sustainability Plan INF 2018-7919

Seeking council direction. Related to replacement of Village Hall and Police Station in conjunction with a private developer.

Written offer included with staff report on website.

White: I remain convinced that non-financial reasons made the townhomes the best option, At this point, 8 million dollars in cash tips the scale. I'm comfortable that this offer is better. If others want to explore options with more townhouses, I would agree to that. The police need facilities, and we can't delay that much longer.

Hosé: When we did the Request For Proposals, my biggest concern was financial.

- Waldack: I don't think you leave process for expediency, but you do step away when it is detrimental. The last process had flawed choices. The public was emphatic that they didn't want tall buildings and more density. The townhomes are the preferred land use. Medical office was OK, but it fell financially short. Get the word out and see if anything shakes, but otherwise, I'm perfectly happy to go ahead. Suggests pursuing 2nd and 4th options while seeking proposals from only townhome developers.
- Barnett: I thought this was a good idea a year or so ago, I continue to think it is a good idea. Move ahead with it expeditiously.
- Earl: said before we needed to wait two years to see if buildings got filled. Townhouses were my preferred option, preferred land use. Lead towards current plans since there are elections coming up. I don't think throwing money at it makes it a whole lot better. If everyone wants to look at townhouses, I can go along with that.
- Walus: Leery of offer. Sudden, a much greater amount being offered. Now is the right time. In the end, I believe option B is going to be our best option, negotiate terms. Does not obligate us to approve. Confirmed with attorney that the village is not at any risk because of previous RFP.
- Tully: Objective is to solve facilities challenge. My concern last time was the financial gap. I'm intrigued by this current offer.

Council Member Reports

Tully Next week, there will be a presentation from the Humane Society and Chamber of Commerce on ordinance relating to sale of pets "puppy mill" ordinance. Nothing will be decided next week.
