1. Tell us about yourself & how your experiences will make you a good candidate for this office.

I'm Carolyn Riccardi, and I am honored to be running for re-election to the Norwood Board of Health. 2. What are the main functions of this office?

There are 7 key functions of the Town of Norwood Board of Health. I have held active and supportive roles in each of these functions.

- a) **Public Health Policy & Regulation** Enforces state and local health regulations while developing policies to safeguard community health and safety.
- b) **Disease Prevention & Health Promotion** Oversees vaccination programs, health screenings, and mental health initiatives while educating residents on tobacco use, nutrition, and chronic disease prevention.
- c) **Environmental Health & Safety** Conducts restaurant and food safety inspections, regulates septic systems and public sanitation, and monitors air and water quality.
- d) **Emergency Preparedness & Response** Coordinates public health responses to disease outbreaks, hazardous waste events, and natural disasters while working with the Medical Reserve Corps.

- e) **Community Health & Wellness Programs** Supports blood pressure clinics, substance abuse prevention, and senior health programs while advocating for health equity and essential health services.
- f) Tobacco & Substance Use Regulation Implements tobacco control policies, including age restrictions and flavored tobacco bans, while supporting opioid misuse and substance abuse prevention initiatives.
- g) Licensing & Inspections Issues permits and conducts inspections for food establishments, body art studios, wellness centers, and housing while enforcing regulations for safe public spaces and businesses.

3. What community resources or supports for residents do you feel Norwood lacks, and how would you work to make them available?

Norwood could benefit from expanded mental health services, substance abuse prevention programs, and accessible wellness initiatives for all residents. I would advocate for increased funding and partnerships with local healthcare providers to enhance mental health resources and addiction support.

Having dedicated years to advocating for community health in Norwood, I am committed to bridging gaps in services by leveraging my experience and strong local partnerships. I will work closely with community organizations, town officials, and healthcare providers to expand vital programs while actively seeking state and federal grants to fund new initiatives. My goal is to ensure the residents of the Town of Norwood—regardless of age or background—have access to the essential health resources they need to thrive.

4. What are the most pertinent health issues facing residents of Norwood, and what would you do to address them?
