### Women's Equality Day Picnic Held on August 22 **Polly Parton**

We had a beautiful evening at Howard Amon Park celebrating the ratification of the 19<sup>th</sup> Amendment that gave women the right to vote. Our speakers for the evening were LoAnn Ayers, President and CEO of United Way of Benton and Franklin Counties and Marisol Lister of Planned Parenthood. Both are volunteering for a successful census count, and they explained its importance to our community. Each person not counted in the census results in \$2,000 lost each year in federal funding. Undercounting may result from homelessness, moving populations, multi-family households, mistrust or fear of our government, and various other reasons.

Please watch for your notice in April 2020 with instructions for how to fill out the information online. After two unanswered prompts, a paper form is used and/or a census taker will knock on your door. Libraries and other public locations will have kiosks available to enter an online form for those with no reliable Internet. To prevent fraud, no email or phone calls are used. The Census Bureau is prohibited by law from sharing any information on individuals with any other public agency. It was noted that the citizenship question is NOT on the census.

Temporary employment for part time and full-time local census takers will be available at \$18 per hour after training. We as individuals and informed League members can spread the word of the value and importance of the upcoming census.

# League of Women Voters of Benton and Franklin Counties: A History

The Benton-Franklin League of Women Voters began as two separate leagues: Richland and Kennewick.

The Richland League was organized in the spring of 1947. Its first task was to register voters for the presidential election of 1948. Since Richland, as part of the Federal reservation, was unincorporated and essentially under county rule, the nearest registrar was in Prosser. League members were deputized to register voters and proceeded not only to register over 11,000 persons, but also to draw up precinct lines and street guides. On April 12, 1957, the Richland League applied for and received Incorporation by the State of Washington. The names of 47 women appear on the incorporation papers.

Meanwhile, the Kennewick League started as a Provisional League about November 1954. It attained League status in March 1956. The first accomplishment of the Kennewick League was the publication of a booklet entitled "Know Your County," in 1957-58. In 1965, the Kennewick League became the League of Pasco-Kennewick.

In April 1971, the Pasco-Kennewick League and the Richland League merged to form the Benton-Franklin Counties League. Apparently the merger occurred because of the efforts of some of the board members at that time. It took about a year to complete all the necessary paperwork and to work out all the problems, such as from which League were officers to be chosen, whether to be a bi-county or a tri-county League and how to go about the merger. The reasons given for the merger were: "Our community was and is growing together rapidly. The organization needs to be in a position of encouraging this consolidation. It will let us make better use of our woman power and be a more effective and efficient force in the community."

The first local program for the newly-formed League was a review and comparison of the city governments of the three cities. Over the next several years local studies included the justice system and facilities; "An Evaluation of the Merger of Benton-Franklin Counties"; Port Districts; taxes – those that are properly exempt in the two counties; and local government budgets.

## Voter Registration at WSU Tri-Cities Marilyn Perkins

JoAnn Bengston contacted WSU-TC about registering students and her timing was perfect as we were able to have a table at their community activity fair in August. We had a prime location, at the entrance to the building, plus we were close to the food.

Luckily, Valerie Moffit was also able to help. Not having registered people before, she was a natural. Though most of the people we spoke with were registered voters, we did manage to sign up a few new ones, and we processed a change of address for the Chancellor.

The highlight of my day was when a young student recognized me from registering him at a Naturalization Ceremony over a year ago. He is from Iraq, has his AA from CBC, and is working on an engineering degree at WSU. I remembered him because he was so outgoing and positive at the ceremony. Hopefully there will be a time when we can all meet him.

Last spring some of us attended the dedication of a ballot drop box on the WSU-TC campus. Student government leaders took the initiative to get one on campus, which is not an easy undertaking. After talking to students, we learned that Franklin County students use it as well. (Continued on next page)

#### From LWVWA: 50-State Redistricting Campaign

The League of Women Voters US will be leading a national 50-state redistricting campaign focused on creating fair political maps nationwide—the People Powered Fair Maps Campaign. Although Washington is in much better shape than many states, we'll be part of this effort.

The June 27, 2019 decision by the U.S. Supreme Court in three partisan gerrymandering cases (including Rucho v. League of Women Voters of North Carolina) was a call to action for the League of Women Voters. When the court decided to take a hands-off approach to redistricting, the League decided to jump into a people powered fair maps campaign to ensure fair representation across the country.

Because the Supreme Court has said they won't hear any more of these cases, **state legislators** have a green light to continue this undemocratic process that silences voters. We don't have an equal playing field when it comes to election maps across the country, and the redistricting process set to begin in 2021 is in danger. We do not have to rely on the Supreme Court to solve partisan gerrymandering.

#### **Electoral College:**

A federal appeals court ruled late Tuesday, August 20 that presidential electors who cast the actual ballots for president and vice president are free to vote as they wish and cannot be required to follow the results of the popular vote in their states.
