## **Treasurer's Report**

We have a new fiscal year, 2018-19, which began July 1, 2018 and ends June 30, 2019.

Checking: \$ 1,622 Savings: \$1,856 Total: \$3,478

**Budget:** The new budget is in the new fiscal year report. At the end of July, checking was \$1,622; savings was \$1,856 for a total of \$3,478.

*Income:* We received \$450 in dues and \$325 in member contributions. Thank you to our board members for their generosity.

**Expenses:** \$29 for the North Pavilion in Howard Amon Park; The first quarter of the State PMP for \$225.63 was paid and there was \$14.58 "in kind" expenses from JoAnn Bengtson for the primary forums.

*Membership:* We still have 48 paid members and 56 in total. We have not received dues from some potential members who expressed interest in the League.

We will change the membership form to reflect the free student membership until 2021. Student ID will be required for free membership.
