President's Message

We are pleased to announce that LWVOP has received an LWVSC Empowerment Grant to support our 2026 voter education and engagement program. You will learn more about this new initiative at our January 31 meeting. The two hour, Saturday meeting will allow more of our members who are unable to attend a weekday meeting to join us. More time to get to know your fellow members. More time to discuss League objectives and volunteer opportunities. The Board will provide beverages and breakfast goodies.

The annual Oconee County Delegation meeting will be held on Thursday, January 22, 6:00 p.m. at the Westminster Depot. The Oconee delegation includes State Senator Thomas Alexander, Delegates Bill Whitmire, and Adam Duncan. I will represent LWVOP and speak in support of League positions. The second session of the 2025-2026 South Carolina Legislature has convened and promises to keep our lobbyists very busy at the State House. Many of the bills are carried over from the 2025 session; some are perennial favorites that will be debated in committees, on the floor, and in the media. Attempts will be made to further regulate access to abortion medication while others will continue to push for a complete ban on abortion from conception.

Two bills that would close partisan primaries by party affiliation have been introduced and hearings are scheduled for this week. H.330 would mandate closed primaries and H.3643 would require voters who want to participate in a partisan primary to register their party affiliation. Others proposed bills would further define how independent and unaffiliated voters would participate in primaries.

Additional information on these and other bills of interest to the League will be included in the weekly Action Alerts and other League publications.

Prepare for a very full year of election and legislative activities, many of them will be suitable for members who prefer a short time commitment. Join us on Saturday, January 31 to learn more.

Sue Blount is one of our most dedicated observers. If she is not at the Oconee County Council meeting, she is watching the livestream on her laptop. Here Sue describes her attendance at an Oconee County School Board meeting.

“My husband and I attended the November 10 meeting of the OCSB. This is our favorite meeting to attend. Before each meeting a group of students presents an extra activity, they are part of and any awards or honors they receive. Then two schools get to brag about what is happening in their schools.

OCSB got great grades on the state report card. However, because Oconee County is a "wealthy" county (?!) the state may reduce funding. A wealthy county is defined as having too large ratio of teachers to students. If the funding is reduced, OCSB may have to ask for a mill levy increase of 0.1 to 13.7 with a goal of 3.2.

This is an engaging board that welcomes new attendees and treats the regulars as friends. During the meeting the members exchange information in an open and conversational manner. If anyone would like to attend with me, please let me know. The Observer Corps needs you.”
