## THEATRICAL PORTRAYAL OF FANNYE A. COOK AT MARCH 10, 2018 MEETING, PEARL LIBRARY

The League of Women Voters of the Jackson area will host its next membership meeting from 10:30 a.m. to 11:30 a.m., Saturday, March 10 in the Meeting Room of the Pearl Library, 2416 Old Brandon Rd., Pearl. This meeting is free and open to League members and the general public. A glimpse at Fannye Cook's remarkable life unfolds in a half-hour, biographical portrayal performed by wildlife biologist \*Cathy Shropshire with introduction and closing by \*\*Libby Hartfield.

Fannye A. Cook, a 1911 graduate of what is now the Mississippi University for Women, was a pioneer among scientists, conservationists, and women. Miss Cook was born in 1889 in Crystal Springs, Mississippi, when women couldn't vote, serve on juries, and were considered generally unsuited for the serious business of politics or science. Still, none of the naysayers deterred her, and may have emboldened her. She was the driving force behind creating the Game and Fish Commission (now the Department of Wildlife, Fisheries and Parks), she founded the Mississippi Museum of Natural Science, led the push to create a system of wildlife management areas and the push to protect the Gulf of Mexico's barrier islands, catalogued Mississippi's flora and fauna, spent her life researching and teaching, and doing so much more.

\*Dr. Shropshire retired from the Mississippi Department of Wildlife Fisheries and Parks, served for over 11 years as executive director of the Mississippi Wildlife Federation, and is now the theatrical incarnation of Miss Cook. Dr. Shropshire's captivating portrayal both entertains and educates, in the true spirit of the incredible Fannye Cook.

\*\*Libby Hartfield is the former Director of the Mississippi Museum of Natural Science and coeditor of the book, "Fannye Cook: Mississippi's Pioneering Conservationist." Copies of the book will be available for purchase.



#### DEVELOPMENT OF PEARL RIVER IN JACKSON AREA

Some years back, the LWVJA did a series of about six programs on a proposed Le Fleur Lakes development. #### LEFLEUR LAKES PROJECT We

recognize that the Pearl River can be an asset for development, flood control, recreation and enjoyment of nature in the tri-county area; however, we support the exploration of alternative proposals other than the Lefleur Lakes project. We are interested in alternatives which are less expensive, create less damage to the environment, do not destroy existing habitat and recreational opportunities, are not irreversible and provide more public space.



At our March meeting Libby Hartfield will tell about the Fannye Cook Wildlife Area which is being developed in the Jackson Area. Keep in mind these LWVJA goals for development of the area along the Pearl River as you hear about the new development.

#### **GUN CONTROL**

#### **LWVUS POSITION** (established in 1990)

The League of Women Voters believes that the proliferation of handguns and semi-automatic assault weapons in the United States is a major health and safety threat to its citizens. The League supports strong federal measures to limit the accessibility and regulate the ownership of these weapons by private citizens. The League supports regulating firearms for consumer safety.



The League supports licensing procedures for gun ownership by private citizens to include a waiting period for background checks, personal identity verification, gun safety education and annual license renewal. The license fee should be adequate to bear the cost of education and verification.



The League supports a ban on "Saturday night specials," enforcement of strict penalties for the improper possession of and crimes committed with handguns and assault weapons, and allocation of resources to better regulate and monitor gun dealers.
