Hopefully by now you have taken a look at our new website, <u>www.lwvnoc.org</u>, and explored some of its new features. One big change is the Calendar.

You will notice that the Calendar displays entirely differently than before. Each event appears as a brief and separate paragraph in chronological order. In many cases there is more information to be viewed by clicking on "<u>Read more</u>" at the bottom right of each event. When an address is given for the event, the <u>Google Maps</u> link will map the location for you. You may also add the event to your computer calendar (such as Outlook) by clicking on the "Add the Calendar" button.

Attention No Party Preference Voters Who Plan on Voting for President: Plan Today

from the Orange County Registrar of Voters

No Party Preference Voters who want to vote for U.S. President must request a primary election ballot with presidential candidates.

SANTA ANA, CA – December 27, 2019 – If you are a No Party Preference voter and want to vote for a presidential candidate, the Registrar of Voters needs to hear which ballot you would like by January 2nd for March 3, 2020 Presidential Primary Election. No Party Preference voters that do not inform the Registrar of Voters will receive a ballot without presidential candidates.

Several weeks ago, the Registrar of Voters sent a postcard with pre-paid return postage to the County's nearly 425,000 voters so they can make their selection via mail. No Party Preference voters may also submit their request online at <u>ocvote.com/npp</u>, by calling our office at 714-567-7600, or by sending a fax to 714-567-7556, even after January 2nd.

The American Independent, Democratic, and Libertarian Parties allow No Party Preference voters to participate in their Presidential Primary Elections. If you want to vote for a Green, Peace and Freedom, or Republican Party presidential candidate, you must re-register with that specific party. You can re-register to vote online at <u>ocvote.com/register</u>. If you need to re-register after February 17, 2020, you may need to register to vote in person at a Vote Center.

Quote by Registrar of Voters Neal Kelley:

"We are asking No Party Preference voters to inform us at their earliest opportunity if they would like to vote for a presidential candidate. By doing so, voters will receive the ballot with the presidential candidate they would like to vote for, and this will prevent delays during the voting period and make voting more convenient and easier for voters."

All voters will receive a vote-by-mail ballot starting in the March 3, 2020 Presidential Primary Election and all voters can check their registration, re-register, and register to vote at <u>ocvote.com</u>. For more information, call 714-567-7600 or visit <u>ocvote.com</u>.

Petitions for SCHOOLS & COMMUNITIES FIRST by Mary Fuhrman

Many of you have received petitions for the initiative LWVC and other organizations are circulating to put on the November, 2020 ballot. Some of you have received one in the mail from the state league. When you have finished collecting signatures, you can mail them to LWVC.org, 921 11th Street, Suite 700, Sacramento, CA 95814. If you need more petitions, you can call me.

Remember when explaining the issue, to stick to the message that the league has sent. The state website, LWVC.org has info on the initiative if you are uncertain.


Check the signatures carefully to make sure that they are entered correctly. Be sure to fill in the info at the bottom as the solicitor of the signatures, and place Orange in the county space at the top and at the other side of the petition. If you have collected signatures from another county, be sure they are on a separate petition headed with that county's name. At the bottom right corner after the letters GE, in the next two boxes place L W, so the League gets credit for your petition.

February 11th The Mirage Factory; Illusion, Imagination, and the Invention of Los Angeles by Gary Krist (Crown, May 20, 2019) 416pp. Reviewed by Satya Khouri, hosted by Deborah Vagts at the Cypress Library, co-hosted by Mary Fuhrman. At the heart of Los Angeles' meteoric rise were three flawed visionaries: William Mulholland, an immigrant ditch-digger turned self-taught engineer, who designed the massive aqueduct that would make urban life here possible; D.W. Griffith, who transformed the motion picture from a vaudeville-house novelty into a cornerstone of American culture



and gave L.A. its signature industry; and Aimee Semple McPherson, a charismatic evangelist who founded a religion and cemented the city's identity as a center for spiritual exploration. All three would pay a steep price to realize these dreams, yet when the dust settled, the mirage that was LA remained. Spanning the years from 1900 to 1930, **The Mirage Factory** is the enthralling tale of an improbable city and the people who willed it into existence by pushing the limits of human engineering and imagination.


